The world is full of evidence-based solutions to this crisis, but these are often inaccessible to education leaders.

Significant barriers prevent education leaders from using evidence because it is:

Not relevant

Academic reports and donor agendas rarely reflect the needs of education system leaders.

Not comprehensive

80% of education evidence goes unpublished, excluding valuable local knowledge from NGOs, foundations, governments, and agencies.

Not comprehensible

Most academic and technical reports are dense, impenetrable, and often paywalled.

We improve learning outcomes by distiling complex evidence – often local – into actionable insights, and accompanying policy and programme leaders to drive innovations at scale.



Our flagship guidance condensed 750 sources into 4 pages, contributing to new policies in **Kenya** and **Sierra Leone** potentially **impacting 2.3 million students.**

2 Develop actionable guidance by gathering and analysing relevant evidence, including local, non-published, and academic sources, appraised via our distinct approach, **LIFTED***.

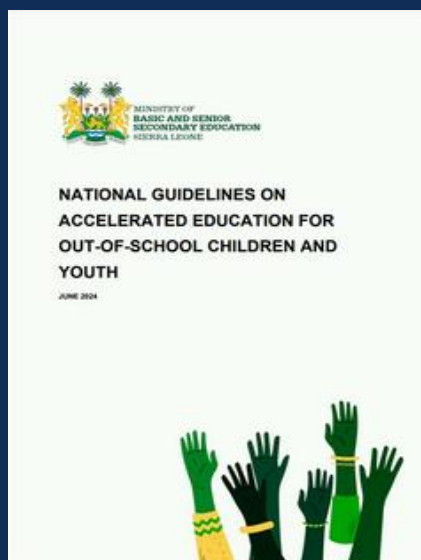

Sierra Leone's Guidelines for Accelerated Education



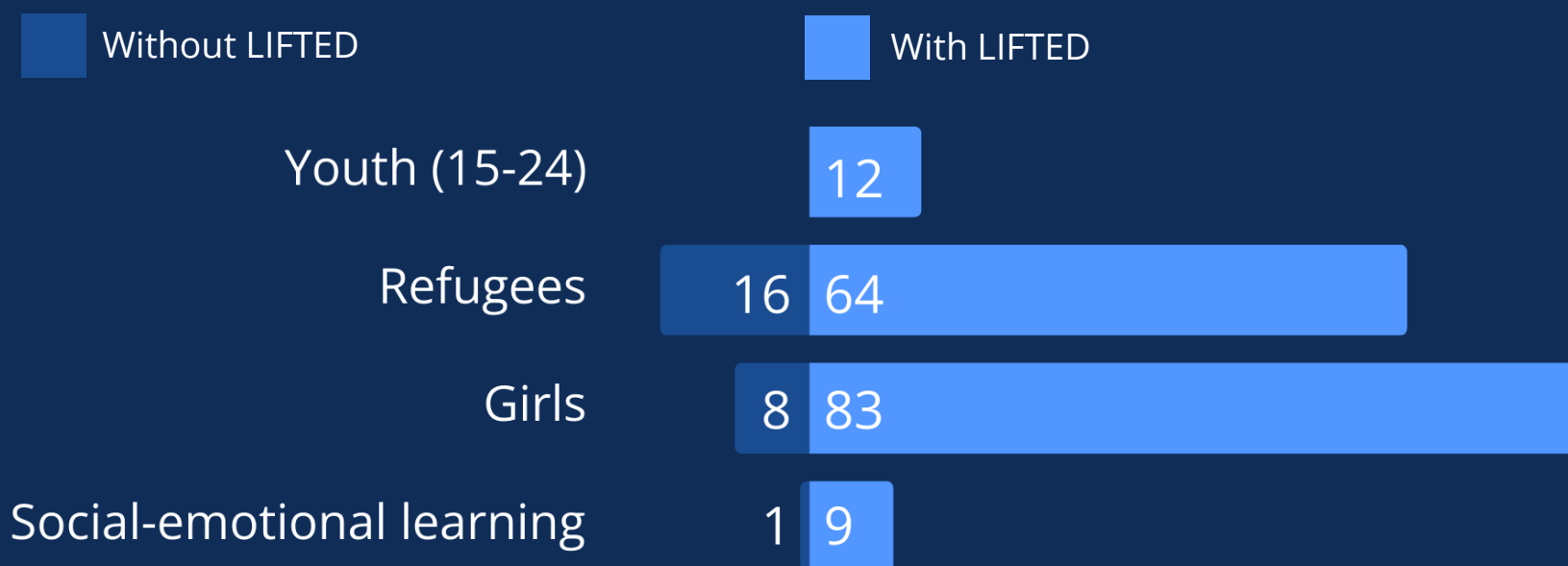
Co-designed by **20 organisations**—including NGOs, academic institutions, funders, and experts—for robustness and relevance.

Developed in 10 months with input from **4 ministries** and **12 local government authorities**; officially **endorsed by the Minister** for Basic Education.

Rooted in this success, we are **exploring AI** to accelerate and scale our approach.

Our **LIFTED** approach to broaden evidence **amplifies Global South voices** and reveals more insights on marginalised communities, enhancing guidance for leaders.
