The following conditions must be understood before enrolling:

1. Students under age of 18 are required to complete a state approved driver's education program prior to receiving a driver's license, and have the driver Education certificate handy on day one pick up (also known as DEC-1, Pink Slip, Green Slip, DTS-B, DTS-C).
2. Student will be notified by phone call in the event the school cancels classes. Cancelled classes will be made up at the end of the course.
3. School does not guarantee that any student will pass the state license examination or that the student can secure a license or that student will be guaranteed employment upon completion of any course instructions.
4. \$25 fee will be charged for returned checks; \$25 processing fee for replacement of lost certificates.
5. Course consists of minimum of 14 periods of Behind-The-Wheel instructions for students less than 18 Years of age. (7 periods of observance and 7 periods of actual driving) at cost of \$225.00 for most of Prince William residents and \$235 for most Woodbridge. (Each period is fifty minutes long).
6. Additional Behind-The-Wheel lessons are available at \$40.00 per lesson. (Lessons are fifty minutes long).
7. A no shows up fee of \$25 will be charged for each intentionally missed Behind-The-Wheel class. A minimum of 24 hours' notice is required for cancellation of Behind-The-Wheel lessons. Failure to comply will result in a charge of \$25 for last minute cancellation. When canceling, the student or a parent must speak to an Office Representative during the business hours or cancellation via E-Mail (info@taladrivingschool.com) Sorry no Exceptions.
8. A refund of all fees paid will be made, upon request, if school is not capable of or willing to begin instruction within 30 calendar days from the date agreed to in the contract.
9. Students are fully accountable for their conduct. They can be dismissed from the course for misbehavior without refund. No food, drink, Cell phones use while driving, smoking or sleeping is allowed in car.
10. It can take up to two or three weeks to complete a Behind-The- Wheel course, depends on the student's availability.

11. It is the responsibility of the student or in case of minor the parent or legal guardian to report the Department of Motor Vehicles any concerns regarding school facilities, instructor behavior or quality of instructions be the school.
12. It is mandatory that you provide your child with a minimum of forty-five hours of supervised behind-the-wheel driving conducted before program completion. As a parent, you must make the ultimate decision to determine if your child is ready to handle the responsibility of operating a motor vehicle unsupervised.
13. Due to COVID-19 safety measures, I as a parent signing this agreement I have no problem allowing TALA Driving School to conduct one-on-one behind the wheel lessons with my teenage child.
