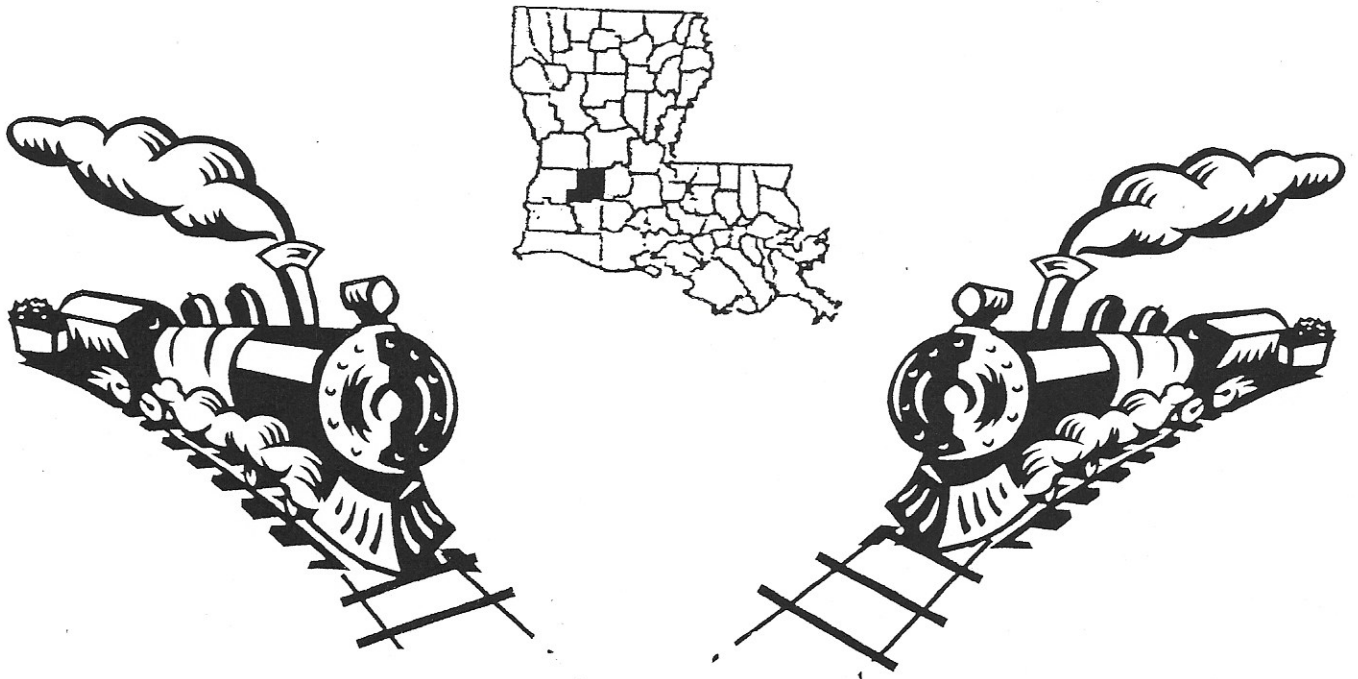

Coe Family – From Maryland, Virginia, Kentucky to Louisiana
Part 2; Continued from last issue.
Contributed by: Carl Robert Coe of Ohio
Author of: “The Coe Families of Maryland and Virginia”

James Coe married April 5, 1802, in Warren County, KY, Martha “Patsey” Hudspeth, daughter of David and Sarah (Wooldridge) Hudspeth. The marriage was performed by Gladin Gorin, with William Hudspeth as security. Patsey Coe died in St. Landry Parish, LA, in August 1827, leaving a three-month-old baby, a one-year old, a two-year old, a five-year old, and a thirteen-year old. Her estate was inventoried in St. Landry Parish, January 13, 1830, and was found to be valued at \$2469, \$2400 of which was in slaves.

After Martha Coe died, James Coe became involved in litigation over his wife’s estate and his ability to properly care for his minor children. On October 27, 1827, Coe’s brother-in-law, Green Hudspeth, filed suit against him in the parish court, claiming that...

“Coe has neglected and refused to cause himself to be confirmed in the Tutorship to his said children and to cause an inventory to be made of said property. That said James Coe manages the interests and property of said minor children unfaithfully and negligently and has demeaned himself so badly as to render him unworthy and an unproper person to manage the property or persons of his said minor children.”

The major point of contention between Coe and his wife’s brother was a slave named Nelsy, whom Hudspeth claimed was Hudspeth property, but whom Coe contended had been a wedding gift back in Kentucky from his father-in-law David Hudspeth. The matter was complicated by the fact that Nelsy had been inventoried as part of Hudspeth’s estate in 1812. Judge George King of the parish court settled the matter June 23, 1828, when he decided that Nelsy and her children belonged to Coe’s wife’s heirs, namely the Coe children.

On September 9, 1828, Coe filed a long motion seeking a new trial, going to great length to explain the circumstances of the case, arguing that because the original transfer of the slave had been made in Kentucky the Louisiana court had no authority in the matter. He further lamented the incompetence of his attorney in the first hearing, one Valentine King, Esquire. Finally, on December 9, 1828, the court offered a final ruling, annulling its former order and declaring it had no jurisdiction in the case. At the same time the court threw out Hudspeth’s contention that Coe was an improper guardian for his children and on October 9, 1830, confirmed him “as natural Tutor to his minor Children.”

James Coe died at Mountville, LA, in March 1831. On March 10 Green Hudspeth petitioned the court of St. Landry Parish, declaring “That James Coe late of said Parish died therein a few days ago, and left several minor children who are without tutors towit: David Coe about seventeen years old, Uliesses Coe, Amazone Coe and James Coe the last three are under the age of puberty....”

On March 14 the parish judge ordered an inventory to be taken and “proceeded to the last residence of the late James Coe of Said Parish deceased, in the town of Mountville distant about eight miles from the Court house of Said Parish, in order to make an estimative Inventory of the estate of the Said James Coe & Patsey Hudspeth his deceased wife. ...”

Among other property, they found eleven slaves which they valued at \$2900, three horses worth \$60, various parcels of leather, a saddle, shoemaking tools, pots, and other items, with a total estimated value of \$3049. Their estimate was low, however, and when the estate sale was held April 15, 1831, a total of \$4091.121/2 was raised. Purchasers at the sale were Gabriel Hickman, West Butler, George Hudspeth, Isaac Ventioner, John Taylor, John Wright, Michael O’Connor, Levi Morris, James Morgan, William Cooper, David Hudspeth, Edward Fahey, Missouri Ardrey, John Budd, Dennis Leberge, Thomas Leberge, Aaron Dyal, James Pierce, Stephen Reed, and Green Hudspeth.

By the time the estate was settled in October 1834, it gained \$9.79 1/2 in interest; estate debts came to \$1054.47, leaving \$3046.45 to be equally divided among five children, namely, David Hudspeth Coe, Missouri Coe Ardrey, Amazon Coe, Ulysses Coe, and James Timothy Coe. On September 24, 1833, the court of St. Landry Parish appointed Green Hudspeth tutor/guardian of David Coe, James Coe and Amazon Coe. George Hudspeth was appointed tutor of Ulysses Coe; John D. Hudspeth undertutor.

DAVID HUDSPETH⁶ COE (James⁵ (24), Timothy⁴, Timothy³, Timothy², Timothy¹) was born September 2, 1812, in Hardin County, KY, on a farm now part of Fort Knox. As a baby he was taken by his father and mother to St. Landry Parish, LA. When his father died there in 1831, Green Hudspeth was appointed by the court to be his tutor. Reared in Hudspeth's home, on April 28, 1840, he and his sister Missouri Ardrey appeared before parish judge George King and signed a document declaring that they had received their share (\$609.29 each) of their father's estate from George Hudspeth, "agent of the Said Estate." On May 10, 1844, he sold a tract of eighty acres located at Grand Prairie, St. Landry Parish, to John O'Connor for \$150. He appears on record in the parish March 28, 1849, when he made a deposition at Opelousas, stating that he had received \$96.87 from Samuel M. Hudspeth, administrator of the estate of George Hudspeth, deceased; the amount due him from the estates of his father and his deceased brother Ulysses. On May 12, 1849, he petitioned the court of St. Landry Parish to be named "Natural Tutor" of his three minor children, whose mother had died. The petition was granted. His brother James Timothy Coe was approved as secondary tutor.

He remained in St. Landry Parish until about 1850, when he moved to Rapides Parish, where he appears in the 1850 census. In 1860 he was living at Alexandria, LA. On October 1, 1860, he patented an 80-acre farm in Section 34, Township 1N, Range 3W, Rapides Parish. He appears on the 1865 tax list of Calcasieu Parish. In 1870 he was living in Catahoula Parish. A blacksmith, he first learned the trade at the age of sixteen, apprenticed to Alexander Duggins, January 28, 1829.

He married (1) September 11, 1834, in St. Landry Parish, LA, Charlotte O'Conner, who died there in 1849. He married (2) Clarissa, born 1832 in Louisiana. Sons George and James in her name received a 161-acre farm in Section 29, Township 1S, Range 6W, on the Allen/Jefferson Davis Parish line, March 23, 1897. He married (3) October 3, 1869, in Catahoula Parish, LA, Mrs. Mary Ellen (Eskew) Whatley, born 1847 in Louisiana, daughter of Mrs. M.C. Eskew.

Part 111 of the 'Coe Family of Southwest Louisiana' will continue in the next issue of CrossRoads, with George Washinton Coe, who was born in Rapids' Parish, Louisiana, and ended up in Allen Parish, Louisiana. It is said that he donated land for the Pine Chapel Cemetery (Oberlin, LA) in which he, his wife, and some of his children, are buried. There are many descendants of the Coe family found in Allen and Calcasieu Parishes; some still living today.

His death and burial is listed in Rev. Paul Leeds Congregational Church Records, with Rev. Leeds officiating at his services.

One of his sons, Athan Coe, married on May 12, 1912, Jennie Nevils of Indian Village Community, daughter of James Nevils and Adeline Buller, also recorded in Rev. Leeds' Church Records.

***Interesting query found on a message board: (author: Edgar Johnson)

Thursday Ann (Brown) Benton b. abt. 1840 in MS, married John R. Benton on Oct. 5, 1857 in Pike County, MS

Thursday was living in Kinder, Allen Parish, LA, in 1926 and 1930, when she filed a "Widow's Application for Confederate Pension". She was 90 years old. Her name had been changed to Bennett, but Application states 'Jack Benton' She is buried in Kinder McRill Cemetery near her daughter Mollie. Headstone reads: Theeresa Bennett – 1837 - 1933

In a letter dated Dec. 26, 1930, written by Geo. Hamm, Kinder, LA – Geo. indicates in the letter he is the grandson of Thursday A. Benton of Kinder, LA

John (aka Jack) and Thursday had the following children:

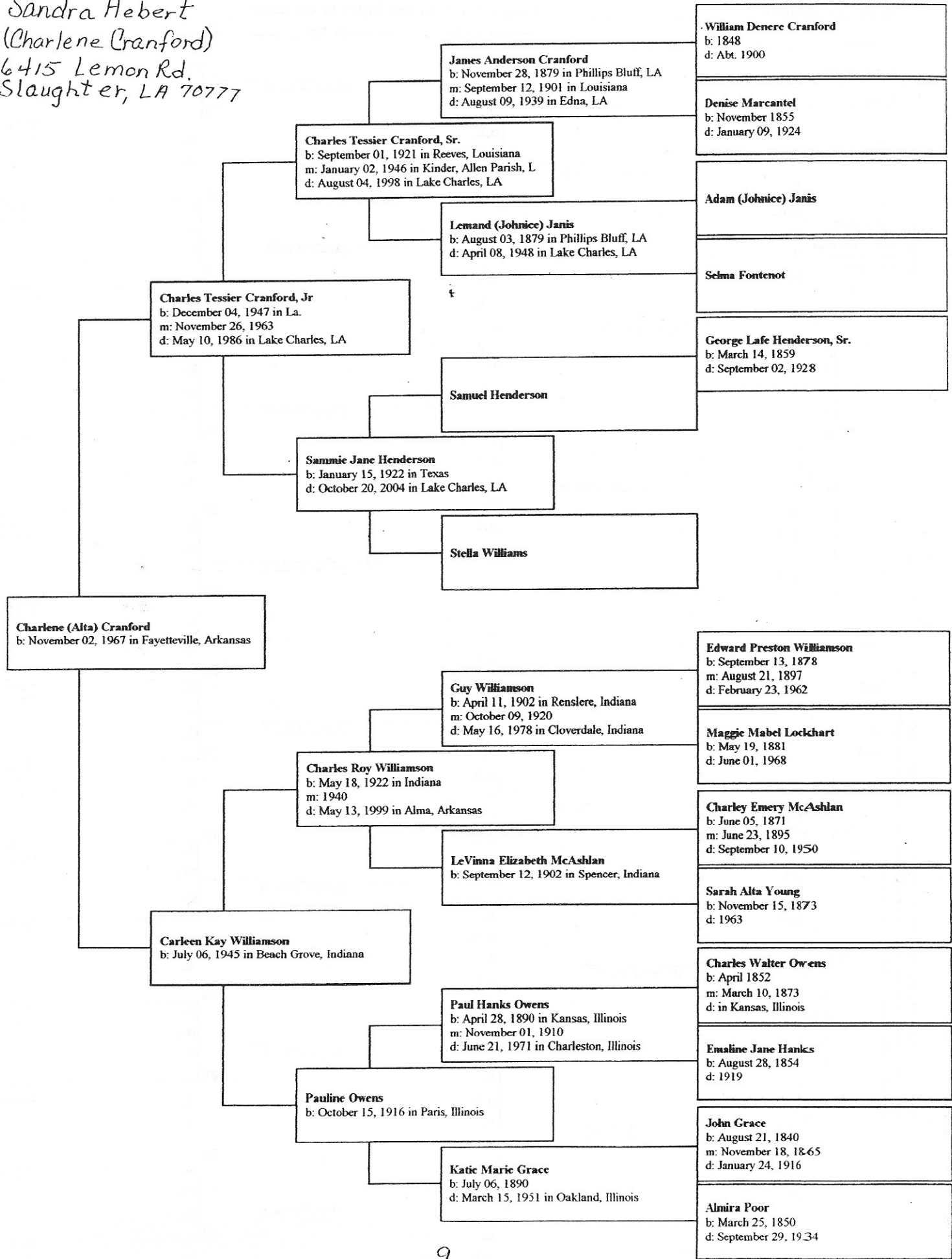
