Membership Offerings

RJ's Cigar Lounge Members

- 1. As a member you will receive one locker with either key or combination.
- 2. You will receive \$25.00 per month credit toward cigar purchase and cigar accessories (not food and beverages).
- 3. You will be allowed to bring up to 3 guests per visit for a charge of \$10.00 per guest. Spouses are free.
- 4. You will receive 20% discounts on Drinks and food purchases.
- 5. On house choice night you will receive one sample of the Cigar being shared with members for free that evening. Your guest may enjoy the sample with you for 20% off the retail price of the sample stick.
- 6. You will be allowed to bring 10 cigars per month from outside RJ's, all cigars must be inspected and logged before placed in your locker.
- 7. You and your spouse will be able to eat the daily member only Buffet for \$10.00 each. Your Non-Member Guest can dine for \$15.00
- 8. You will be allowed to rent space in the club for private parties. Pricing depends on the number of guests and hours reserved.
- 9. You will be invited to enjoy a %50 off bar tab night once per week (Drinks Only). Your guest shall be included. This night shall be designated by RJ's and recur the same night each week.



LOCKER RENTAL AGREEMENT

Members agree to adhere to the following policies and procedures:

- 1. Lockers will only be rented to customers 21 years of age or older
- 2. Lockers will not be extended month to month rentals.
- 3. Lockers cannot be shared.
- 4. Members only can store bottles of Liquor in their Lockers. Liquor can be brought into by members only to RJs for consumption or storage. Liquor can only be removed from the premises with food orders to go. Liquor must be served by TABC certified workers of RJ's, you will be charged a pour fee for the service. Members may purchase bottles from RJs for consumption and storage.
- 5. The term of membership is one year and will be renewed annually with a new agreement signed.
- 6. Members are responsible for the contents of their locker and agree not to store any illegal products in their locker.
- 7. RJ's will not be responsible for any valuables stored in your locker
- 8. Management reserves the right to open any humidor locker for inspection and maintenance and cancel the rental agreement for any violations of this agreement.
- 9. Members are responsible for any damage to the locker.
- 10. Locker rental includes a personalized name plate on the door of locker. Changes to your nameplate will require a \$40 fee.
- 11. Members will remove any items from locker at end of rental agreement. Items not removed will be disposed of after 30 days.
- 12. All locker rentals are final and non-refundable.



The undersigned agrees to follow the policies and procedures outlined herein. It is understood that Locker Rental is subject to approval requiring payment of \$100 non-refundable deposit and providing an executed credit card authorization form. Payments made online will require this form to be signed and uploaded to the website message center.
