1. Scope of Services

2. Client Responsibilities

- · Provide accurate and complete information for all travelers.
- · Review and confirm all booking details in a timely manner.
- · Ensure that all travelers meet passport, visa, vaccination, and entry requirements for their destinations.

3. Payment and Fees

- · Planning fees must be paid in full prior to the commencement of research or booking services.

- · Clients travel at their own risk. ABIONE Travel LLC is not liable for personal injury, loss, delays, or other disruptions caused by weather, pandemics, political unrest, or other unforeseen events.

6. Limitation of Liability

- · We are not liable for losses, injuries, or damages incurred as a result of travel arrangements, delays, or cancellations.

I have been advised that the suppliers whose names appear in the information supplied to me are those who are actually responsible for providing the travel services I have purchased.

I consent to and request the use of those suppliers and agree not to hold ABIONE TRAVEL LLC responsible should any of these suppliers:

- 1) fail to provide the travel services I have purchased;
- 2) fail to comply with any applicable law; or
- 3) engage in any negligent act or omission that causes me any sort of injury, damage, delay or inconvenience.

I accept that ABIONE TRAVEL LLC is not responsible for, nor will I attempt to hold it liable for, any injury, damage or loss I may suffer on account of any conditions, actions or omissions that are beyond its reasonable control. I will not hold it responsible for any injury, damage or loss I may suffer while on any third party provided or operated excursion or activity.

I will review my travel documents for accuracy upon receipt and understand that I may contact ABIONE TRAVEL LLC if I have any questions. I understand that discounted fares typically involve restrictions and that changing any aspect of my travel arrangements may result in the payment of additional money.

I have been advised to use a credit card as this may offer me the opportunity to dispute the charge should a vendor cease operating.

I understand that the Transportation Security Administration (TSA) requires me to carry a government issued identification card in order to board a flight. I have been advised that the name, date of birth and gender that appears on the identification card must exactly match the same such data that is listed on my airline ticket and in my booking records. I acknowledge that my failure to strictly comply with these requirements may result in denied boarding or an undue delay at an airport security checkpoint causing me to miss my flight.

I understand that if traveling internationally, I must have a valid passport and depending upon my destination and nationality, I may need to obtain one or more visas.

I understand that the airline tickets, air tours or other products I am purchasing are subject to supplemental price increases that may be imposed after the date of purchase. Post-purchase price increases may be applied due to additional costs imposed by a supplier or government. I acknowledge that I may be charged additional sums by ABIONE TRAVEL LLC to offset increased fees, fuel surcharges, taxes, fluctuations in foreign exchange markets or any combination thereof.
