SAFEGOLD DIGIDEMAT PVT LTD (also referred to as "Prosper", "Company", "we", "us", or "our"), a company incorporated under Companies Act, 2013 bearing corporate identification number (CIN) U67190MH2022PTC386112 and having its registered office at Shop No 03, GRD FLR, Vora Ashish 1 Near Diamond Market, Malad East, Mumbai, Maharashtra, India - 400097.

Prosper gives utmost importance to the protection and privacy of the information submitted by the clients, users, distributors, visitors, etc. (collectively referred to as "Users/You"). The distributor(s) may be referred to as a partner on the various pages/sub-domains of Prosper for a limited purpose, without any legal implications. We are committed to ensuring the privacy of the Users' information.

This Privacy Policy is intended to let you know the nature of personal and non-personal information we collect, why we collect it (purpose), and what we do with it (use), including processing, sharing, and transfer of personal information and your rights relating to such personal information shared with us. By using Prosper's website and mobile application ("Platform"), you agree, understand, and consent to this Privacy Policy and any future amendments and additions.



1. Consent & User Agreement

- Image of identity/address/bank proof for KYC verification
- Demat account details

II. Non-Personal Information:

- Usage data, web beacons, session data
- Log data, aggregate information
- Device/browser details and internet behavior

4. How We Collect Information

We collect personal information through various sources, including:

- Direct interactions on our platform (e.g., registration, transactions)
- Tracking tools, including cookies, to monitor browsing behavior and preferences
- User interactions with customer support, recorded for quality assurance
- Social media engagement
- Third-party data enrichment sources, where permitted by law

5. Use of Personal Information

We may use and process user information (Personal and Non-Personal) for a range of purposes, including:

- Providing and administering services
- Enhancing user experience through personalized content
- Research and analytics for service improvement
- Fraud detection and monitoring
- Compliance with legal and regulatory requirements
- Enabling targeted advertising and promotional offers



6. Cookies & Tracking Technologies

We, our third-party service providers, and partners may send 'cookies' to your computer to enhance your online experience. Cookies help us recognize repeat visitors, save user preferences, and optimize the platform for a better experience.

You can configure your browser settings to accept, refuse, or delete cookies. However, disabling cookies may limit your ability to use certain features of the Platform. We do not control third-party cookies and advise users to review third-party policies.

7. Data Sharing & Disclosure

We do not sell, rent, or trade your personal information to third parties for marketing purposes.

We may share data only for legal, operational, and service-related purposes with:

- Regulatory authorities (SEBI, exchanges, government agencies)
- Payment processors & service providers (Payment Gateways, banks, clearing corporations)
- Business partners (for co-branded services)

All data sharing is done in compliance with Indian laws, and security measures are in place.

8. Data Security

- We take reasonable security measures to protect your personal data.
- Data may be stored in electronic and physical formats.
- We may use third-party storage services with security standards.

No data transmission over the Internet is fully secure. You acknowledge that we cannot ensure the security of any information you submit.



9. Data Retention & Deletion

However, certain legal obligations may prevent full deletion of your data immediately.

We use Razorpay for processing payments. We/Razorpay do not store your card data on their servers. The data is encrypted through the Payment Card Industry Data Security Standard (PCI-DSS) when processing payment. Your purchase transaction data is only used as long as is necessary to complete your purchase transaction. After that is complete, your purchase transaction information is not saved.



Our payment gateway adheres to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover.

PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.
