It is the song that never ends.

It goes on and on my friends. Somebody started singing it, not knowing what it was, and we continue singing it forever just because it is ...

Minister's Message:

I used to sing this with my children when they were little, as we drove the long miles to see Grammie. It is such an incessant song. At some point even the kindest, gentlest soul would ask us to "STOP!" and look around for something else to do.

I think that is where we are at... as a new year begins we look around and see that we are still on this covid-19 journey. Sure, there are a few things we should have done before we started this journey, but now it's just time for some of us to change our tune, and focus on what we are learning on this Grand Adventure that is still called, "Life," yours and mine. We spent several weeks talking about the Book of Joy this year, a book by Desmond Tutu and The Dali Lama. They were not just talking about you being happy just for you, but for the sake of all creation. We need to keep those pillars of Joy propping us up every day: Perspective, Humility, Humour, Acceptance, Forgiveness, Gratitude, Compassion and Generosity. To focus on these helps us find our song.

We started the year off focused on a music program that was growing again here at Stamford Lane United Church. People of all ages were wanting to be a part of a church, a spirit, a people, a place, an acceptance, an understanding that we sing here. We have always sung the story of our faith here, with all the bells and chimes, opening our doors to every opportunity of encouraging people of all ages to express themselves and their relationship with God and one another, here. We remain determined to help you "Make your life a song to God." Encouraging a choir director, an accompanist, and hiring a communications assistant and an administrative assistant, are all about packing life full of the right necessities for this journey of a lifetime.

This is still the journey we are on.

When Covid-19 hit, I became a roving videographer while Lucie kept the Lord's house ready to welcome you back to worship in a beautiful sanctuary and to coffee together in a sparkling clean hall. Declared non-essential, pastoral care in person became restricted, and impossible for the most vulnerable. Daily emails and calls reached out best to the families of Stamford Lane, as well as others who used to be, or wanted to be, connected. We read Charlie Mackesy's "The Boy, the Mole, the Fox and the Horse." Sara and Linda were asked to stay home during the early part of this ride until we figured out how to re-route, and Sharon was already on the way to retirement in June. Sara and Linda both volunteered for everyone who offered to be recorded singing. Eventually we were able to adjust hiring plans to fit our changing needs to include Leslie as Administrative Assistant, Bryanna as Communications Assistant, and even Ryan on sound for a few hours each week. By September, with the generosity of singers, preachers and givers, we settled back into worship in the sanctuary with all of our staff until the end of the year when new regulations limited attendance to 10.

I know it was hard on the heart not to be able to sing along with all those old songs together as we remembered old friends all through the fall, and all the carols we always sang together in December. With each song that I can't sing with you, I realise more and more that I have lost too many people that I still hold in my heart, and I guess I have packed away some stuff that should

have been sorted through. This present journey is hard on the heart, mind, body and soul. So perhaps it is best for you to plan to sing from home while you sort through some of your own stuff, and look for new signs that we are on the right path through this Pandemic. This new year offers an opportunity to change our tune as we go along.

Your staff will keep working to help you worship with songs, prayers and the Word of God from those who found their way through tough times before. We are figuring out the audio visual thanks to a few volunteers. I do need to thank my children. Anne is here every week recording, she and Chris sort through the technology. Hope offered some online time with children who we found were just over zoomed, so Anne helped me deliver some care packages several times to a list that Santa counted to include over 80 nice children. Sandra, Sara, and Bobbie, have helped with those as well. We have tried to keep in touch with all the children of the church including Paisley and Rev. Cathie's Sunday School classes, nursery and Choir. Barbara Cole has been very supportive of the worship format and has helped Lucie and Peter Land looking after our Covid protocol. Diane Becken has been keeping track of all the seniors and we deliver updates and communion to those who are in residential care, while keeping in-touch with those who experience loss or illness. Dan MacDonnell has been working with Lucie to keep up on maintenance, repairs and inspections. Ray Marshall is a constant presence who has looked after your church in so many ways. He has been busy trimming the budget, the decorations inside, and the branches outside. Ray tends to the money with Leslie, he volunteers to keep the bells ringing and the bills paid with your donations and the government's support through 2020. We are actually in a better financial position now than we had projected earlier in the year. We receive government support because we are not meeting our operating budget at the same level as we had before. We were spending about \$4000 more than we were taking in every month at the beginning of 2020, but with your incredible generosity and Ray working with Tim and the Finance committee, along with Dennis and the trustees, we will begin the year with a bit of a cushion as is always needed for the long road ahead!

Thank You for your support as we learn to sing together separately for now. We learned a lot along the way, how to worship differently, how to share, care and be there, differently. The new year promises new possibilities and opportunities that I pray we will want to, and be able to, sing about at the top of our lungs before long. For now, pray with me and smile... even behind your mask I can see the song on your heart. I pray it is filled with joy. The life we are living is filled with Joy. You need to sing it now. I need to hear your joy. Your church needs to hear what gives you Joy. All of creation needs your joy. So sing it until you feel it.

I've got the Joy, joy, joy, joy, down in my heart, Where?

Committee Reports:

Dan Taylor opened the meeting up for questions and comments regarding the committee reports published in the Annual Report (p.1-2; 13-27).

The following committees added some comments:

Java 98 - We will not be renewing our *Socan* license now that the Java 98 Coffeehouse events are over.

<u>Turkey Dinner Report</u> – In the future please do not use the label "Men's Club" and replace it with "The Turkey Team" as the many volunteers organizing the Turkey Dinners are men, women and youth.

<u>Rental Committee Report</u> – Council was asked to revisit the request to allow alcohol at events held here. Council looked clearly at the different aspects of this request and decided it wasn't worth the risk to the church in comparison to the benefits it could provide. Council voted against bringing this motion to the congregation meeting. The current rental policy is being updated regarding vaping, cannabis, allergies, etc. and insurance requirements.

<u>Transitions Canada</u> – Hailey Gienow-McConnell is willing to help support the Transitions Canada programs.

<u>Teen and Children Choir</u> – "*To Clap or Not to Clap*": no clapping allows the service to be a little more prayerful, calm and spiritually pleasing. It is important to clap for children when they do something extra special, so they know they are appreciated. But when adults are performing they are performing for worship and prefer no clapping. Feel free to compliment them for their performance after the service during coffee hour.

Property Report – Leslie Maddalena asked that some hooks be put up in the ladies washrooms.

<u>Trustees</u> – Dennis Gilmore explained what it took to do the name change on deed to "Stamford Lane United Church". This took over 4 years to resolve and we appreciate all that Dennis has put into clearing this up.

Financial Report 2019

Ray Marshall went over the financial statements (p. 28-30) and answered any questions.

Turning to the Receipts & Disbursements, pages 28 & 29

INCOME: On Page 29

- Local Offering was less than 2018 (down \$3K)
- FundScrip entry was 2 years rebates transferred to the general account this December (617.83)
- FUNd Ctte: cupcake slipper sales by this new committee (886.10)

- GNU entry was given towards the elevator repairs (1,000)
- Rebates included a rebate of part of the 4th Quarter Dues from Niagara Presbytery (\$2,483.49) and HST rebate (\$5,555.32) an additional \$700 was deposited in the Roof Directed Fund.
- IN-Touch Ctte wished \$5,000 to go to the General Fund and \$400 towards "Coffee Hour".
- Turkey Dinner Proceeds & Thompson Endowment similar to 2018; Sponsorships are up \$1K.
- Our rents were down in 2019, but not as much as expected with the loss of Niagara Adult Learning
- The Directed Funds transferred to the General Fund include the excess collected for the roof to assist with the Elevator repairs (\$4,198.69) and the closure of the Dinners Directed Fund (\$640.30) and the Sunday School Directed Fund (\$391.30). So as not to skew the total income, it is reported on a separate line below the Sub-Total.
- Also, the Niagara Extension Council Grant was surprisingly paid in 2019 (\$12,457.54). It is a one-time income and was also reported outside of the regular incomes.

EXPENSES:

- Salaries are as budgeted.
- Worship & Service
 - o Appreciation Garden Expense was over budget, as we purchased some gifts for future years
 - o Fellowship Hour Expense of 364.50 was actual cost
 - o 4 pianos were tuned for \$500; organ was also tuned in fall; cost taken from Directed Funds
 - o Sanctuary Flowers, Gifts were gifts to staff & Laura Sparkman at the AGM & Christmas
- On Page 29
- Christian Ed & Development
 - o Sunday School expense represents needed supplies and curriculum
 - Youth Work was for registration at a Family Ministry Conference
- Operating & Building
 - Office Expenses included \$777.59 Service Charges, \$430.23 postage; \$3,087.02 supplies and printing; and \$126.41 computer licenses & upgrades
 - Land Registration: As you can see in the Trustees report on page 26, our property is now registered under the Trustees of Stamford Lane United Church \$4,081.76
 - Elevator costs include repairs \$4,350.50; license \$100.00, Kone \$1,521.20 & Brock Contract \$300

We spent \$1,159.76 more than we received and so our General Fund Balance on Dec. 31, 2019 was \$8,686.47

DIRECTED FUNDS report found on Page 30

- Broadview: 11 families subscribe
- Choirs: the income and expenses of Terrence Wu's recital, Bells Festival, Guest Musicians, & music are included here
- Dinners: balance of \$640.30 was transferred to the General Account in December
- FundScrip: balance of \$320.83 + 297.00 was transferred to the General Account in December. Once we ask, we will be receiving the 2019 earnings (\$362.03) in 2020

- Good News Unit have closed their bank account and this Directed Fund will record transactions, starting in 2019
- IN-Touch: income from receptions; expenses for receptions & transfers to General account
- Java98 expenses include Light of Day \$150, & Autism Ontario \$315.00; and ½ Socan License \$104.56
- Our Memorial fund received \$9,272.20 in 2019, transferred \$17,135.23 to the roof Fund

- Organ was tuned in October -- \$484.77
- Planned Legacy Giving: received donations from Ratcliffe & Blain families, Estates of Pat Billingsley & Kay Bean; invested \$35,012.05 in a High Interest Savings Account with Investors from July to Dec 31.
- Income for the Roof includes donation \$8,206.07 and transfer from Memorial \$17,135.23; Expenses were \$15,557.53 and \$4,198.69 transferred to the general account for Elevator Repairs
- On behalf of others we collected \$230 for Cave Springs Camp, \$650 for Guardians of Hope, \$1,380 for NF Community Outreach, and \$1,275 for Project Share; the White Gift collected \$4,521 and all the moneys left after purchasing the food vouchers was given to Project Share

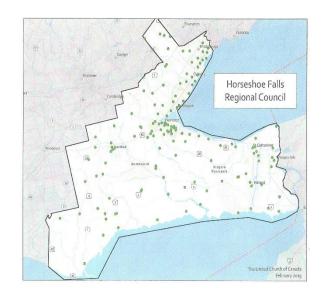

TRANSITIONS CANADA 2020

Although this year has been one of great uncertainty with the onset of Covid-19 we still have lots to be grateful for. Kelly Green has joined Transitions Canada as a partner and we also welcomed three new participants, Maria, Jacob and Courtney. With the ongoing support of Stamford Lane United Church our program has continued to operate safely. We have implemented numerous preventative measures to protect the safety of the people we support. Some of the precautions taken include having a dedicated entrance, limiting access to the program, screening participants on arrival, restricting activities to within the building, using plexiglass dividers, filtered air exchangers, increased cleaning and the wearing of masks. We have also altered our program to enable social distancing. In all of these actions we have been guided by the advice, recommendations, and instructions of public health officials, and the Government of Ontario.

We are aware the coming months will continue to be challenging and the need for vigilance and preparedness for the possibility of increased cases will be a challenge of balancing the health and safety of participants and their emotional well-being and human rights. During this time, we will continue to improve supports to be responsive, person-directed and sustainable. We will continue to be resilient, providing a safe and innovative service.

TRANSITIONS CANADA provides services and life skill training for persons that have an intellectual/developmental disability. We strive to develop and maintain mutually contributing and positive relationships by providing supports that help in eliminating barriers to acceptance and emphasize abilities so that all are welcomed in the community as valued citizens with full inclusion. These are the true measure of happiness and quality of life.

Following our mission to provide supports that reflect the individuals changing needs and to enhance their opportunities to participate in their home communities and attain their best quality of life we provide the following services:

Transition Services for individuals with disabilities - we help the transition through the complex move from youth to young adult, to employment, further education or more independence in living and daily activities.

Day Program/After School & Respite – individuals can attend half day or full days, one or more days a week.

Home Management Training and Supports - We assist the participant in developing skills required for more independence and safety in the home. Providing supports so the individual can move toward independent living and we also support the individual so he/she can stay in their own home.

Life Skill Training/Recreation - Our program offers diverse activities and topics according to participant goals and needs. Each day is unique. Participants are welcome to attend half or full days and any number of days during the week/month. Through volunteer openings we invite the leaders in our community to share their giftedness, skills and strengths with us. Our participants of different abilities can gain experience in a safe and welcoming environment. We look forward to seeing you so we can practice our socialization and conversation skills as well as learn new hobbies and ways to gain health and wellness. Through your support, participants can learn new skills and have a greater chance at full inclusion.

Trustees Report

Our current trustees are Bryce Anderson, Anne Arnott, George Bethune, Bob Cattanach, Mary Dempsey, Dennis Gilmore, Marion Lennox, Paisley Janvary-Pool, Joan MacKenzie, Paul Patterson, Rev Harvey Tobey, and Gerald (Tim) Zavitz.

The Board of Trustees holds property for the use and benefit of the congregation.

All lands, premises and Real Property and Personal Property held or acquired in trust for or for the use of a congregation are to be held, used and administered by the Board of Trustees. Personal Property is defined to include money and investments.

- Per direction of Finance the Trustees received \$40,000.00 in August which represents Directed Funds. In December Finance asked Trustees to hold \$20,000 which represents Cash. These monies were put into Investments until needed by Finance.
- Our Investments are held by Investors Group managed by Ken Hendriks and Barb Tobey in a Moderate/Conservative Portfolio. Typically this portfolio will yield 4-6%. We are pleased that this Portfolio has weathered the Pandemic well and continues to perform as expected.
- Our insurance plan is administered by Olsen-Sottile Insurance Brokers Inc. The Master Policy is with HUB HKMB International which is a General Insurance Plan for the United Church of Canada providing Property, Boiler and Machinery, Crime, Commercial General Liability and Abuse Indemnity Form. Our plan is up for renewal in March. We have been forewarned by Erik Mathiesen, Chief Financial Officer UCC, that our premium will likely go up by 30% at time of renewal. One of the significant factors is due to the age of our Churches across Canada.

Planned Legacy Giving

We continue to be blessed with the generosity of our Church members. We received donations from the families of Jim Munro and Loree Turnbull.

Legacy gifts help fund our congregation's ongoing ministries, build our reserves, facilitate new ministry programs and opportunities and help our congregation in the future. These gifts come in the form of:

- Bequests you can make a gift in your will to any area of the church or divide your gift among several programs and ministries
- Annuities you make a gift now; you receive a charitable donation receipt for a portion of your gift; you receive guaranteed semi-annual payments for life
- Life Insurance a substantial future gift is created to support the ministry and mission of the church
- RRSP's, RRIF's and TFSA's a substantial future gift is created to support the ministry and mission of the church; your estate receives a charitable donation receipt that will offset taxes, which will in turn replenish the value of your estate; designating a ministry as the beneficiary of a policy helps avoid probate fees on these gifts

Notes on Treasurer's Statement for 2020

We all need to realize that 2020 will have a HUGE Asterisk beside it for so many reasons. The church building was closed for worship from March through September. Since we returned, we have had to limit the number able to worship in the sanctuary. We have received unprecedented government grants which has coloured our financial picture. As a congregation, you have truly supported your church and I am pleased to share the financial statements with you.

I would remind you that there are 4 main ways you can continue to support Stamford Lane: using Offering Envelopes, Post-dated cheques, e-transfers (to <u>Treasurer@StamfordLaneUnited.ca</u>) and PAR – the United Church's automatic deposit service. All eligible money received will be credited to your 2021 Tax Receipt. If you require assistance to make a donation, please contact Ray or Leslie. We are here to help.

INCOME:

- Local Offering was only down from 2019 by \$4,000
- Rent revenue was down significantly, as our building was completely closed for 3+ months
- Amazingly, the Turkey Dinner Proceeds & Sponsorships are similar to 2019
- The Government of Canada made a loan/grant available to some churches; we qualify because we have rental income and report it on our charity report. It is an interest-free loan until December, 2022. If it is completely paid by then, one-third is given to us as a grant \$20,000. The Government also made a wage subsidy available to us. This wage subsidy started at 75% of wages (with a cap) and is decreasing over time. It also requires us to compare income from 2019 to that of 2020 in the formula. This grant is continuing for the first half of 2021, but no details of its calculation have been released. Transitions Canada qualified for the rent subsidy and we received a grant of \$1,733.27.
- The Niagara Extension Council gave us \$1,500.00 towards the cost of our Land Registration that we paid in 2019. They also gave each church in the former Niagara Presbytery a COVID Grant of \$2,500.00.

EXPENSES:

- Salaries are as budgeted.
- Worship & Service
 - Most are normal, but Council did approve Goats, Sheep, & Donkeys, and so that line is over budget.
- Christian Ed & Development
 - We only spent \$150 on Sunday School supplies early in the year.
- Operating & Building
 - Office Expenses included service charges, postage, supplies and printing, computer program licenses
 - o The purchase of a new office computer was approved by Council
 - o Here is where we show investing \$20,000 from the General Fund

We received \$60,281.38 more than we spent and so our General Fund Balance on Dec. 31, 2020 was \$68,967.85

Of this, \$60,000 is the CEBA loan/grant and \$8,967.85 is cash in the General Fund, very close to our 2019 balance.

- Dinners: the income & expenses were from the Perhaps Love concert held last February
- The 2019 rebate \$362.03 and the 2020 rebate of \$271.03 remain in the line.
- Good News Unit income was chiefly from their Chili & Trivia night; expenses were at their direction.

- Investment Holding here is where we moved money from Directed Funds to Investments.
- The Memorial fund was used to purchase a new projector for the sanctuary.
- I have a mea culpa here. Early last January, we received a memorial donation of \$25 from the funeral home, with the instruction that the person get a tax receipt for the money in 2019. We did this, but I reported the \$25 as in the Memorial Fund in the 2019 Annual Report. I should not have done that. Thus you will see that the amount in the Memorial Fund to start 2020 is \$25 less than reported in the 2019 Annual Report. I won't be making that mistake again.
- M&S funds are remitted to the United Church of Canada quarterly. This year we sent \$21,761.20, which includes a donation of \$1,500 from GNU; also \$422.00 collected for World Development.
- Mission Ctte: income is from Pancake Lunch; expenses: \$600 to Women's Place of South Niagara.
- Organ was tuned in October -- \$484.77
- Planned Legacy Giving: received donations from the Munro & Turnbull families.
- On behalf of others we collected \$625 for Guardians of Hope, \$1,625 for NF Community Outreach, and \$2,915 for Project Share; the White Gift collected \$5,060 and all the moneys left after purchasing the food vouchers was given to Project Share
