Agape` Pest Control shall install a bait monitoring system for the Customer's structure specified in this agreement. **Formosan and Drywood termites are not covered with-in this contract.**

Agape` Pest Control shall treat any area infested of the structure and 10 feet to either side of the infestation @ **\$6.50** per linear feet.

**This service will expire if the account is past due for more than (90) ninety days from the date of the previous monitoring cycle or if customer refuses regular monitoring. There is a \$50.00 renewal fee for a Service re-instatement of a canceled account from date of cancel to 3 months.**

**CUSTOMER'S OBLIGATIONS TO MAINTAIN SERVICE:** Customer agrees to maintain the structure free from any conducive conditions and in ordinance with terms of this contract. In the event the premises are structurally modified or altered, Customer agrees the alteration is not covered and additional stations may be needed at **\$15.00** per station. Customer agrees that payment is due at time of service. Agape` Pest Control will add stations to the alteration as an additional monitoring. **THIS MONITORING SERVICE IS NOT A GUARANTEE AGAINST TERMITE NOR HAS ANY TREATMENT BEEN MADE AT TIME OF INSTALL. THE HOME IS NOT COVERED UNDER ANY GUARANTEE.**

**RENEWAL:** To maintain this Service, Customer shall pay a Quarterly monitoring fee of **\$30.00**.

**REINSPECTION/WINTER MONITORING:** Agape` Pest Control monitor's station four times a year including winter months. In the event the stations are inaccessible due to weather conditions the regular charge will be applied to the account. The customer may request an interior termite inspection in place of bait monitoring by contacting Agape` Pest Control. Agape` Pest Control will make regular inspection if required by applicable state law or regulations.

**LIMITATION OF LIABILITY:** Customer acknowledges that Agape` Pest Control is performing a service and, except for any damage caused by Agape` Pest Control or any of the companies employees. Customer understands that any natural disaster by flooding, or acts of God that are beyond our control void the guarantee and the service of this contract.

**CANCELLATION: CUSTOMER MAY CANCEL THIS AGREEMENT AT ANYTIME PRIOR TO MIDNIGHT OF THE 3<sup>RD</sup> BUSINESS DAY AFTER THE DAY OF THIS TRANSACTION.**
