This Welcoming Committee Charter ("Committee") of Willow Forest Homes Association Inc., is made by WILLOW FOREST HOMES ASSOCIATION INC., ("Association").

Background Statement

WHEREAS, Article IX of the Bylaws of Willow Forest Homes Association Inc. ("Association")., recorded in the office of the County Clerk of Harris, Texas, under Clerk's File Number U144810, as same has been or may be amended from time to time, the Board of Directors ("Board") is authorized to appoint committees to perform such tasks and to serve for such periods as may be designated by a resolution adopted by a majority of the directors present at a meeting at which a quorum is present. Each committee established by the Board shall operate in accordance with the terms of the resolution of the Board designating the committee

Pursuant to this authority, the Board has resolved to create the Welcoming Committee of the Association which is governed by the terms set forth in this Charter.

Membership: The Committee membership shall consist of a minimum of 3 and a maximum of 5 property owners or residents of Association. Members shall serve a term of (2) two years. Members must be in good standing (assessments paid in full and no pending legal action) with the governing documents of the Association.

A Committee member can be removed by the Board if they violate any provision of this Charter, or cause which includes, but is not limited to:

- Any act of harassment towards any Committee member, Board member, member of the Association, or Managing Agent;
- Any detrimental or abusive attitude or behavior toward any Committee member, Board member, member of the Association, or Managing Agent;
- Participating in the reckless or intentional misrepresentation of the information relating to the Committee, the Association, the Board, or the Managing Agent;
- Using the contact information of any Owner within the Association;
- Communicating directly with any vendor of the Association or requesting a vendor to submit a bid to
 provide services to the Association without the express written approval to do so from the Board;
- Failing to fully disclose to the Association any personal or business relationship with a vendor of the Association;
- After missing three consecutive meetings of the Committee;
- If the Committee member becomes a member not in good standing of the Association

Objectives/Purpose: Create a Welcome Packet for new homeowners, Give them items that will help them settle in. Examples of items, but are not limited to:

- Utilities, names and contact numbers
- Board Members, Willow Forest website, board email
- · Website link to obtain governing documents
- Current newsletter
- Area services and restaurants
- Community Amenities

Organization/Meetings: The Board will elect a Committee Chair to lead and organize the Committee. The Committee may meet in person or communicate by any means it deems appropriate. Minutes of meetings are not required, but records must be kept as appropriate. Except in the case of written reports submitted to the Board. Committee records shall not be considered official records of the Association.

Authority: The Committee members do not have the authority to commit or expend Association funds without prior approval from the Board. By September of each year, the Committee should develop goals and submit a request for an amount to be considered by the Board for the next year's budget. The approved budget amount does not provide approval for specific projects or expenditures throughout the year.

Reporting: The Committee chair shall provide monthly updates to the Board Liaison. Any document submitted to the Association shall not be considered as an official Association record...

Duration: The committee is established in perpetuity to welcome new homeowners to the" community or until a different function is established or no longer required.

NOW, THEREFORE, by execution below, the undersigned officers of Willow Forest Homes Association Inc. certify that the Welcoming Committee Charter of Willow Forest Homes Association Inc. attached hereto have been adopted by a majority vote of the Board of Directors at a duly called meeting thereof held on upon recording shall immediately become effective.
