INFORMATION

- **TO BE ELIGIBLE FOR FINALS, YOU MUST BE A CURRENT MEMBER OF THE SDCC AND HAVE COMPETED AT ONE JACKPOT AS AN SDCC MEMBER.**
- **3D SLOT RACE:** THIS CAN BE YOUR QUALIFYING RUN FOR THE FINALS ON SATURDAY AND SUNDAY. YOU ARE NOT ALLOWED TO RUN IN THE SLOT RACE ONLY.
- **FRIDAY NIGHT RUN:** SDCC SANCTIONED RUN FRIDAY NIGHT- 4:00PM. PRE ENTRY WILL BE AVAILABLE, ENTRIES TAKEN THAT NIGHT WILL GO IN THE LATE DRAW FRIDAY. IF YOU RUN IN THIS RUN TO QUALIFY FOR FINALS, YOU WILL RUN IN THE LATE DRAW SATURDAY AND SUNDAY.
- **DRESS CODE:** WESTERN ATTIRE IS RECOMMENDED. HATS, LONG SLEEVE (DO NOT NEED A COLLAR) AND BOOTS. YOU CAN WEAR SDCC SHIRT AND HAT. \$5 FINE IF YOU LOSE YOUR HAT.
- **VET RELEASES:** VET/MEDICAL RELEASES WILL BE ACCEPTED UNTIL 10:00 AM ON JUNE 29TH. CALL EMILY IF YOU NEED TO VET OUT. 507-227-5900. PROCESSING FEE WILL NOT BE REFUNDED.
- **NO REFUNDS** WITHOUT VET RELEASE. IF YOU NEED TO SWITCH TO A DIFFERENT HORSE YOU CAN.
- **KIDS UNDER 10 MUST CHOOSE BETWEEN THE PEEWEE AND YOUTH. THEY CANNOT RUN IN BOTH.**
- **MONEY WILL BE PAID ON EACH GO-ROUND WITH AWARDS TO THE AVERAGE OF TWO ROUNDS.**
- **PAYOFF WILL BE DETERMINED BY TOTAL NUMBER OF ENTRIES IN EACH CLASS.**
- **YOU MUST RUN THE SAME HORSE IN BOTH GO-ROUNDS TO BE ELIGIBLE FOR AWARDS.**
- **DRAW:** A RANDOM DRAW WILL DETERMINE THE RUNNING ORDER.
- **AN ELECTRIC TIMER WILL BE USED. TIPPED BARRELS ARE A NO TIME.**
- **CAMPING:** PICK YOUR SPOT. YOU WILL HAVE TO PAY THE \$35/ NIGHT FEE EVEN IF YOU USE A GENERATOR.

- **IF YOU RUN OUT OF TURN YOU WILL BE DISQUALIFIED. DOUBLE CHECK THE POSTED DRAW AND LISTEN FOR YOUR NAME.**
- **YOU MAY CIRCLE IN THE ARENA- ONE OR TWO WILL DO!**

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
 - Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
 - Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
 - Form 1099-S (proceeds from real estate transactions)
 - Form 1099-K (merchant card and third party network transactions)
 - Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
 - Form 1099-C (canceled debt)
 - Form 1099-A (acquisition or abandonment of secured property)
- Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See later.
