Presidents Corner:

1.1.1. Subcommittee Reports

The MSCA is interested in any safety concerns, target quality, facilities, registration and the overall shoot experience at our clubs. Often the clubs do not reach out to ask for help even when they need it. Since we are not a governing body, we can just suggest helpful information, but between us we are a wealth of information. We have a number of shooters that can help with target setting, and Dan Williams is our Scorechaser guru etc. It is also helpful to have committee members from all sides of the state.

*These members work on our two main fundraisers of the year and anything new that we might acquire. Much of the work for this will be prior to the state shoot in June. Each year our sponsors provide us with a gun and a set of Pilla glasses to raffle off. Flyers need to be made, publicity, tickets, selling tickets at the shoot, winner selection etc. For 2025 we decided to provide all of our giveaways at the state shoot, instead of spreading them out throughout the year. We also purchase flats of shells to be given to the shooters.

*These members handle the shoot scheduling, card and poster design with Value Print in Ann Arbor. After printing, the items need to be shipped to the clubs. Also, at the State Shoot and Great Lakes, the committee would be responsible for posting all sponsor flags on the property and removing them as well. Most clubs are really helpful with this process.

1.2. Secretary's Report/NSCA News

*This information is intended to bring everyone up to speed on our MSCA big events this year, and what decisions have already been made.

*Michigan State Championship: June 20-22 at the Grand Blanc Huntsman's Club. The MSCA gives them \$4500 plus \$2500 for trophies for hosting the event. We also give them \$3000 for additional enhancements. They have opted for us to assist them with trappers. I have already been in contact with 2 MISCTP teams in the area that want to use this as a fundraiser for their team. These teams do not pick their members until February. They need to be contacted after they have their team in place. The \$3000 will pay the trappers with either shoot cards or ammo. 20 people are needed for 2 days for the main event only. Brooks said that he will help me train/organize this prior to the shoot. Very little training should be required. Also, Brooks is working with Grand Blanc to bring in Top Gun Make-a-Break as a side game for all 3 days. Jovan felt very strongly that the Top Gun needs to be a part of our state shoot. Details to be determined.

*Great Lakes Tournament: Multi-Lakes Conservation on September 20-21. Not much information is available yet, but it is possible that they may work with Detroit Gun Club again to provide extra events. TBD

*Michigan State team is selected each year. Traditionally the trophies are awarded at the state shoot. Trophies of some kind need to be purchased after the team is announced.

To date: 1,286 followers (up from 1,248 end of Q3 2024). During the last 28 days, 7,226 people have seen something from or attributable to our page. 21,489 over all of Quarter 4! (6,700 for all Q3!) and 2,429 people have visited the page. The past week, content has only reached 577 people. We are definitely into the end of the shoot year - holiday lull in activity. From October 12, 2024 to January 12, 2025 (3 months) 259 people have engaged with the page – a decrease, 385 people during the comparable span in 2023.

End of Year 2024 review:

Since the 2023 EOY Report: 1,286 followers (up from 1,130 end of Q4 2023). 120 followers in December 2019.

Quarter 4 review:

Since previous report (Q3 October 2024): Followers/Page Likes continue to increase. Overall engagement overall slightly higher than with previous Quarter 3 reports. Overall engagement decreased slightly with the end of tournament season (end of quarter), also consistent with previous reports. Overall views greatly increased. No great increase in followers would indicate this is due to more informative posts and followers passing notices on to others outside of the shooting community. We have seen similar trends when junior shooters make the page.

Page Reach (since the previous report): Age (35-64) and M/F (86%/14%) demographics remain constant. People reached (content shows up on their individual page) and people engaged (comment on our posts) consistent with previous reports. Most people reached/engaging/following the page are in the SE Michigan area.

- I won my first state championship in 5,050 registered targets in 2009 while in AA class against Hall of Fame shooters Pat Lieske, Matt Houtteman, Joe Huff, Deeann Massey and Red Ball.
- I punched into master class 5,900 targets. I won my second state championship in 2016 and the majority of
 my titles up to that point in 20,850 targets, in my first 12 years of registered shooting.
- Major accomplishments: Michigan State CH 2009, 2016 (60 pts). Runner up state champ 2010, 2013 and 2015 (60 pts). In 2009 US Open AA main event champion (20 pts). Michigan state championship 12ga Fitasc CH 2016 (20pts). Michigan State Championship 5 stand CH 2019 (20pts). Motor state champion 2011 and 2015, runner up 2012.
- Points to date for the MSCA point system is 390 (20 yrs MSCA 100 points, 11 yrs all state team 110 points, open champ/runner up titles 180 points). In the next 2 years, or possibly this year, I should reach 400 points.

SUBJECT: HALL OF FAME RESUME

Thanks for the nomination to the Michigan Sporting Clays Hall of Fame. It's a great honor and I am very appreciative. Not sure what you are looking for in a resume, my shooting history or owning Pacific Sporting Arms, so I will give you a bit of both.

This was a life-changing event, and nothing would be the same after. Within a week I had a new Browning over under and expanded to skeet and eventually a new game just starting in the United States, Sporting Clays. I fell in love with all the clay target disciplines, from Skeet, Trap, Sporting Clays, Olympic skeet and trap, live pigeons, upland birds. I have shot close to 2 million shot shells in my lifetime with over 300,000 NSSA, NSCA, ATA registered tournament targets. I was proud to attain AAA Skeet class, Master Class Sporting, Long yardage ATA Trap all at one time. I have been on over 20 All American Teams.

In 1998, my love of clay target sports expanded with the opening of Pacific Sporting Arms in Southern California. We specialized in fine clay target and hunting shotguns. Selling only the best in quality and service. We represent over 20 of the finest makers of shotguns made in the World today and carry the largest inventory of these fine guns in the United States. In 2015, we started another store in Commerce Township, MI. I grew up in White Lake, MI and it was a perfect opportunity "come home". Every year I would travel to shoot at the Detroit Gun Club and realized I never wanted to leave and go back to California, so opening a store was a great way to be able to spend time in my original home.... Michigan!

With the two full time stores as well as satellite stores in Texas and Ohio, Pacific Sporting Arms has become the largest dealer of fine shotgun in the World, but from the beginning of Pacific Sporting Arms 27 years ago, I felt it was important to support the shooting sports as best I can. This started out with small shoot sponsorships and



donations for raffles and auctions. After a few years we were sponsoring major shooting events in Southern California and the Southwest United States. We now sponsor major shoots all over the United States. With the move to Michigan, I continued to help and anyway I could by sponsoring shoots and stations at the Detroit Gun Club and at other clubs throughout Michigan. We help sponsor the Michigan State Sporting Clays Championships every year as well as the Michigan Skeet Championships and Michigan Trap.

It has always been important to me to support and give back to the game, I have loved every minute of it from the competition to the hundreds of friends I have made around the World in the clay target World.

Being inducted in the Michigan Sporting Clays Hall of fame, is one of the greatest honors I have had in my shooting career, and I would like to thank everyone who made it possible, and I promise to continue my support of Michigan Sporting Clays in the years to come.
