Most if not all of their complaints have been tried in the past with little to no participation. Every state operates independently which provides the shooters with different shoot experiences. The board is looking forward to our Great Lakes Tournament at Hillsdale on October 5th.

\*Brooks noticed that some medals printed on the State shoot flyer were not given out at the shoot. Not sure what happened.

\*Detroit Gun Club opted not to use a shooter master list for the main event. That is a requirement written in our bylaws. For next year, we need to be sure that the master list is used for the main event.

### 1.1.1.1. Liaison to Member Clubs

\*Any news from monthly shoots from Bald Mt (96), Kent County (22), Two Hats (34), Action (39) or Charlevoix (21)?

\*Mary Jo heard from Dave Scott at Kent County that the shooters thought the targets were very difficult at their last shoot. The HOA score was an 82 shot by Les Housler.

\*Two Hats had their second shoot. There were fewer people this time, but the targets were great.

\*Action had their first shoot of the year. Kim Jones said the targets were great and they had a great time.

### 1.1.1.2. Fundraising

\*Nearly \$2000 was raised at our earplug sale at the State Championship. The drawing took place and Kevin Radtke was the winner of the Fabarm Sporter semi-automatic shotgun generously donated by Pacific sporting Arms. Thanks to Jim, Matt, Brooks, Mary Jo and the DGC girls for selling the 200 tickets.

\*Our next earplug sale will be held at the Great Lakes Tournament at Hillsdale on October 5-6. As a bonus, Clay Target Vision has donated a \$1300.00 gift certificate to purchase a set of Pilla glasses. We have the case and the certificate already in hand thanks to Greg.

\*Tickets will be \$10 each for one set of earplugs. With each set of earplugs purchased you will receive one ticket for the Pilla shooting glasses set. Only 130 sets of earplugs will be sold. When all of the ear plugs are sold, the winner will be drawn.

### 1.1.1.3. Liaison to SCTP

\*604 MISCTP shooters attended the 2024 State Championship at Mason this year. 306 shot the sporting clays event. Two shooters had scores of 91. Matt Gay set the sporting clays targets again this year.

\*Twelve scholarships were given away to high school graduates ranging from \$1250-\$4000. \$33,800 in total was given away. Last year's total scholarship pot was a little over \$20,000. Loraine was able to find a number of new sponsors for this year.

\*A new grant of \$70,000 has already been received from Midway for further improvements. 2 more skeet fields will be built, and more traps will be purchased. An additional \$40,000 has already been donated to add 2 Helice fields.

\*Checking account balance is \$28,409.41 which does not include the earplug sale money (\$1990) or the state shoot fees from Detroit Gun Club (\$2400). Approximate total \$32,799.41.

\*Money expected to go out: Spartan Purse, \$2500 to Hillsdale for the Great Lakes, drinks and snacks for the Great Lakes approximately \$200, \$512.66 for the State team trophies, and the webmaster salary.

\*Money expected to come in: Shoot fees from 38 shoots in 2024.

## 2.1. Spartan Series Update

### \*The State of the Spartan!

\*The board members all agree that the Spartan Series rules and details were not communicated to the shooters as well as they should have been. The Spartan flyer was sent to Dan on March 5th and March 18th. On March 30th the rules and club responsibility forms followed. I don't know if the clubs ever got their responsibility forms which left them unprepared to answer shooters questions at registration. The Spartan flyer and rules did not get e-blasted out to the shooters as planned. On May 5th the Spartan information finally went out. As a result of the miscommunication, many shooters did not pay into the purse at one or more of the first two Spartan shoots. Some shooters that wanted to be included in the end of series payout are not eligible. The board will discuss whether it would be better to cut the Spartan Series short or continue on as planned. Votes to discontinue the Spartan purse and refund all the money/Matt and Jim. Votes to continue with the Spartan Series as planned/ Mary Jo, Charlie, Greg and Brooks. The Spartan Series will go on as planned.

# 3. NEW BUSINESS

## 3.1. 2025 Michigan State Championship

### 3.1.1. 2025 Michigan State Championship

\*A corrected bid was sent to all board members after our ZOOM meeting with Len Smith and Vince Lori on July 2nd.

\*Grand Blanc withdrew their Great Lakes bid for 2025 and put in a bid for the 2025 State Championship instead. They contacted Promatic to work out a deal so they will have enough traps to run a 200-bird main event. The entire State Championship will be completed in 3 days.

\*The new bid includes: a 100-bird preliminary event on Friday, a 200-bird main event on Saturday and Sunday, a 50 bird FITASC event, and a 50 bird 5-stand. All sporting events will be run with at least 16 stations with 2 rotations per day.

\*Box lunches will be available for purchase on Friday. Saturday and Sunday lunch will be included with the shoot fees.

\*The \$3000 MSCA enhancement fee could be used to pay for the main event trappers. I have agreed to help them locate trappers from their area. I am already looking at high school boy scout troops and dads in the Grand Blanc Area to fill the need. Vince said that we would need 16-20 trappers for each day. Grand Blanc can provide the extra trappers so only 16 would be needed. Brooks, I am hoping that you might help me with this task since this is your home club. There is a good training video on-line, but probably a one-day session might be needed to be sure that the trappers are all up to speed. This could be a good fundraising opportunity for the boys. It was also suggested that we might use SCTP shooters instead. Brooks will try to get me contact information from Grand Blanc.

\*The date for the shoot will be June 20-22, 2025. It was important to do some research to avoid scheduling conflicts with one of our border states. The following have dates already on the calendar that could cause a conflict: WI State Shoot July 9-14, Ohio State shoot July 31-Aug 3rd, Indiana state shoot Aug 14-17, US Open April 28-May 4, NC Regional August 6-10, NE Regional June 10-15, SE Regional October 1-5, SC Regional September 10-14, Western Regional August 27-31 and National Championship October 18-26.

\* Suggestions for next year's state shoot: 1. Offer Lewis class and Class purse for the main event only. 2. Snooker -Grand Blanc has had it in the past.

\*Grand Blanc will host the 2025 Michigan State Championship.
