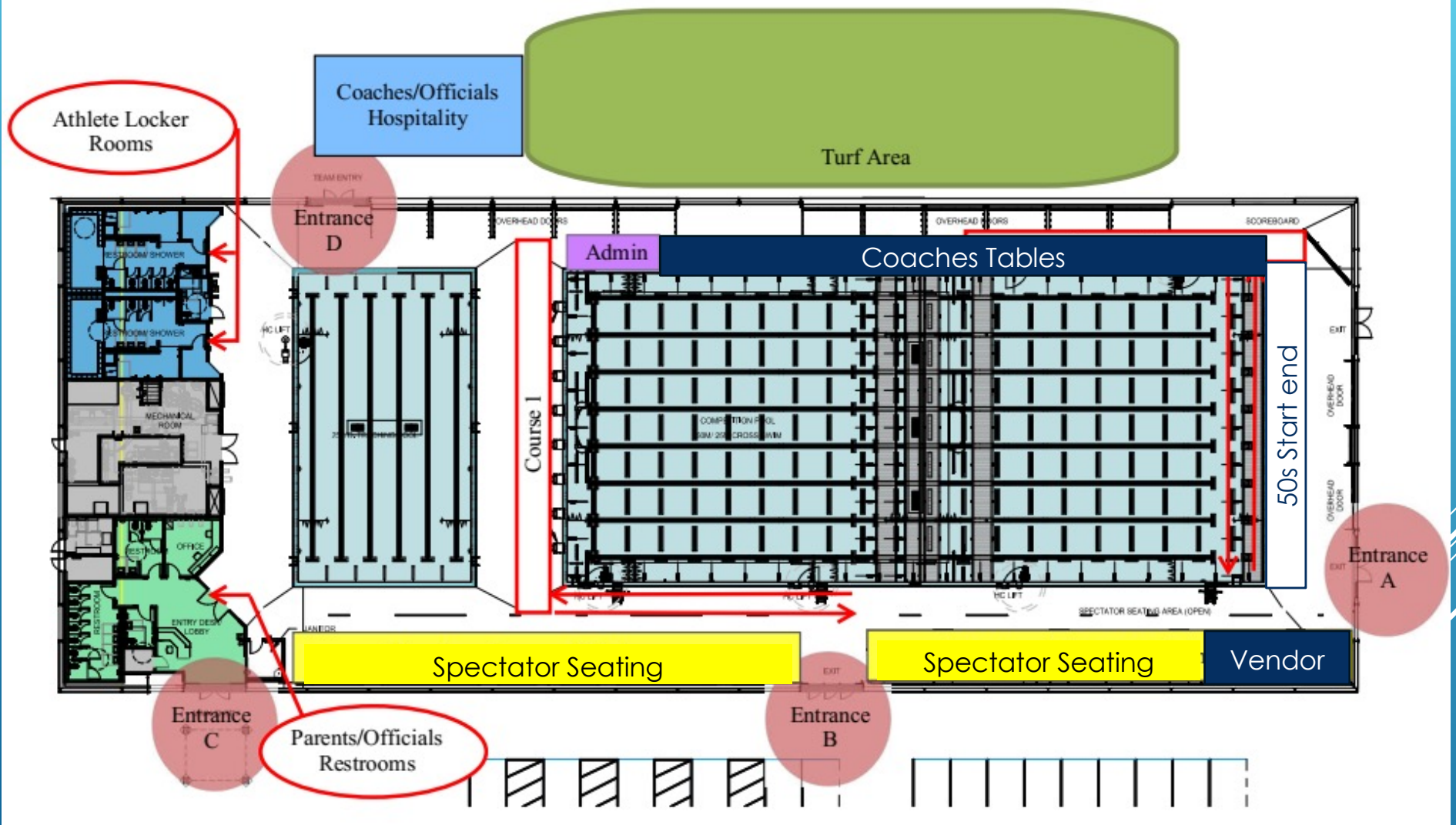

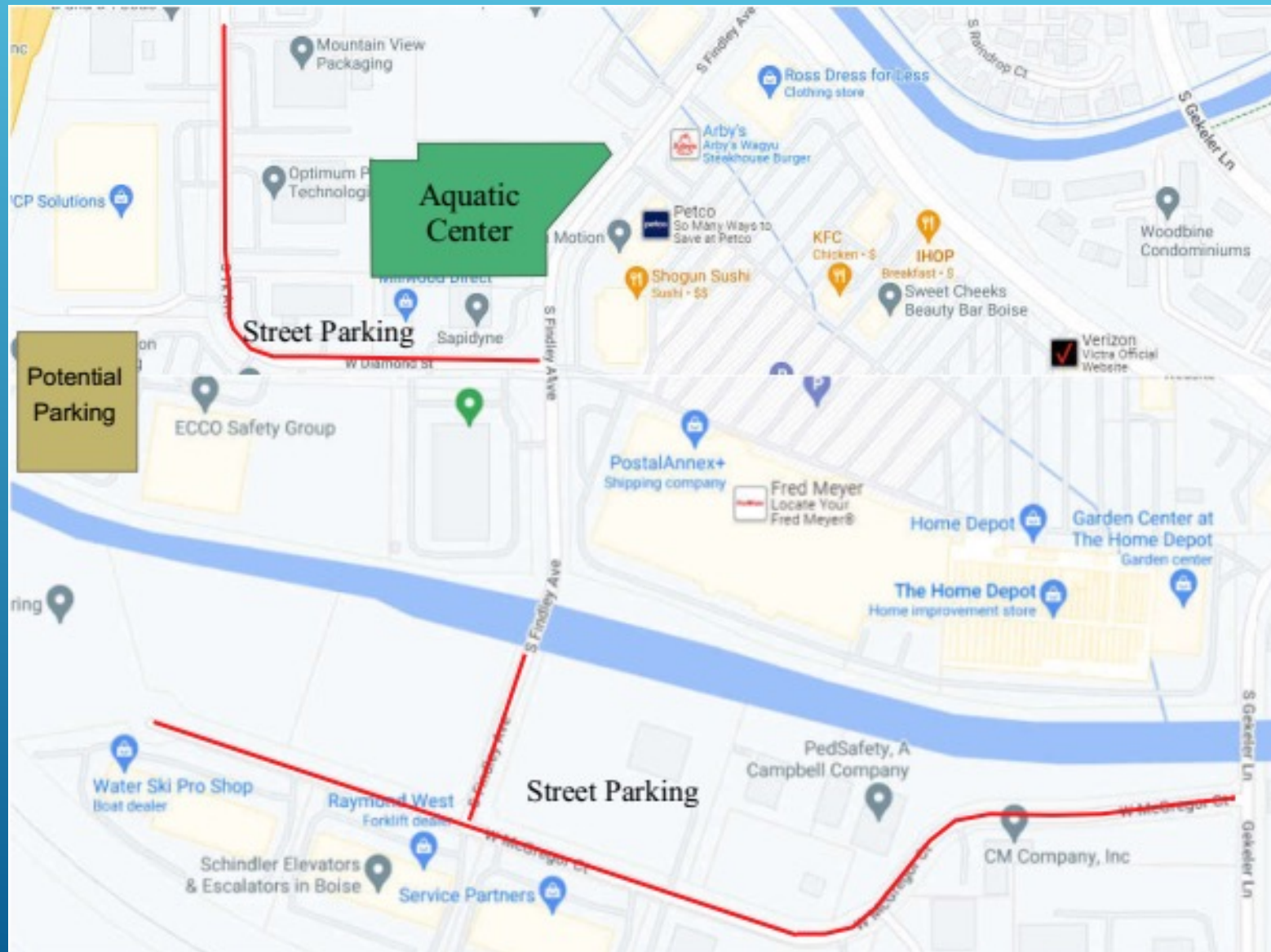

Schedule- Prelims

- ▶ Warm-Ups 7:00 AM – 8:50 AM
- ▶ Competition 9:00 AM
- ▶ Time Trials
 - ▶ Approximately 15 minutes following conclusion of Prelims
 - ▶ Approximately one (1) hour on Thursday, Friday & Saturday
 - ▶ Distance Time Trials will be offered Friday ONLY
 - ▶ Sunday – limited to approx. 30 minutes

Scratches

- ▶ **Wednesday - Saturday:**
 - ▶ **Prelim Events and Relay Events:**
 - ▶ *Deadline is 6:00 PM evening prior*
- ▶ **Relays & 1800/1500 Freestyle athletes** may request to **swim in prelims** session
- ▶ **FINALS Scratches**/Intent to Scratch:
 - ▶ *Within 30 minutes* of announcement of qualifiers
- ▶ **SUNDAY FINALS**
 - ▶ *If your team is leaving after Sunday Prelims – PLEASE notify Admin*

2026 SPEEDO SECTIONALS – BOISE, ID

Be Mindful of Event Limits

- ▶ 3 individual events/day (including TT)
 - ▶ 6 individual events/meet (not including TT)
 - ▶ 3 time trial events max /meet
 - ▶ Must properly SCRATCH by deadline—DFS and NS count towards event limit

2026 SPEEDO SECTIONALS – BOISE, ID

No-Shows

- ▶ *Individual Prelim/Timed Finals Events*- Barred from all further competition that day, including relays, and must positively check-in with Admin Referee prior to the scratch deadline in order to be seeded in subsequent day's events
- ▶ *Finals*—Out of meet
- ▶ *Relays*—No penalty, but please scratch to allow for full heats and the best experience for all
- ▶ Buy-Back Procedure

2026 SPEEDO SECTIONALS – BOISE, ID

Seeding

- ▶ Prelims—Fast to slow with the top 3 heats of 200 or less, and the top 2 heats of 400 or more are circle-seeded * ***Fastest Athlete in Heat 1***
- ▶ Finals—Slow to fast: D (18U), C Final, B Final, Championship Final

2026 SPEEDO SECTIONALS – BOISE, ID

Meet Operations – On Deck Admin. Referee

- ▶ Declared False Starts:
 - ▶ Pre-session – see the On-Deck Administrative Referee in Admin Tent
 - ▶ During the session – see the Chief Judge or the Deck Referee at the Starting area.
- ▶ Questions regarding Disqualifications – Report to Chief Judge in starting area.
- ▶ Special Needs or Requests – Please coordinate with Judi Creech in advance (or Ed & Ryan).

Meet Operations – Relay Cards

PRELIM Names are due by:

- ▶ 8:00 AM on Thursday
- ▶ 10:00 AM on Friday and Saturday
- ▶ 9:00 AM on Sunday

FINALS Names are due by 6:00 pm

Relay Cards:

- ▶ Will be available to take to the blocks from Admin
- ▶ *Remember, no-show in prelims = may not participate on relays that day, whether in prelims or in finals*

Meet Operations – Finals & Awards

- ▶ **Finals – 4 Heats in the order of D, C, B, A**
 - ▶ D finals are 18U only (D Final is not scored)
 - ▶ *Championship A Final WILL be paraded* & introduced at the starting blocks. Please have athletes report to Ready Area by Lane 8.
 - ▶ Alternates must be in the start area ready to swim; we will not call for alternates. 18U D Final will have their own alternates
- ▶ **Awards: Top 8 Individual Events – Top 3 Relays**
 - ▶ *Championship A Final Awards will be presented immediately following their swim to the Top 8 Finishers.*
 - ▶ Awards to be presented by the Coach, if available, of the 1st Place athlete

Meet Operations - Swim-offs

- Swim-offs may be required for ties in positions for 8 & 9, 16 & 17, 24 & 25, 32, 33, & 34
- ▶ Coaches Cell Phone #s are *REQUIRED*.
Please provide at check-in.

► **Time Trials**

- Time Trial Referee – Aline Benson
- Coordinator – Ann Erwin (Clerk of Course desk)
- Offered on all days.
- Starts approx. 15 minutes after end of prelims for about one hour
- Each Day's Sign-up offered at clerk of course at 7:00AM. Sign-ups close at. 10:00AM. .
- Time Trials for the 800 Free & 1500 Free Distance events to be offered only on Friday
- Must stay within limit of 3 individual events per day—any overages over entry limit will be scratched without refund.
- Limit of 3 time trials per meet.

REMINDERS

- ▶ **REQUIRED:** Complete USAS Competition Waiver for all athletes (boisesectionals.com)
- ▶ Provide own timers (2) for time trials, 800 & 1500 Freestyles, and a person to count, if desired.
- ▶ Changing in or out of swimsuits other than in locker rooms is prohibited.
- ▶ No Paddles or Fins allowed in Competition pool. Soft Equipment may be used in warm-down pool.
- ▶ **REQUIRED:** Coaches must present USAS certification to receive credential
