1.	The authors grant the producer the right to stage a production of Speak Up!, royalty free.
2.	All ticket sales and proceeds of the play must be donated to a suicide prevention organization of
	the producer's choice or to the nonprofit organization "Theatre on Purpose" to support its suicide
	prevention work through Project SPEAK UP! If there are no formal ticket sales, the producer must
	make available the opportunity for the audience to make donations that can then be donated to
	a teen suicide prevention program.
3.	Proof of donation must be sent to the authors within one month of the final presentation c/o Amy
	Luskey-Barth, Theatre On Purpose, 141 Savona Walk, Long Beach, CA 90803.
4.	The program distributed to the audience must include literature about the chosen suicide
	prevention organization, including but not limited to phone numbers where a teen in need can
	seek help.
	It is HIGHLY RECOMMENDED that a trained counselor be present at any presentation of Speak
	Up! to facilitate discussion, reference support materials and/or refer students in crisis.
5.	The title and authors will receive the following credit in the program distributed to the audience:
