## MEMBERSHIP APPLICATION

**OBJECTIVES:** To ensure a close working relationship with water/wastewater operators within our territory and to help support the advancement and knowledge of public water supplies.

To hold regularly scheduled workshops, with guest speakers, where members may discuss and exchange ideas affecting the water supply and wastewater treatment of the communities they represent.

**UTILITY MEMBER:** Shall be an operator, superintendent, manger, or officer of a municipal or private water works; a civil, hydraulic, or sanitary engineer; a chemist or bacteriologist; a State or local health officer or representative of a State regulatory body governing water supply; or any qualified person engaged in performing services to the water wastewater industry.

**ASSOCIATE MEMBER:** Shall be an individual representing a manufacturer or corporation engaged in the furnishing materials or supplies for the construction, operation, and maintenance of water works; a consultant in engineering, public health, or advisory capacity for water supply or wastewater treatment units; or a person engaged in performing services to the water or wastewater industry.

**DUES:** Full payment of dues is required upon membership registration for the remainder of the calendar year and will again become due January 1 of the following calendar year. A member, to be in good standing, cannot be delinquent in the payment dues for more than six months. Annual dues for Utility Members shall be ten dollars (\$10.00). An Associate Membership is thirty dollars (\$30.00) for the principal member of any manufacturer or firm, and ten dollars (\$10.00) for each additional member of said firm.
