# Privacy Policy

- To send periodic communications (ex. newsletters or event updates)
- To comply with legal obligations or protect our rights

We do not use your personal information for automated decision-making or profiling.

## 3. Sharing of Your Information

We do **not** sell your personal information.

We may share your information with:

- **Service providers** (ex. email providers, CRM platforms, analytics providers)
- **Legal and regulatory authorities**, if required
- **Business partners**, only with your explicit consent or to deliver co-branded offerings

All third parties are required to process your information in accordance with applicable privacy laws and this Privacy Policy.

#### 4. Data Retention

We retain personal data only as long as necessary to fulfill the purposes for which it was collected, including legal, accounting, or reporting requirements.

#### 5. Security

We implement appropriate administrative, technical, and organizational safeguards to protect your data. However, no transmission method is 100% secure. If you believe your data may have been compromised, contact us immediately.
