Use of Cookies

Uskoa, LLC, b/b/a The Clayton Team, The Clayton Team powered by Paragon Mortgage Services, Inc, Paragon-Loans.com and LinneaClayton.com website uses 'cookies' to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by the web server in the domain that issued the cookie to you.
