TONTO BASIN COMMUNITY MEETING MINUTES WITH SUPERVISOR HUMPHREY

August 9, 2022

Supervisor Humphrey covered his recent activities. He attended 3 Agenda Meetings, the Arizona Office of Tourism Best Marketing Program Awards Gala for Discover Gila County Website, a Republican Club Meeting, a Miami Town Council meeting for a presentation by Copper Corridor Blight Busters, held a Gisela Community Meeting, held a Roosevelt Community Meeting, was on KQSS on the 8th at 5:30 PM, will attend a Stagecoach Drainage Project Meeting on Wednesday, will attend the Gila County LEPC Conference on Thursday.

Supervisor Humphrey shared the latest Bridge update: Ames Construction was awarded the contract for the Tonto Creek Bridge. We are still planning to begin work on October 1st. On July 5th the Board of Supervisors approved an amendment to the ground lease for CCAT LLC for the land where the cellular tower is located. The amendment extends the lease term for 4 renewals of 5 years each through June 4, 2043. Construction on the new tower has begun and once completed, the old tower will be removed.

Supervisor Humphrey shared the Fairgrounds Update: On Tuesday August 2nd the Board of Supervisors awarded Sunland Asphalt the contract to remove and replace the asphalt at the fairgrounds. They will have the work completed prior to the fair on September 22 through the 25th . Convenient Mobile Services, LLC was awarded the contract for material hauling, ground preparation, and installation of the portable roping arena at the Gila County Fairgrounds. The arena work is scheduled to be complete on September 1st . Dixon Rock also demolished and removed the old racetrack, outbuildings, and announcer booth. We will be holding a meeting for

stakeholders at the fairgrounds on August 16th to discuss future plans and uses of the facility.

At our last meeting a resident asked if we have someone come and discuss water issues. Joel Rose of the Cobre Valley Watershed Partnership will be attending our September 6th meeting.

Supervisor Humphrey explained to the residents that Gila County had created a tourism website specifically to highlight the places of interest in our county. The website has won 7 awards to date and during the covid crisis use of the site allowed the county gain funds from tourists rather than lose money.

Supervisor Humphrey then discussed how many of the county ordinances are outdated and do not serve the residents in today's world. He let residents know that the Board is aware of this and is working to change the ordinances to fit better with current lifestyles. He discussed the Rural Addressing ordinance. The ordinance was last updated in 1990 when a landline telephone was required to have a parcel of land addressed. He said that Tom Homan, Gila County Rural Addressing, had worked very hard to rewrite the ordinance. Supervisor Humphrey said that allowing vacant land to be assigned an address was very important to the county. He stated that with building costs being so high, property owners might opt to purchase a park model home or simply use an RV. With the changes made to the ordinance, they will now be able to do that.

Tom Homan – Tom discussed the changes he had implemented in the new ordinance. Residents will now be able to obtain an address for their land by submitting a site plan and paying the \$200 fee. He said that if residents build on the land within one year, the \$200 fee will be transferred to Community Development to help cover costs of building permits. He said that having an address on vacant land will not qualify residents for a free PO box due to post office policy. In order to get a free PO box residents must actually reside on the addressed property. Tom explained that the 911 addressing was originally to help first responders locate people that called 911. With the advent of cell phones 911 works differently now. Instead of using the address of the landline telephone number, 911 operators utilize the GPS in callers cell phone to pinpoint their location.

A resident stated that they needed help with Lake Vista dike. He stated that it had flooded badly in 2008 and 2010. He said that if the issue isn't corrected, it will flood again soon. Mark Cline of Gila County Public Works replied that he had looked at the dike after our last meeting. He said that he needed an engineer to look at the dike, but that he hadn't turned it in to Steve Sanders yet. Supervisor Humphrey said that he would discuss this with Public Works.

A resident brought up the condition of Greenback Road. He stated that he had done some research and that Greenback was considered a grade 3 road per the USFS road grading scale. He said that grading the road doesn't help because there is no surfacing on the road. Supervisor Humphrey said that he agreed and that he had driven Greenback Road and taken pictures of the conditions. The resident said that the road is so bad that a cow had fallen out of his stock trailer this week. He said that the road is getting worse because of folks on UTV's driving it and that the bridge opening would only increase traffic on the road. Another resident stated that the road is the worst he has seen in the past 60 years. Mark Cline said he is trying to help, he said he sent someone to grade the road, but that he hasn't gone to see if grading it helped.

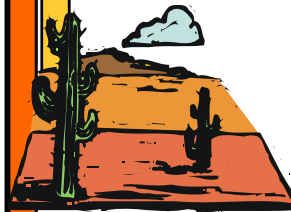
The resident said that grading hadn't helped because the material in the barrow ditches wasn't used to resurface the road. He said that a semi-truck tried and failed to make it up the road. He said he barely made it up the road himself using 4-wheel drive and has ruined 4 tires since May. Supervisor Humphrey reiterated that he would turn this over to Public Works. Supervisor said that he wasn't aware of how bad it had gotten as he and staff have been tied up with NRCS projects and dealing with the aftermath of fires and flooding. The resident said that the

agreement prior to building. Supervisor Humphrey said that to get a building permit applicants have to provide a "will serve" letter from a water company. Supervisor said that he had heard some water companies were purchasing water from Lake Mead and using that as their

guarantee. He reminded folks that we will have a water expert at our September meeting to discuss any water issues residents have. A resident asked if Supervisor knows what is happening next to the IGA.

Supervisor called Randy Plumier, Community Development Director on speaker phone and asked him. Randy said that on one of the projects the county had issued a cease-and-desist order because the owner hadn't obtained grading and drainage permits. Randy said that the owner continued the work even after being served. Randy said that he is in talks with the county attorney on how to proceed. Residents asked to be kept in the loop on what is happening. A resident stated that she lives next to the property and is very concerned that with the monsoon in full swing water from the property will drain onto her property. Another resident asked what they should do if they see the property owner violating the cease-and-desist order. Supervisor Humphrey suggested that they call and report it to the county attorney.

Jeremy Plain – USFS Jeremy let residents know that HWY 88 will reopen from the Apache Lake Marina to the Reevis Trailhead. He said the HWY 88 paving project is scheduled to start next month and will be an 18-month project. He said that USFS has removed all fire restrictions due to the recent rains. He addressed the issue of Greenback Road by letting everyone know that Greenback (FSR71) is a joint road between USFS and Gila County. USFS has a meeting with Public Works on Thursday and the road will be on the agenda. He said he is scheduling a road assessment for next week but like everyone else, staffing is an issue for his department.

A resident mentioned to Jeremy that the Tonto Basin sign coming into town had

been damaged by the recent storms. The sign is located on USFS land that the Chamber of Commerce pays to have there. She stated that several years ago the sign at the other end of town was damaged and USFS worked with ADOT to repair it. She asked if Jeremy would be able to assist with the current sign damage. Jeremy said he wasn't even aware of the agreement, but that he would look into it.

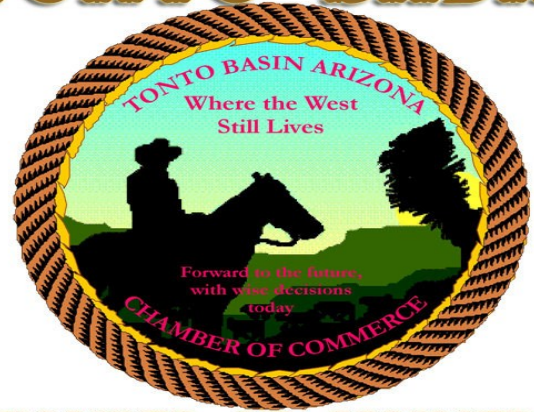
A resident asked Jeremy of the portion of HWY 88 that had washed out after the Woodbury fire would be returned from ADOT to USFS. Jeremy said that ADOT is looking into it. He said that a typical fire scar is 5 years. Since the Woodbury fire happened in 2019, there are still 2 years before ADOT will make that decision.

A resident let Jeremy know that the brush pit in town is full and asked when it would be burned. Jeremy said that USFS is on a freeze for prescribed burns. He said that the fire in New Mexico was a result of a prescribed burn getting out of control. Jeremy said that the burn ban would end on the 19th of August, and he would receive direction from his supervisor as to when he would be allowed to burn the pit.

Anthony Puscarik from Animal Control let residents know that his department has a rabies clinic planned for Tonto Basin in September or October. He said that it will be advertised in the local paper, on Facebook and that fliers will be posted in advance.

Sgt. Don Engler of the Gila County Sheriff's Department gave his monthly update. He said there had been 160 calls for service in Tonto Basin, 20 rescues performed on the lake, 6 accidents, 73 contacts, 2 warnings, 47 hours on the water, and 86 hours on watercraft items. He said that there is a lot of moss on Cholla boat ramp, and 3 trucks have gone into

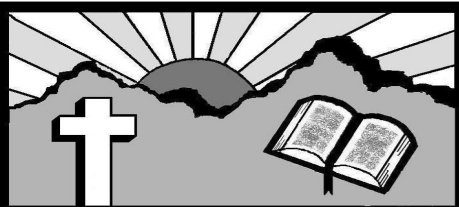

POPEYE THE SAILOR MAN

_____ is a fictional cartoon character created by Elzie Crisler Segar. The character first appeared in the daily King Features comic strip **Thimble Theatre** on January 17, 1929, and Popeye became the strip's title in later years. The character has also appeared in theatrical and television animated cartoons.

Segar's **Thimble Theatre** strip was in its 10th year when Popeye made his debut, but the one-eyed sailor quickly became the main focus of the strip, and **Thimble Theatre** became one of King Features' most popular properties during the 1930s. After Segar died in 1938, **Thimble Theatre** was continued by several writers and artists, most notably Segar's assistant **Bud Sagendorf**. The strip continues to appear in first-run installments in its Sunday edition, written and drawn by **R.K. Milholland**. The daily strips are reprints of old Sagendorf stories.

In 1933, **Max Fleischer** adapted the **Thimble Theatre** characters into a series of **Popeye the Sailor** theatrical cartoon shorts for **Paramount Pictures**. These cartoons proved to be among the most popular of the 1930s, and **Fleischer**—and later **Paramount's** own **Famous Studios**—continued production through 1957, these productions included **Allied** propaganda during the **Second World War**. These cartoon shorts are now owned by **Turner Entertainment** and distributed by its sister company **Warner Bros.**

Over the years, **Popeye** has also appeared in comic books, television cartoons, video games, hundreds of advertisements, peripheral products ranging from spinach to candy cigarettes, and the 1980 live-action

film directed by Robert Altman and starring Robin Williams as Popeye.

Charles M. Schulz said, "I think Popeye was a perfect comic strip, consistent in drawing and humor". In 2002, TV Guide ranked Popeye number 20 on its "50 Greatest Cartoon Characters of All Time" list.

Popeye's story and characterization vary depending on the medium. Originally, Popeye got "luck" from rubbing the head of the Whiffle Hen; by 1932, he was instead getting "strength" from eating spinach. Swee'Pea is Popeye's ward in the comic strips, but he is often depicted as belonging to Olive Oyl in cartoons.

There is no absolute sense of continuity in the stories, although certain plot and presentation elements remain mostly constant, including purposeful contradictions in Popeye's capabilities. Popeye seems bereft of manners and uneducated, yet he

often comes up with solutions to problems that seem insurmountable to the police or the scientific community. He has displayed Sherlock Holmes-like investigative prowess, scientific ingenuity, and successful diplomatic arguments. In the animated cartoons his pipe also proves to be highly versatile. Among other things, it has served as a cutting torch, jet engine, propeller, periscope, musical instrument, and a whistle with which he produces his trademark toot. He also eats spinach through his pipe, sometimes sucking in the can along with the contents. Since the 1970s, Popeye is seldom depicted using his pipe to smoke tobacco.

Popeye's exploits are also enhanced by a few recurring plot elements. One is the love triangle among Popeye, Olive, and Bluto, and Bluto's endless machinations to claim Olive at Popeye's expense. Another is his near-saintly perseverance in overcoming any obstacle to please Olive, who often (if temporarily) renounces Popeye for Bluto.

Thimble Theatre was cartoonist Segar's third published strip when it first appeared in the New York Journal on December 19, 1919. The paper's owner, William Randolph Hearst, also owned King Features Syndicate, which syndicated the strip. Thimble Theatre was intended as a replacement for Midget Movies by Ed Wheelan (Wheelan having recently resigned from King Features). While initially failing to attract a large audience, the strip nonetheless increasingly accumulated a modest following as the 1920s continued. At the end of its first decade, the strip resultantly appeared in over a dozen newspapers and had acquired a corresponding Sunday strip (which had debuted on January 25, 1925 within the Hearst-owned New York American paper).

Thimble Theatre's first main characters were the lanky slackerish Harold Hamgravy and his thin flapper-influenced girlfriend Olive Oyl. In its earliest days,

the strip featured the duo, alongside a rotating cast of one-shot characters, acting out various stories and scenarios in theatrical style (hence the strip's name). As its first year progressed, however, numerous elements of this premise would be relinquished (including the recurring character "Willie Wormwood", introduced as a parody of melodrama villainy), rendering the strip largely a series of comic anecdotes depicting the daily life and exploits of Hamgravy and Olive Oyl. It could be classified as a gag-a-day comic in those days. In mid-1922, Segar began to increasingly engage in lengthier (often months-long) storylines; by the end of the following year, the strip had effectively transitioned fully into a comedy-adventure style focalizing Hamgravy, Olive, and Olive's enterprising brother Castor Oyl, initially a minor character yet arguably the protagonist of the strip by 1924. Olive's parents Cole and Nana Oyl also made frequent appearances. By the late 1920s, the strip had likewise ac-

quired a number of notable characters beyond the sphere of Hamgravy and the Oyl family, including Castor Oyl's wife Cyllinda (to whom he was married from 1926 to 1928), her wealthy, misanthropic father Mr. Lotts and Castor's fighting cockerel Blizzard, all of whom had vanished or more explicitly exited the strip by the close of 1928.

Popeye first appeared in the strip on January 17, 1929, as a minor character. He was initially hired by Castor Oyl and Hamgravy to crew a ship for a voyage to Dice Island, the location of a casino owned by the crooked gambler Fadewell. Castor intended to break the bank at the casino using the unbeatable good luck conferred by stroking the hairs on the head of Bernice the Whiffle Hen. Weeks later, on the trip back, Popeye was shot many times by Jack Snork, a stooge of Fadewell's, but survived by rubbing Bernice's head. After the adventure, Popeye left the strip, but, owing to reader reaction, he was quickly brought back after an absence of only five weeks.

Ultimately, the Popeye character became so popular that he was given a larger role by the following year, and the strip was taken up by many more newspapers as a result. Initial strips presented Olive as being less than impressed with Popeye, but she eventually left Hamgravy to become Popeye's girlfriend and Hamgravy left the strip as a regular in mid-1930. Over the years, however, she has often displayed a fickle attitude towards the sailor. Castor Oyl continued to come up with get-rich-quick schemes and enlisted Popeye in his misadventures. By 1932, however, he settled down as a detective and later on bought a ranch out west. Castor's appearances have resultantly become sparser over time. As Castor faded from the strip, J. Wellington Wimpy, a soft-spoken and cowardly hamburger-loving moocher who would "gladly pay you Tuesday for a hamburger today" was introduced into the

Sunday strip, which he had evolved into a prominent fixture of by late 1932. After first appearing in the daily strip in March 1933, Wimpy became a full-time major character alongside Popeye and Olive.

In July 1933, Popeye received a foundling baby in the mail whom he adopted and named Swee'Pea. Other regular characters introduced into the strip following its retool in 1930 were George W. Geezil, an irascible cobbler who spoke in a heavily affected accent and habitually attempted to murder or wish death upon Wimpy, Rough-House, the temperamental owner of a budget diner (and resultant long-suffering foil to Wimpy), Eugene the Jeep, a yellow, vaguely doglike animal from Africa with magical powers, the Sea Hag, a terrible pirate and the last witch on Earth, Alice the Goon, a monstrous creature who entered the strip as the Sea Hag's henchwoman and continued as Swee'Pea's babysitter, the hapless, perpetually anxious King Blozo, Popeye's

lecherous, superannuated father Poopdeck Pappy and Toar, an ageless, dim-witted caveman.

Segar's strip was quite different from the theatrical cartoons that followed. The stories were more complex (often spanning months), with many characters that never appeared in the cartoons (among them King Blozo, Toar and Rough-House). Spinach usage was rare, and Bluto appeared within only one-story arc. Segar signed some of his early Popeye comic strips with a cigar, his last name being a homophone of "cigar" (pronounced SEE-gar). Comics historian Brian Walker stated: "Segar offered up a masterful blend of comedy, fantasy, satire and suspense in Thimble Theater Starring Popeye".

Thimble Theatre became one of King Features' most popular strips during the 1930s. A poll of adult comic strip readers in the April 1937 issue of Fortune maga-

zine voted Popeye their second-favorite comic strip (after Little Orphan Annie). By 1938, Thimble Theatre was running in 500 newspapers, and over 600 licensed "Popeye" products were on sale. The success of the strip meant Segar was earning \$100,000 a year at the time of his death. The strip continued after Segar's death in 1938; a series of artists performed the work. Following an eventual name change to Popeye in the 1970s, the comic remains one of the longest-running strips in syndication today.

**Toppers
Thimble Theatre had a number of topper strips on the Sunday page during its run; the main topper, Sappo, ran for 21 years, from February 28, 1926, to May 18, 1947. (Sappo was a revival of an earlier Segar daily strip called The Five-Fifteen, aka Sappo the Commuter, which ran from February 9, 1921, to February 17, 1925.) For seven weeks in 1936, Segar replaced Sappo with Pete and Pansy – For Kids Only (Sept 27 - Nov 8, 1936).**

There were also a series of topper panel strips that ran next to Sappo. Segar drew one of them, Popeye's Cartoon Club (April 8, 1934 – May 5, 1935). The rest were produced by Joe Musial and Bud Sagendorf: Wiggle Line Movie (September 11 – November 13, 1938), Wimpy's Zoo's Who (November 20, 1938 – December 1, 1940), Play-Store (December 8, 1940 – July 18, 1943), Popeye's Army and Navy (July 25 – September 12, 1943), Pinup Jeep (September 19, 1943 - April 2, 1944), and Me Life by Popeye (April 9, 1944-?).

After Segar's death in 1938, many artists were hired to draw the strip. Tom Sims, the son of a Coosa River channel-boat captain, continued writing Thimble Theatre strips and established the Popeye the Sailor spin-off. Doc Winner and Bela Zaboly, successively, handled the art-

work during Sims's run. Eventually, Ralph Stein stepped in to write the strip until the series was taken over by Bud Sagendorf in 1959.

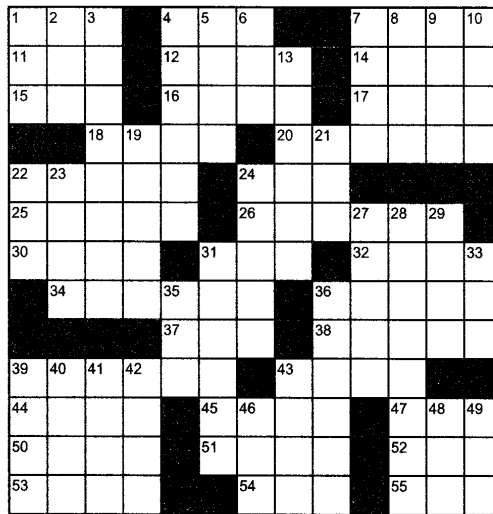
Sagendorf wrote and drew the daily strip until 1986, and continued to write and draw the Sunday strip until his death in 1994. Sagendorf, who had been Segar's assistant, made a definite effort to retain much of Segar's classic style, although his art is instantly discernible. Sagendorf continued to use many obscure characters from the Segar years, especially O. G. Wotasnozzle and King Blozo. Sagendorf's new characters, such as the Thung, also had a very Segar-like quality. What set Sagendorf apart from Segar more than anything else was his sense of pacing. Where plotlines moved very quickly with Segar, it sometimes took an entire week of Sagendorf's daily strips for the plot to be advanced even a small amount.

From 1986 to 1992, the daily strip was written and drawn by Bobby London, who, after some controversy, was fired from the strip for a story that could be taken to satirize abortion. London's strips put Popeye and his friends in updated situations, but kept the spirit of Segar's original. One classic storyline, titled "The Return of Bluto", showed the sailor battling every version of the bearded bully from the comic strip, comic books, and animated films. The Sunday edition of the comic strip was drawn by Hy Eisman, from 1994 to 2022. Following Eisman's retirement, the Sunday strip was taken over by R.K. Milholland, who had previously contributed Popeye cartoons to the web-only feature Popeye's Cartoon Club in 2019 and 2020. The daily strip has featured reruns of Sagendorf's strips since London's firing.

On January 1, 2009, 70 years since the death of his creator, Segar's comic strips (though not the various films, TV shows, theme music and other media based on

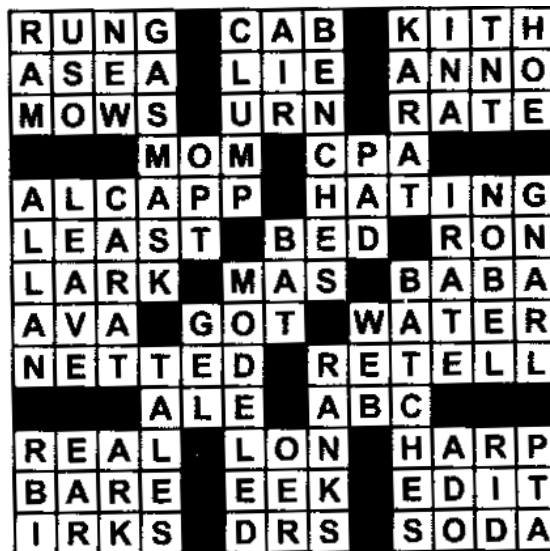

them) became public domain in most countries but remain under copyright in the US. Because Segar was an employee of King Features Syndicate when he created the Thimble Theatre strip, it is treated as a work for hire under US copyright law. Works for hire are protected for 95 years from publication or 120 years from creation, whichever is shorter. As of 2022, Thimble Theatre comic strips from 1919 through 1926 have entered the public domain, none of which feature Popeye. Even after the strips enter the public domain, trademarks regarding Popeye remain with King Features, as trademarks do not expire unless they cease to be used, and King Features has used the trademark continuously since the character's debut.

TRIVIA ANSWERS

- 1. Answer: Sticky Fingers is 11th studio album by the Rolling Stones. The original cover artwork, conceived by Andy Warhol and photographed and designed by members of his art collective, The Factory, showed a photo-**

graph of a man in tight jeans with a real, working zipper embedded on the cardboard that opened to reveal underwear fabric. The cover was expensive to produce and damaged the vinyl record, so later re-issues featured just the outer photograph of the jeans. **Sticky Fingers** is considered one of the Rolling Stones' best albums.

2. **Answer:** In 1964, The Rolling Stones recorded a jingle for Kellogg's Rice Krispies. The television commercial was recorded a year before "Satisfaction" made the band a household name. During the 26-second commercial, milk is poured into a bowl of Rice Krispies while Mick Jagger begins to sing about the cereal. Original band member Brian Jones composed the short jingle. While the band didn't write any other jingles, some of their songs were used for commercials, including "Satisfaction" for Snickers and "You Can't Always Get What You Want" for Levi's.

3. **Answer:** The Toyota War was fought between Chad and its more heavily armed northern neighbor, Libya. The 1987 war takes its name from the Toyota pickup trucks used by the Chadian forces during the final phase of the conflict. The use of Toyota Hilux and Land Cruisers proved to be a critical part of Chad's strategy and a decisive factor in the war's outcome. The Chadians did not have a conventional force, but they were provided with 400 Toyota pickup trucks armed with guided missiles to engage Libyan aircraft and tanks. This resulted in a crushing defeat for Libya.

4. **Answer:** Julius Caesar modified the Roman calendar in 46 B.C. to make each month have either 30 or 31 days, with the exception of February, which has 28 days and gains an extra day every fourth year. Four months in a year have 30 days: April, June, September, and November. There are seven months in a year having 31 days: January, March,

four, February then has one day more."

5. Answer: David Winfield is a former Major League Baseball player who is a 12-time MLB All-Star. Winfield earned a baseball scholarship to the University of Minnesota in 1969, where he played baseball and basketball for the Minnesota Golden Gophers. Following college, Winfield was drafted in three different sports. The San Diego Padres selected him as a pitcher with the fourth overall pick in the MLB draft. Winfield was also drafted by the Atlanta Hawks in the 5th round of the 1973 NBA Draft. Though he never played college football, the Minnesota Vikings selected Winfield in the 17th round of the 1973 NFL Draft. He is one of only six athletes ever to be drafted by three professional sports.

6. Answer: The White House entered a weird new place called the World Wide Web when it launched its very first website on July 29, 1994. A link labeled "The First Family" on the homepage linked to images of Bill and Hillary Clinton. You could also find useful pages such as "What's New" (since 1995, at least), "Publications," and "Tours." On the same page, President Clinton literally states, "I hope you enjoy your brief visit through those treasures. Keep in mind that you too are a part of that history. This is, after all, the very first on-line White House tour."

7. Answer: Ferrari is recalling nearly every vehicle sold since 2005 over a potential defect with its braking system. The recall states that the vehicles are equipped with inefficient brake fluid reservoir caps which may create a vacuum that could potentially leak brake fluid, leading to partial or total loss of braking capability. The recall, announced last month, affects a whopping 23,555 cars across 19 different models, in-

cluding units from model years as far back as 2005. The company estimates that only one percent of the car being recalled are affected by this issue.

8. **Answer:** Archduke Maximilian of Austria, who would later become Holy Roman Emperor Maximilian I, is believed to be the first man to propose with a diamond engagement ring. The lucky lady was Mary of Burgundy (also known as Mary the Rich). Mary reigned as the Duchess of Burgundy for five years until her death at 25 years old in 1482. To unite the households, Maximilian sent a diamond engagement ring — the first such ring in history — along with his proposal. The ring reportedly featured the letter "M" in diamonds. He didn't know it at the time, but that ring started a trend that continues to this day.

9. **Answer:** Verbs are not just limited to describing an action. While it's true that verbs typically describe action, they can also describe existence or occurrence, even when no action is occurring. Some examples of action verbs include: run, sang, jump, and throw. The word "is" in the context of today's trivia question is what is known as a "state of being" verb. State of being verbs do not express a particular action or activity; rather, they describe an existence or occurrence. In other words, a state-of-being verb identifies who or what a noun is, was, or will be.

10. **Answer:** Grace Kelly died on September 14, 1982, from injuries sustained in a car crash the previous day. Her death was reported on the front page of the debut issue of USA Today on September 15, 1982. The choice of the lead story was a controversial pick at the time. That's because two other major news events also occurred: Lebanese president-elect Bashir Gemayel was assassinated, and a plane crash in Spain killed 55 people. The papers' editors believed the public would be

Fires, flooding limit hunting access in units 7E, 11M near Flagstaff Coconino National Forest says closures to affect all hunts in 2022

The Arizona Game and Fish Department (AZGFD) advises hunters that the recent Tunnel and Pipeline fires, and subsequent burn-scar flooding, have resulted in serious safety issues that will impact public access into these areas near Flagstaff.

The Coconino National Forest has closed portions of game management units 7E and 11M to address these issues. These closures will limit hunting access for all hunts in 2022. AZGFD is working closely with the Forest to ensure hunters will have as much access into these units as safely as possible.

The U.S. Forest Service administratively closes lands for various reasons, including safety concerns. These types of closures are not necessarily limited to vehicular travel; they also may include access by foot. All hunters are urged to be safe, follow all restrictions, and plan ahead to determine areas of access for their hunts.

“All of us want to be out enjoying the Forest, but it is not worth the risk of injury or death to unlawfully be in an area that has been temporarily closed for valid safety concerns,” said Colby Walton, wildlife manager for Unit 7.

The Arizona Game and Fish Department (AZGFD) suspended fish stockings from Page Springs Hatchery in June due to a bacterial outbreak of *Lactococcus garvieae* in fish at the facility.

AZGFD does not stock diseased fish, therefore the stockings scheduled for June and July from Page Springs were replaced with fish from the Tonto Creek and Canyon Creek hatcheries.

It is important to note there will be no interruptions in stockings, and anglers will be able to continue to enjoy fishing for trout that are stocked throughout the state.

AZGFD also has been working to identify the source and extent of the outbreak, as well as treat the infected fish with medication. The fish did not respond sufficiently to treatment, however, and the department will begin to implement a multi-pronged approach to address the bacterial outbreak and future production at the

facility, including:

- **The depopulation of fish and disinfection of the Page Springs Hatchery and two ponds at Bubbling Ponds Hatchery.**
- **The use of two different vaccines (immersion and injection) at the affected hatcheries once fish are brought back on station. The vaccines have shown recent success at controlling *Lactococcus* outbreaks at a private hatchery in California.**
- **The use of trout from other department hatcheries and contracts with external vendors to provide catchable rainbow trout in waters that are typically stocked with fish from Page Springs until the hatchery is back in full production.**

Both facilities will be closed to the public during the depopulation and disinfection processes. Page Springs will be closed Aug. 15 through Oct. 17. Bubbling Ponds will be closed Aug. 15 through Aug. 29.

Lactococcus garvieae is a naturally occurring bacteria that has been reported in freshwater and saltwater aquaculture facilities, as well as cattle and poultry farms around the world. The detection of Lactococcus at Page Springs in June was the first known occurrence of the bacteria in Arizona. Similar outbreaks have occurred since 2020 at several hatcheries in California.

The fish-to-human transmission of this bacterium is rare and extremely unlikely. As always, anglers should follow the U.S. Food and Drug Administration and U.S. Department of Agriculture recommendations to cook fish to an internal temperature of 145°F. When a food thermometer is not available or appropriate, cook fish until it's opaque (milky white) and flakes with a fork.

Page Springs and Bubbling Ponds hatcheries are located near Cornville, Ariz., about 100 miles north of Phoenix.

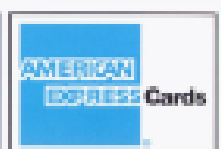
