Important Information for All Exhibitors and Traders

Vehicle Passes:

Each vehicle pass permits entry for one vehicle with up to four occupants.

Staff arriving on foot must have staff passes—a vehicle pass cannot be used for pedestrian entry.

Site Rules and Regulations :

(Applicable to Everyone on Site at All Times)

No admission after 10:00 AM each day.

For health and safety reasons, no vehicle movement is allowed between 10:00 AM and 5:00 PM during the show.

Insurance Requirements:

I confirm that my exhibit will be covered by at least a £2 million public liability insurance for the duration of the rally and, where required, it will also have the necessary insurance – tests and certificates.

Speed Limit:

The Road Traffic Act applies on site. A 5 mph speed limit will be strictly enforced.

Driving Rules:

No unlicensed or underage driving is permitted anywhere on the grounds.

Fire Safety:

All traders must take appropriate fire precautions within their allocated area, including any tent, marquee, or other temporary structure they have erected or installed.

All traders are required to have a suitable fire extinguisher available.

Dogs:

Dogs must not be allowed to run free or foul the show field.

Entry Requirements: NO PASS, NO ENTRY.
Vehicle passes must be clearly displayed in the windscreen at all times.
