Governmental Issues and Responses Re Covid-19

On September 15, 2020, a Federal Judge in Pittsburgh Ruled that Certain of Governor Wolf's Pandemic Orders Were Unconstitutional, as Impinging on Fundamental Individual Liberties; A Stay Request and an Appeal are Planned:

The case was brought by Butler, Fayette, Greene, and Washington Counties. They challenged the Governor's stay at home order, closure of non-life-sustaining businesses, and indoor and outdoor gathering limits, designed to stem the spread of the coronavirus. The Judge, appointed in 2019, found that the order impinged on fundamental constitutional liberties. The ruling does not impact other Orders, including the mandatory mask order. The ruling comes as states are girding for a potential resurgence of the virus in the fall, just as the flu season also begins. A previous ruling by Federal Judge Surrick (of Philadelphia) upheld many parts of Governor Wolf's orders, as did the PA Supreme Court in July (regarding Governor Wolf's emergency declaration). An appeal of the latest decision is expected.

<u>Philadelphia's City Solicitor Has Advised that the City's Limits for Indoor and Outdoor Gatherings Are Not Affected by the Federal Court Ruling Against the State's Limits on Gatherings</u>.

A Bipartisan Coalition in the House, Dubbed the "Problem Solvers Caucus", Has Proposed a \$1.5 Trillion Coronavirus Stimulus Package: The caucus includes 50 House members equally divided between Republicans and Democrats, who seek to foster bi-partisan cooperation on key policy issues. Included is a second round of stimulus checks, supplemental unemployment benefits, state and local funding, aid for small businesses and schools, and election funding, and other provisions.

<u>The U.S. Senate May Balk at Anything Beyond its Recently Proposed "Skinny"</u> **\$500 Billion Package**, that has no state and local government funding or a second round of stimulus checks.

The Speaker of the U.S. House of Representatives Has Announced that the House Will Stay in Session Until a Stimulus Aid Package is Passed.

<u>Unemployed Workers in PA Began Receiving an Additional \$300 a Week in</u>

<u>Supplemental Unemployment Benefits Retroactive to August 1, 2020 Under the</u>

<u>Lost Wages Assistance Program ("LWA") on Sunday September 14:</u> Applications opened Sunday September 13. Applicants must log into www.uc.pa.gov/cert as if they were filing a biweekly claim, then select "Complete LWA certification". To qualify, applicants must already be receiving \$100 a week from an existing unemployment program. LWA payments will be made retroactively for August 1, 8, 15, 22 and 29. The funds are Federal FEMA Disaster Relief moneys, diverted by Executive Order, and will provide 6 weeks+/- of supplemental unemployment.

Governor Wolf Has Announced that PA Restaurants (But Not in Philadelphia, Which Has its Own Rules) Can Increase Indoor Dining Capacity to 50% of Capacity Starting on September 21; Alcohol Sales Must Stop at 11:00 PM and Can Only Be Served With Food: Restaurants must commit to observing safety precautions through completing a self-certification process. Ongoing enforcement will begin October 5. A list of self-certifying restaurants will be published on a state website. New Jersey Approved Indoor Dining at 25% Capacity, Starting on September 4.

Starting September 14, Philadelphia Allowed Outdoor Gatherings of up to 150 People (the Prior Limit was 50); The Limit on Indoor Gatherings Remains at 25.

The PA Department of Health Has Updated Its Nursing Home Guidelines To
Allow for Visitors "In Limited Situations": Visitors may include friends, family and volunteers if they are deemed to be "important caregivers" and they can play an important role in the resident's physical, mental and emotional wellbeing.

For Information About Which States Are Currently Included in Pennsylvania's Self-Quarantine List, click here. Those coming into PA from any of the States on the list (including returning PA residents) must self-quarantine for 14 days upon arrival. The list changes frequently as new states are added, and others removed.

<u>Philadelphia Has Allowed Movie Theaters to Open, At Strict Capacity Limits</u>: Multiscreen theaters are limited to a total of 250 people, with individual screen showings limited to 25 people. No food is allowed.

With Congress Deadlocked on Aid to State and Local Governments, Many States (Including PA and New Jersey) are Looking at Significantly Reduced Budgets
With Major Cuts in Services: The bipartisan National Governors Association and Moody's Analytics have cited the need for \$500 billion in Federal aid to states and local governments to avoid major damage to the economy.

New Jersey Has Responded to the Budget Crisis By, Among Other Steps, Raising Tolls on Two Major Roadways (the New Jersey Turnpike and Garden State Parkway) By 36% and 27% Respectively: Tolls will also go up on the Atlantic City Expressway, and gas taxes go up by 9 cents a gallon, to maintain the State's transportation trust fund. Gasoline consumption dropped significantly this year.

A Seriously Inaccurate Census Count Could Result From an Early Closing of the Counting on September 30, as Ordered by the Administration; A Federal Judge Had Enjoined the Early Census Shut Down Until a Hearing Can be Held, Now Postponed Until September 22 After Officials Failed to Produce the Required Documents: Be sure to fill out your census form now if you have not already done so. The census count is extremely important, including for the establishment of voting districts, State representation in Congress, and trillions of dollars of federal funding, among other issues. The 2020 count will shape America for the next decade!

The Administration's Payroll Tax Deferral Program Began September 1:

Employees Are Still Liable to Pay the Tax by April 30, 2021, and Employers Must

Start Withholding Double Taxes in the First Four Months of 2021; Employees

May Want to Opt-Out: The current deferral isn't mandatory. If you don't want a double deduction in 2021, tell your employer you want to opt out now. If you think you have received a raise, it may just have been the payroll tax deferral!

<u>The Centers for Disease Control and Prevention ("CDC"), a Division of the Department of Health and Human Services ("HHS"), Has Issued a Nationwide Moratorium on Residential Evictions, Based on Coronavirus Concerns:</u> The CDC's September 1, 2020 ban is effective through December 31, 2020. It is not clear whether the CDC had the authority to issue the order. Some exceptions apply.

A Philadelphia Judge Has Ordered a Ban on Residential Evictions Until

<u>September 23:</u> The order also limits the number of eviction notices that the City's landlord tenant officer can serve until September 21, and he/she must serve notices explaining the new Federal moratorium on eviction for nonpayment of rent, and provide a form to be used to apply for federal protection. Click <u>here</u> for the form. *The City's Landlord-tenant Court reopened after Labor Day.*

<u>Philadelphia Criminal Courts Began Holding Jury Trials Again on September 9,</u>

<u>With Strict Controls in Place; Civil Jury Trials Have Been Postponed Until January</u>

<u>2021</u>: The number of jurors called to report for criminal trial jury duty is being limited. Jurors will be in a separate room from the Courtroom, with a plexiglass

divider. They will watch the trial through Zoom and masks are required. The number of people in elevators is being limited. Hand sanitizers have been installed throughout, including in Courtrooms and elevators.

Philadelphia District Attorney Krasner Filed a Petition to the PA Supreme Court To Block the You Tube Real Time Broadcasting of Philadelphia Criminal Trials, to Avoid Witness and Defendant Intimidation; the PA Supreme Court Granted the Petition on September 17th: Oddly, when Philadelphia criminal jury trials resumed, with jurors in one room and the proceedings in another, the virtual format selected was online real time broadcasting on You Tube. The DA petitioned the Supreme Court to halt this form of proceedings, arguing that those viewing the broadcasts could record them, redistribute them over social media, and use them to intimidate witnesses and defendants. (It is for this reason, among others, that cell phones and other electronic devices are prohibited in courtrooms). The DA presented other alternatives including closed circuit tv, or private Zoom proceedings. On September 17, the PA Supreme Court granted the petition. It is not clear what alternative virtual format will now be used.

<u>Philadelphia Will Put Off Reassessing Properties in 2021 (For the 2022 Tax year)</u>
<u>Because of the Pandemic</u>: That means that if tax rates stay the same, there will be no increase in real estate taxes at least until 2023.

PA Will Start Offering REAL IDs at Its Recently Reopened Drivers' License Centers, But the Enforcement Date Has Been Moved to October 1, 2021.

The Philadelphia Parking Authority is Seeking to Advance Its New "Park, Eat, Love" Campaign, to Promote Indoor Dining, in a Poster Design Contest:

Voting in the November Election: Good News on Several Fronts!

On September 17, the PA Supreme Court Ruled That Mail-In Ballots Are Eligible
To be Counted if Postmarked by Election Day and Received within 3 Days After
The Election; It Authorized the Use of Drop Boxes and Satellite Election Offices:
It is not clear if the PA legislature will try to undo the Court's decisions on mail-in ballots. A vote on more restrictive PA Senate legislation is expected on September 21. Governor Wolf vows to veto any legislation that restricts mail-in voting. He has also been urging the legislature to allow processing of the ballots starting
21 days before the election (opening the envelopes and removing and scanning the ballots, checking voter eligibility, etc.). The Supreme Court ruling also removed a Green Party candidate from the PA ballot.

Former PA Governor Tom Ridge (R) Has Urged the PA Legislature to Allow Election Officials to Start Preparing Mail-in Ballots for Counting Well Before the Polls Close.

The PA Department of State Has Directed Counties Not To Discard Mail-In

Ballots Solely Because an Election Official Did Not Think the Signature Matched

That of the Voter, and to Give Voters A Chance to Correct The Issue: The State

now has a uniform process for verifying signatures on Mail-In Ballots.

A Federal Judge in Washington State Grated an Injunction Sought By 14 States to Temporarily Block Operational Changes at The Post Office That Have Slowed Mail Delivery: The Judge found that the changes were a politically motivated attack on the efficiency of the Postal Service that could disrupt the 2020 election. The States sought and were granted an injunction to require the Postal Service to end the "leave behind" policy where mail trucks go out on delivery routes before loading all of the mail, treat mail in ballots as 1st Class Mail, and restore/retain the high speed sorting machines required for 1st Class Mail processing, that have previously been removed or are slated to be removed.

More Poll Workers are Being Sought for the 700-800 Polling Places That Philadelphia Proposes to Open for the November Election; Sign Up Now! The

pay is \$250 including \$50 for a mandatory training session. Given the confusion engendered by the possibility that the State Legislature could enact new restrictive rules, Philadelphia must be prepared for more in-person voting. Many poll workers have traditionally been older individuals who could be more susceptible to the virus. As a result, Philadelphia is looking for new, and in many cases, younger volunteers. <u>Stay Tuned for The Ultimate Decision on the PA Election Laws that Will Govern</u> <u>the Conduct of PA's November 3 Election.</u>

<u>The Centers for Disease Control and Prevention (CDC) has recommended mail-in</u> ballots as a way to vote without risking exposure to the virus at the polls.

Other:

The PA Public Utility Commission Has Prohibited Non-Payment Utility Shutoff for Utilities Governed by the PUC Until Further Notice. A decision had been delayed multiple times into the next hearing, but the Commission decided on September 17 to disallow non-payment utility shutoff resumption until further notice (it could technically be brought up again at any Commission meeting, but is reportedly not expected to be heard until April 2021 at the earliest).

The City is Closing Multiple Streets Near the Sports Complex in South

Some Recent Polls Have Shown That More Americans Are Reluctant to Get the Coronavirus Vaccine, When Released, Citing Fears that a Vaccine Rushed Out for Political Reasons May Not Be Safe or Effective:

The Head of the Centers For Disease Control and Prevention ("CDC") Has Now Advised that a Vaccine Will Not Be Generally Available to the Public Until Late in the 2nd Quarter or the 3rd Quarter of 2021: He also stated that "masks are the most important health tool we have", and may offer more protection than a vaccine. The CDC had earlier advised states to get ready to distribute a vaccine in October and November 2020.

Good News: Wearing A Mask Will Also Help Protect Against Transmission of the Flu, as We head into the Fall-Winter Flu Season with the Pandemic Still with Us.

There Are Three Categories of Coronavirus Tests Available; What Do they Do? It is reported that there are 3 broad categories of coronavirus tests used in the U.S. 1) Genetic tests, mostly done by nasal swab, but some by saliva tests, look for the virus DNA and are said to be the most accurate. The tests typically take hours to come back. 2) Antigen tests look for protein on the surface of the virus and while not as effective are cheaper, faster and require less specialized lab equipment. They require a nasal swab. A recently approved Abbot Labs antigen test can get results in 15 minutes. 3) Antibody tests look for proteins that show whether a person has had and fought off the virus. It is not clear if infected people develop antibodies. These tests are typically used to measure what percentage of the population has been infected.

<u>THE EPA Has Approved Nearly 500 Household Products That Kill the Virus:</u> Some are faster- acting than others, taking from 1 to 10 minutes to be effective. For the complete list, click <u>here</u>.

On September 10, Philadelphia City Council Voted to Require Employers to Provide 2 Weeks of Paid Sick Leave, Through December 31, 2020, For Employees Not Covered by Federal Sick Leave Legislation, Including Gig Workers. The Mayor has said he will sign the bill.

<u>Community College Students Are Working as Contact Tracers; the City is at Now at 75% Effectiveness in Tracing:</u> The City reached out to Community College to recruit tracers and 7 were given jobs. The City sought individuals from all zip codes and those who speak other languages. As of last week, the City has been able to trace 75% of the contacts identified by infected patients.

<u>Nybe Urgent Care, with a Facility at 1500 Spring Garden St., is Now Offering a Rapid Nasal Swab Test by Appointment, With Results in 15 Minutes, For Asymptomatic Patients</u>: The 15 minute results are extremely helpful for those who need quick clearance for work, school, travel, or access to medical or other care. The test is currently not covered by insurance, although that may change, and costs \$75. For an appointment call 267-728-4033.

The Parkway, Rodin Museum, Azalea Garden and Ridge Ave. Encampments
Were to be Disbanded At 9 AM Wednesday September 9, Per a City Order, But
the City's Deadline Came and Went With No Action Taken: Neighbors are
becoming increasingly frustrated with this ongoing 3-month-old situation that
poses significant health and safety problems for both the occupants and the
community. The City says it is working on permanent housing initiatives for the
occupants, but more individuals keep joining the encampments. The Mayor
announced that an agreement had been reached for nonprofits to acquire 300
vacant City properties for housing. He declined a brunch invitation with the
occupants and has stated that it is hard to negotiate a resolution because there is
no clear leader. The City has already housed 130 individuals.

Children): With the coronavirus pandemic still very much with us, and flu season approaching, doctors are strongly urging that everyone (including children) get a flu shot. This will help lessen the number of flu cases and avoid the hospitals filling up with flu patients, when their capacity is already stretched thin with the pandemic. Also, the flu and the coronavirus share many symptoms, and it can be hard to tell them apart. Coronavirus patients need to be isolated. There is a treatment for the flu, but not yet for the virus. Some providers including drug stores have the flu vaccine now. Follow the advice of your medical provider on your flu shot. *If you are over 65, and you get the shot at a drug store, be sure to ask for the shot for that age group.*
