- Must have placed top 5 in a competitive event and be registered for that event at ILC.
- Must submit a copy of chapter's ILC registration, showing that the student is registered for ILC.
- The advisor must submit a letter of recommendation testifying to the student's benefit from this scholarship.
- The student must submit a student essay discussing why the student deserves the scholarship (for example: accomplishments in HOSA, preparation for competitive events, SLC experience, community service) AND how the student will benefit from attending ILC. (Must be 500 words or less)
- The student must submit a current resume.
- All scholarship materials must be complete and typed or written legibly, with correct grammar.
- All scholarship materials must be entirely written by the person submitting the application. Submissions containing AI-generated content will not be accepted.
- All typed formatting must be Times New Roman, 12-point font, double-spaced, with black text on a white background, and 1 page front-back.
- There may be at most 3 applicants per chapter. If a chapter submits more than the allotted amount, the entire chapter will be disqualified.
- Recipients must attend ILC, compete in his/her event, and complete any and all other tasks that may be assigned by KY HOSA.

Application Contract

The Scholarship allows you to cover any expenses in accordance to or related to attendance of the HOSA International Leadership Conference (in the year of award) up to the amount of five-hundred (500) dollars. The scholarship will be for a State Level competitor, who placed first - fifth in their respective competitive event or will serve as a voting delegate (not currently serving as a state officer) and is registered as a member of Kentucky HOSA.

These Terms of Application certify that you are the following:

- An active and registered member of Kentucky HOSA
- A participant of an **official event** at the Kentucky HOSA State Leadership Conference and registered for an **official event or voting delegate duty** at HOSA ILC.

These Terms of Application Agreement also certifies that:

- Each chapter is limited to three (3) applicants. In the event that a chapter submits more than three (3) applications. All submitted applicants will be discarded from consideration.
- The amounts and number of scholarships awarded will depend on the funds available for scholarships within Kentucky HOSA's budget.

These Terms of Application Agreement also certifies that:

- KY HOSA will award scholarships to the recipients' chapters upon fulfillment of requirements/criteria specified by application contract. This will be a reimbursement for funds already paid by the student/chapter. The chapters will then be responsible for reimbursing the recipients according to arrangements between the recipient and the chapter.
- In the event that the recipient fails to attend ILC, is listed as a no show list for his/her event, or otherwise fails to fulfill his/her duties at ILC as decided by the Kentucky HOSA Executive Council and/or any committees thereunder, the scholarship funds will be not be awarded.
- In case of extenuating circumstances, a student who has not met the requirements may submit a written appeal to the scholarship committee (kyhosa@education.gov) for review. All decisions will be final.
