1. Introduction

The right of American Citizen to cast a secret ballot is held in high regard, and is even codified in state and federal statute. Organized crime, bribery, power, tumult, or other improper practice must be eliminated as a possibility in U.S. elections to guarantee a voter's right to cast a ballot in secret and free of intimidation.

2. Issues and Solutions Related to Ballot Secrecy

• Ballot Secrecy:

- o **Issue**: Ensuring an auditable paper trail as mandated by the Help America Vote Act while offering the guarantee of best protection and anonymity for each voter's ballot.
 - Case Law outlines that AUDITABILITY comes BEFORE BALLOT SECRECY
 - Ballot Secrecy cannot be used to cover up fraud.
 - Voting By Precinct allows the best of both Ballot Secrecy and an Auditable Paper Trail.
- Solution: Implement in-precinct voting only, eliminating countywide voting/vote centers to preserve auditability and ballot secrecy by keeping all ballots of a given voting precinct together. This eliminates the need for reconciliation of voter's ballots by precinct from polling locations, reduces time and cost of recounts and audits and removes the need to redact what are supposed to be anonymous ballots. These practices adhere to state and federal laws relating to BALLOT SECRECY, AUDITABLE PAPER TRAILS, and ACCESS TO PUBLIC RECORDS.

3. Project Specifics

Project Scope	Throughout the 2024 Election Cycle and into the next Congressional Session and in Target Swing State's Next Legislative Sessions. Offering numerous methods of voter education on these topics, highlighting the aim to protect and secure the Vote in November via Mailers, Social Media, Canvassing Teams with Talking Points and Literature for the Organization, Speaking Engagements at Local Area Clubs. Social Media Boosting Campaigns, Meetings with Local, State and Federal Leaders to ensure precinct-level auditability is strengthened.
Project Constraints	Voter Information: Media will slander this as Voter Suppression without evidence. We have numbers to show voter turnout has dropped since Vote Centers were implimented in Texas. Short Period of Time: Mere weeks to secure precinct level auditability at the county level. This is already state law, we are simply guiding them back to following the statutes as opposed to Secretary of State Guidance.
Deliverables	 State Legislation mandating the use of voting precincts, allowing counties to organize and cast ballots by precinct as best they can to ensure BALLOT SECRECY, AUDITABILITY, and ACCESS TO PUBLIC RECORDS. Federal Legislation mandating the use of voting precincts for full auditability. State Legislation BINDING the Secretary of State to the Will of A DULY ELECTED LEGISLATURE. Federal Statute BINDING the EAC to the Will of A DULY ELECTED LEGISLATURE. A number of Key Counties in Swing States voting by precinct prior to November 2024
Explorations & Decisions	Surgical intervention in the most vulnerable areas was necessary to determine the best direction to advance with the project. Key counties in swing states must be the focus and prevention is key. Top preventative deterrant is the factor of granular auditability. This means being able to audit down to the smallest subdivision outlined by the legislature and local government, the VOTING PRECINCT. We have a federal lawsuit designed to sue the Secretaries of State for facilitating the issues found with countywide voting which cannot be

rectified for elections past, and for the continued cover-up of the
issue related to ballot secrecy in counties who report by precinct
while voting countywide.

Project Scope:

- o Coverage throughout the 2024 Election Cycle and into the next Congressional Session.
- o Focus on key legislative sessions in swing states.
- Offer diverse voter education methods emphasizing the importance of ballot secrecy and auditability.
