The practice also covers strategic alliances, collaborations, technology transfers, licensing, market entry, FDI regulations, stamp duty implications, payment of royalty and cross-border investments and technical support & services. The practice covers the following:

- **A.** Advisory: assistance in structuring of a transaction, assessing the nature & feasibility of any transaction, enforceability of transactional documentation, creating step-by-step checklists, conducting sessions for overall understanding of the legal & regulatory roadmap of the transaction for all internal departments to prepare for the transaction, understanding the aspects related to employee transfer or data protection or cyber security during the transaction, on the corporate governance status of the entity & keeping house in order to prepare for a transaction, understanding the registration related aspects of transactional documents, and stamp duty thereof.
