2025 POOL CLOSING AGREEMENT

Pool Closing Includes:

- Lowering the pool water to the appropriate level for your unique pool.
- Draining water from the pool filter, pump, heater, blower, turbo cell, pressure cleaner, booster pump, and pool pad plumbing.
- Inspecting and pressure washing turbo cell chlorinator if necessary.
- Backwashing of sand or DE filters.
- Inspecting filter cartridges and pressure cleaning if necessary (additional charge).
- Draining water from special features including waterfalls, deck jets, and slides.
- Clearing pool and spa suction and return lines.
- Installing winter plugs into the pool/spa returns.
- Installing Gizmos into your skimmers.
- Adding antifreeze appropriate to your pool/spa.
- Removing and storing pool ladders and railings.
- Turning off all the breakers associated with your pool/spa.

Prior to Closing Your Pool:

- Pool water chemistry should be balanced prior to your specified closing date.
- **The owner** ensures that the pool will be **clear and free** of major debris prior to the closing date and that the pool cover, along with any winterization items, will be readily available.
- Outdoor water faucets and electrical outlets must be operational.

Pool-Spa Closing Pricing:

- Inground Pool up to **7,500 Gallons = Mesh cover \$325.00 Solid cover \$350**
- Inground Pool Greater Than **7,500 = Mesh cover \$425.00 Solid cover \$450**
- Inground Spa, Not connected to the pool with its own pump & filter = **\$150.00**
- Inground Spa, Connected to a pool via spillover & sharing pool pump & filter = **\$75.00**
- **Winterizing chemicals will be an additional charge based on the pool size.**

Additional Closing Services That Might Be Necessary:

- **Turbo Cell Heavy Scaling:** Cleaning with a muriatic acid bath if needed. \$ 69.00
- **Multiple Filter Cartridge - Pressure washing (Up to 4)** \$ 89.00
- **Single Filter Cartridge - Pressure washing.** \$ 59.00
