### **2023 SHOW CHANGES:**

GOOD NEWS...town of Prescott Valley has changed "special-event permit" requirements. The special-event permit has changed to a single-permit purchased by CCG promoter on behalf of all vendors. Thus, means CCG Vendors no longer are expected to purchase a special-event permit for the CCG event. **\*TPT sales tax license is required.**

**\*Any Person/Business participating at the CCG show MUST obtain and/or renew an AZ Transaction Privilege Tax (TPT) license. Purchase of TPT license & reporting sales tax to AZ Dept. of Revenue is an Arizona state law. Vendors can access TPT information by visiting ARIZONA DEPT.
