***CPT Code 90785 for Interactive Complexity refers to factors that complicate the delivery of a mental health procedure. For example: use of clay in expressive arts therapy or dolls in play therapy interventions; difficult communication with acrimonious family members; engagement of verbally undeveloped children. Typically found with patients who: have others legally responsible for their care such as minors or adults with guardians; request others such as family members or interpreters to be involved during the visit; or require the involvement of third parties such as schools or probation officers. 90785 may be added to: psychiatric diagnostic evaluation (90791), individual psychotherapy (90832, 90834, 90837) and group psychotherapy (90853).
