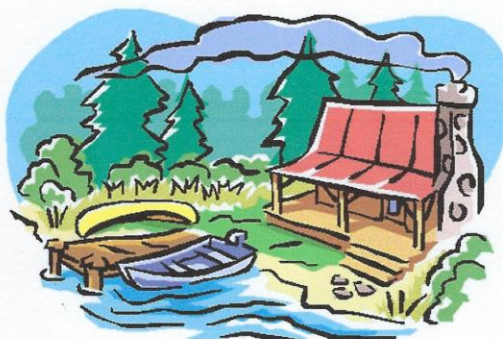

From the Treasurer

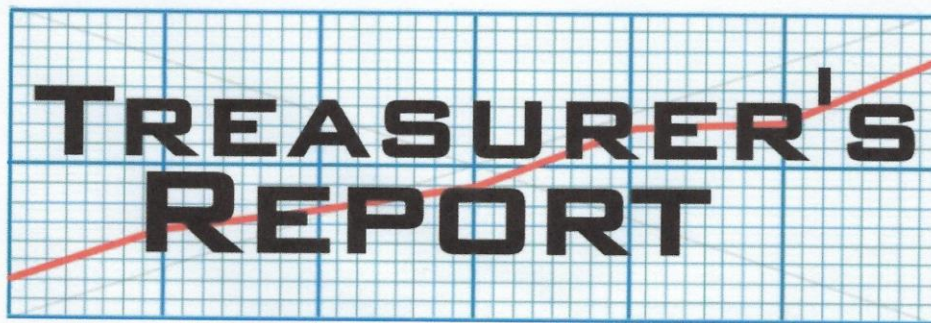

Net Income for the current budget year is \$4,593.06.

Treasurer recommends that the yearly dues remain unchanged at \$205. Based on the annual CPI at 8.5%, the joining fee for the fiscal year ending 7/31/23 is \$350, a \$30 increase over the previous year.

Current balances in our various savings, CDs and checking accounts, as of 4/16/2023 are:

- Checking, \$5,196.77;
- Investor, \$40,239.99;
- CDs, \$32,778.65 (rate 0.7%), \$55,243.22 (rate 3.5%), \$90,959.64 (rate 3%).

10/30/22

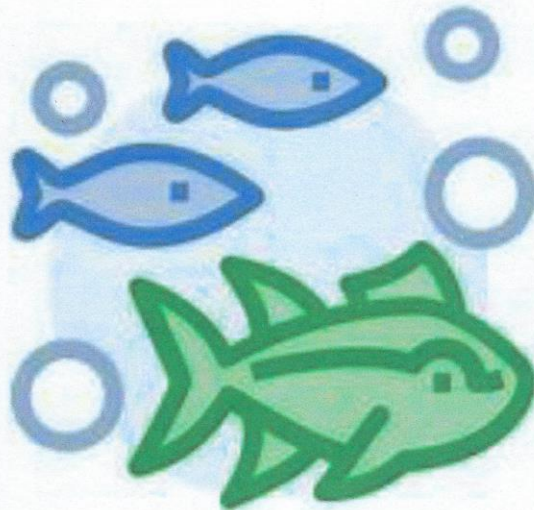
- Approval of the tree removal estimate of \$2000 from Heath Crum,
