

42nd New England Public Works Expo to be held September 15th and 16th



The 2021 New England Public Works Expo is scheduled to be held on September 15th and 16th at the Boxboro Regency Hotel and Conference Center in Boxborough, MA, conveniently located off Route 495.

Massachusetts Municipal Association (MMA) Legislative Update

In the wee hours of the morning on Wednesday, January 6, with only hours remaining in their extended legislative session, the Massachusetts State Legislature voted to pass a \$16.5 billion transportation bond bill (H.5248). With Governor Baker's signature added on January 15, the major transportation funding and policy bill became law (Chapter 383 of the Acts of 2020).

The final version of the transportation bond bill was the result of several iterations that moved between the House and the Senate and to the Governor's desk. Governor Baker ultimately signed most of the transportation spending provisions but vetoed several high-profile policy initiatives in the bill.

The law includes funding for a number of municipal grant programs to be administered by the Massachusetts Department of Transportation:

- \$100 million for a new Municipal Pavement Partnership Program
- \$100 million to be used in part for work on state-numbered, locally owned roads
- \$70 million for the [Municipal Small Bridge Program](#)
- \$50 million for the [Complete Streets program](#)
- \$25 million for a new Local Bottleneck Reduction Program

Although the Legislature authorized borrowing for the above-mentioned renewed and new programs, they still have to be funded by the Commonwealth. The MMA is working with MassDOT to provide input on the frameworks of the new programs in advance of their being funded and formulated.

On the policy side, Governor Baker vetoed a fee increase for app-based ride-hailing services; a requirement that the MBTA implement a low-income fare option and that the state's 15 regional transit authorities study means-tested fare programs for possible future adoption; and a mandate to direct all proceeds from the in-progress regional Transportation and Climate Initiative to the Commonwealth Transportation fund.

On March 9, the MMA testified at the first virtual hearing for the fiscal year 2022 Chapter 90 bond authorization. Franklin Public Works Director Brutus Cantoreggi and Gloucester Public Works Director Michael Hale, both of whom are MHA board members, also [provided testimony](#) in support of increasing Chapter 90 funding to at least \$300 million per year and passing a multi-year authorization. They also spoke to the particular challenges communities have faced due to the COVID-19 pandemic that have caused backlogs in road repair work and additional wear and tear on local roads.

In recent years, the state has added several targeted, competitive road funding opportunities for municipalities, such as the Complete Streets and Small Bridges grant programs. But the MMA argued in our testimony that "there is no substitute for the core Chapter 90 program," which is "the only non-competitive program that maintains local control over how to spend the dollars on local road projects" and the only one that benefits all 351 cities and towns.

Flat funding the Chapter 90 authorization at \$200 million per year since at least 2012 has eroded the purchasing power of the local road funding dollars. And according to the MMA's biennial survey of all 351 municipalities, the \$200 million figure meets only about one third of reported annual need to maintain local roads in a state of good repair.

The MMA also emphasized the importance of finalizing the fiscal 2022 Chapter 90 authorization (H. 57) as quickly as possible so that cities and towns can access their allotment and begin the spring construction season on time.

The MMA filed a standalone Chapter 90 bill, sponsored by Sen. Adam Hinds of the Berkshires, that would fund the Chapter 90 program at \$300 million per year for two years. The bill (SD. 2456) has not yet been assigned a bill number or hearing date.

Who's Going to Fill Your Shoes?

With an aging workforce and a pipeline full of projects, the age-old question of "How are we going to attract the next generation of worker to our industry?" continually comes up.

The Massachusetts Pre-Apprenticeship and Vocational School Training Program was established by the Massachusetts Department of Transportation in an effort to address this issue. The one-week long program is offered at no cost to vocational schools across the Commonwealth with instructors provided by the New England Laborers Training Trust Fund with support from industry, the UMass Transportation Center and numerous Departments of Public Works.

Upon completion of the program, the outstanding students are offered the opportunity to apply for a paid co-op with a Department of Public Works. The students' wages are paid by the municipality and are reimbursed at the end of the co-op by the program. Students work during their shop week instead of going to school. When asked about what he did, one student replied "I do what they do. I patch potholes, fix catch basins, pick up brush, and put up signs."

Co-ops have taken place in Becket, Berlin, Wellesley, New Bedford, Fall River, Norton, Canton, Wilbraham, West Springfield, and Westfield to name a few. Students have gone to work at the Berlin, Ashland, and Springfield DPWs, been accepted at trade unions, and gone to work with private companies after completing the co-ops.

Program graduates have also received scholarships for CDL Class B and Hoisting License training through the UMass Transportation Center OJT/SS program.

Two Legislative Items Impacting Public Works

1. The IG has recommended pending legislation that would end the 30B exemption for snow plowing. It would require a competitive low bid process for snow plowing, that I personally believe will be disastrous for snow removal operations. Towns rely on many small contractors in order to meet their needs and a low bid process would be highly problematic to procure and administer. Additionally, we find that the type of winter influences the number of contractors interested in snow operations. <https://malegislature.gov/Bills/192/H7>
2. Prior to 2017, hauling had been interpreted by prior IGs as being included in the snow plowing exemption. This exemption expanded to snow removal, allowing us to hire snow shoveling contractors in the same fashion we hire snow plowing contractors. <https://malegislature.gov/Bills/192/HD2719>

I strongly suggest that you reach out to your local Representatives to let them know how these bills would further hurt snow removal operations.

Safety Corner

Lowest Bidder, Safest Value?

As the country continues to stretch its legs and get back to work, projects all over are starting up again. With springtime comes new road work, revitalization and looking ahead to a new budget year which brings funds for more projects. To complete these projects, highway departments may use their own crews, or subcontractors, or a combination of both. With budgets in mind and with spending most often on a close watch, subcontractors who can get the job done for the least amount of money may have more of a chance to win the bid. But what other factors should the process of hiring subcontractors include?

Safety considerations should be heavily weighted, if not equally weighted, as cost when choosing a subcontractor. Additionally, being aware of any subs of the subcontractor is also necessary. Hiring a subcontractor who has an unsafe track record can leave a town open for potential risk of injury to citizens, employees, or property. There are some questions that can be asked of subcontractors before awarding projects to them which can assist with the safest decision: federal safety inspection records, workers compensation ratings, and equipment/ employee safety documentation to highlight a few of these points.

One of the easiest ways to follow up if a subcontractor has been inspected or found in violation of safety regulations is through the Occupational Safety and Health Administrations (OSHA) website (<https://www.osha.gov/pls/imis/establishment.html>). Because subcontractors are considered in the private sector regardless of working for a municipality, they fall under OSHA's jurisdiction. Therefore, any inspections and subsequent citations will be listed in this search function. A few minutes of due diligence on this website can reveal one aspect of safety compliance of a subcontractor, although certain safety violations may not be determined to render a subcontractor ineligible for the project. It is a starting point to open the conversation of past audits or citations, and the subcontractor can be asked to produce safety remediation and follow up for past safety infractions. In other words—was the violation something that they learned from and improved on in that area.

Another way to follow up on subcontractor safety is to request workers compensation modification (“mod”) rating. This number may lend to indicating if a subcontractor is higher risk. If the workers compensation

company rates them higher, this may be due to multiple recent injuries, or possibly some larger compensation cases. Some companies hiring subcontractors require mod ratings to be less than 1, or less than the industry standard. One potential concern with setting an exact range for this type of parameters, however, is that one large surgery comp case or serious injury comp case can increase that mod rating for a few years. This number is not always representative of how safe a company is, rather the number of types of injuries their employees have sustained. Yet, using the mod rating as a way to continue the conversation and discuss the injuries would be beneficial for understanding the subcontractor's employee injury record.

Requesting subcontractor's safety verification documentation is another avenue for assessing safety protocols and intentions. Do they inspect their equipment on a regular basis? Can they provide certifications? Are their employees trained in safety (not just an “OSHA 10”, but additional training)? As a hiring entity, towns have the right to request supportive documentation before awarding someone a project. Scrutiny of how a subcontractor plans for a job with equipment and employees regarding safety should be paramount.

Alas, there are subcontractors who can appear to be squeaky clean in the safety division. For example, if the subcontractor is owner-operated and s/he is the only “employee”, thereby being self-employed, they may not fall under OSHA jurisdiction and would not subsequently appear in an inspection search. Or likewise, have workers compensation insurance. However, they may intend to hire subsequent subcontractors at which point it is prudent to request the same information of the subs of the sub.

The bottom line, in the Safety Corner's opinion, is that safety records and intention should be part of awarding projects when looking at a subcontractor to hire. We do not purchase the cheapest fall protection that may not have the ANSI rating and then go walk steel beams; we should not be focusing on low bidding alone to provide services in our towns, especially considering many will be coming with hazardous equipment and scenarios (earth moving equipment, electrical, excavation, work zone, etc....) and risk of injury to the town.

Be safe, not cheap.



John Tyler "J.T." Gaucher, P. E., 66, passed away on January 3rd.

J.T. was a lifelong resident of Millbury. He graduated from Millbury High School Class of 1972. He went on to graduate from the University of Massachusetts Amherst with a Bachelor of Science degree in Civil Engineering and participated in the Environmental Engineering Graduate Program at Worcester Polytechnic Institute.
