CONTRACT TERMS

We agree to abide by the regulations of the CMSA-OK Annual Spring Conference

NEW LOCATION! EMBASSY SUITES - OKLAHOMA CITY NW

BOOTH FURNISHINGS:

The exhibit hall is carpeted. All spaces include:

- One 6 x 8-foot exhibit space
- Skirted and draped 6 foot table
- 1 trash can, 2 chairs
- Background drape with 36" high side divider draping
- Electric is on request and must be noted on contract. There is a \$45.00 charge for electric Any additional decorating and exhibit furniture can be arranged through Event 1.

USE OF FOOD AND BEVERAGE:

Food and beverage may be dispensed from an exhibitor's booth if the exhibitor utilizes the services of the convention center's in-house caterer, no outside food/beverage allowed, unless it is wrapped candy or bottled water.

SHIPPING INSTRUCTIONS:

Embassy Suites by Hilton Oklahoma City Northwest cannot accept shipments of exhibit materials. All shipments must be done through Event 1, the official show decorator, and must be prepaid. Event 1 will email information for packages. Go to www.event1inc.net for more information.

CMSA-OK kindly requests exhibit space **NOT** be dismantled or vacated prior to the official exhibit hall closing time of **3:30 PM** unless approved prior by CMSA-OK. Any exhibitor breaking down prior to this time may not be offered a booth for Fall 2022.

SLEEPING ROOMS:

BOOTH PERSONNEL:

Badges will be provided for two exhibit personnel per space. These individuals may also attend the educational portion of the conference. Additional exhibit personnel badges may be obtained for a fee of \$75.00 per badge. **Badges must be worn at all times. Sharing of badges is not allowed.**

CONTRACT TERMS CONTINUED

MARKETING ACTIVITIES

Attendees are not permitted to distribute materials or to otherwise market themselves or their business on the exhibitfloor, in the conference session rooms, in break areas, or in or around the exhibit area unless such attendees are registered as exhibitors and in this instance must limit their marketing activities to within the confines of their booth.

CANCELLATION OR POSTPONEMENT OF CONFERENCE

In the event the CMSA-OK Annual Spring Conference is cancelled due to the COVID-19 pandemic beyond CMSA-OK's control, the Exhibit contract will be rolled forward to the Fall 2022 live Conference.

In the event that the conference is cancelled by reason of inclement weather, acts of God, strike, lockouts, acts of the elements, or other acts of occurrences beyond CMSA-OK's control, Exhibitor/Sponsor shall not have any right of claim for refund against CMSA-OK for money paid by Exhibitor/Sponsor to CMSA-OK pursuant to their contract.

LIABILITY

This agreement shall not constitute or be considered a partnership, employer-employee relationship, joint venture or agency between CMSA-OK and Exhibitor. Exhibitor hereby agrees to and does indemnify, hold harmless and defend CMSA-OK from and against any and all liability, responsibility, loss, damage, cost or expense of any kind whatsoever(including but not limited to cost, interest and attorney's fees) which CMSA-OK may incur, suffer, be put to, pay or be required to pay, incident to or arising directly or indirectly from any intentional or negligent act or omission by Exhibitoror its representatives, agency, employees, licensees or invitees.

CODES AND AGREEMENTS

Exhibitor agrees to be bound by the Rules and Regulations of the Case Management Society of America Oklahoma Chapter's Annua Conference. Exhibitor also agrees to adhere to and be bound by: (1) all applicable file, utility and building codes and regulations; (2) any rules or regulations of the facility where the exposition is held; (3) the terms of allleases and agreements between CMSA-OK's conference committee and the managers or owners of said facility; and

(4) the terms of any and all leases and agreements between CMSA-OK and any other related party to the conference.

EXCLUSION

CMSA-OK shall have the right to exclude or to require modification of any display or demonstration which, in its sole discretion, it considers unsuitable to or not in keeping with the character of the exposition. CMSA-OK shall have the right to prohibit the use of amplifying equipment or music which, in its sole discretion, it considers objectionable.

Any unused registrations will be donated back to CMSA-OK Scholarship funds and distributed to attendees as needed. 


