Membership Dues Options

CMSA now offers several options for paying your membership dues.

Traditional Annual Payments

Pay your annual dues in full and receive a renewal notice/invoice prompting payment for the next member year. This payment option is available to all Member Types.

Two Year Membership

CMSA now offers a 2-Year membership at a discounted rate of \$310 for A & B members, and \$216 for military members. A savings of \$15 per year over the regular annual rate. Two years local chapter dues are required at time of join/renew to take advantage of the savings. The 2-year membership is available only for Member Types Individual A/B, and Military. The 2-year membership is not available in conjunction with monthly dues payment plan.

Automated Monthly Dues Payment Plan

1. CMSA now offers the budget-friendly, monthly payment plan. These payments will be charged to your credit card each month until you choose to cancel your membership, or change payment types. See cancellation policy for more information. The first payment includes 1/12 of National dues, full payment of local chapter*, and .84 cents/month processing fee. Remaining 11 months will reflect 1/12 of National dues (and .84 cent monthly processing fee). Available to Member types A and B only.

*Chapter Dues will be charged in full in the first installment payment and automatically renewed annually when opting for the monthly payment plan. The installment plan is not currently available for chapter dues.

Example Monthly Auto Installment Payment: National dues \$170. Chapter dues \$20. First monthly payment: National= \$14.16, Chapter= \$20, and Processing Fee= .84 for a total of \$35. Remaining monthly payments: National= \$14.16 + Processing Fee= .84 for a total of \$15.

Collaboration with Case Management is Key to the Quality of Life for Stroke Patients

Multi-disciplinary collaboration between the clinical team, which includes the Case Manager, (in many settings, the case management team can be a combination of case managers and social workers and for this article, we will use the term case manager, which may mean one or both titles) and also the patient is critical in managing many debilitating diseases. After just ending Heart month, we will focus this article on the case manager's importance to the patient's recovery after an acute onset of a stroke or the residual effects of a previous stroke.

Stroke is one of the leading causes of serious disability and death in the United States.¹ Additionally, stroke has been on the rise since the onset of COVID which has led to greater complications (one patient's success after several complications after COVID will be highlighted later in this article). Stroke has been listed in the top 5 leading causes of death in Oklahoma. An improved level of functioning for the stroke patient can be a possibility when the stroke is treated quickly and the patient is stabilized and the patient can progress to undergo intense stroke rehabilitation. The Case Manager, in collaboration with the clinical team and physician, provides guidance and direction for each stroke patient and their family and caregiver as their condition stabilizes immediately following a stroke in the short-term acute care hospital. Depending on the type of stroke, the patient may need different types of rehabilitation and resources that the Case Manager will provide and facilitate.

A study comparing functional improvements after a stroke has been published to assist in determining the best level of care for a stroke patient.² The clinical team and case management in coordination with rehabilitation clinicians can evaluate the patient to determine the course of therapy for the greatest outcomes. Patients who can endure intense stroke rehabilitation in an to function at the highest level possible and return to their own community. The patients who meet the criteria for intense stroke rehabilitation (average of 3 hours per day) in a rehab hospital will have an individualized plan of care developed for them and depending on the type of stroke, the treatments may include physical therapy (mobility, strength, coordination, and balance), occupational therapy (address activities of daily living, fine

motor skills and upper extremity range of motion to perform daily tasks such as showering, dressing, eating and socializing with family and friends) and speech therapy (speech exercises and cognitive therapy). The Case Manager is often seen as a patient advocate and a liaison between the rehab therapy team and the patient and family. The clinical understanding by the Case Manager helps the stroke patient and family understand their progress and how these therapy services will facilitate that progress to live life as independently as possible.

As a part of the clinical team, the Case Manager at the rehabilitation hospital coordinates the length of stay management within Medicare (CMS) guidelines. The length of stay at the rehabilitation hospital requires frequent communication with the patient and the family as the patient progresses and improves. Throughout the course of the inpatient rehabilitation, the Case Manager collaborates with the clinical rehab team to understand the patient's progress and facilitate communication with the patient and the patient's family and aides in determining and arranging the resources the patient may need to continue their rehabilitation once they leave the rehab hospital. Case Managers can assist with follow-up appointments such as outpatient rehab therapy, in-home assist devices, and access to support groups and also guide the family and caregiver in how to best continue the improvements in the level of function desired.

Some patients may be too weak following a stroke to undergo intensive rehabilitation and may need more recovery time to gain strength. In situations where patients need more recovery time or stabilization and may need to stay in a short-term acute care hospital, skilled nursing facility, or a long-term acute care hospital before being referred to an intense rehabilitation hospital. The Case Manager's expertise and guidance during this process are important to ensure the patient has the highest opportunity to improve in the most appropriate clinical setting.

Let's talk about a patient who had experienced a significant health impact from COVID, which led to additional complications which inpatient rehab program have the greatest outcomes and the ability resulted in a deterioration of this active elderly patient's condition. He had endured sepsis and acute hypoxic respiratory failure. After medical stabilization at acute care short-term and long-term hospitals, he was admitted to Oklahoma City Rehabilitation Hospital for intense medical rehabilitation. He had also become severely depressed from his inactivity and his daughter was concerned that he had lost his will to live. The clinical rehab team with the Case Manager as the advocate to the patient and the patient's daughter set goals of returning this patient to his life without oxygen and overall improved mobility.

The patient succeeded in achieving these goals plus a few more! The Case Manager stated that the patient 'made a 180, was walking out of his room talking with his daughter and the rest of the rehab team.' His physical and medical health greatly improved and he was discharged with a smile on his face.
