HEALTH TIPS

Paano itataas ang potassium level sa dugo

Ang pagpapanatili ng normal na antas ng potassium sa dugo ay mahalaga upang mapanatiling maayos ang paggana ng puso, kalamnan, at mga ugat. Ayon sa mga eksperto, ang mababang potassium sa dugo o hypokalemia ay maaaring magdulot ng panghihina ng katawan, pamumulikat ng kalamnan, hindi regular na tibok ng puso, at iba pang seryosong komplikasyon kung hindi agad maaagapan. Ang normal na antas ng potassium sa dugo ay nasa pagitan ng 3.5 hanggang 5.2 mmol/L.

Isa sa pinakamabisang paraan upang mapataas ang potassium level ay ang pagkain ng mga pagkaing mayaman sa naturang mineral. Kabilang dito ang mga prutas tulad ng saging, abokado, melon, orange, at kiwi. Mainam din ang mga gulay gaya ng patatas, kamote, spinach, broccoli, at kamatis. Makatutulong din ang pagkain ng beans, lentil, mani, tuna, salmon, pati na ang pag-inom ng buko juice at orange juice bilang bahagi ng balanseng diyeta.

Kung masyadong mababa ang potassium level, maaaring magreseta ang doktor ng oral potassium supplements. Gayunman, mahigpit na ipinapayo ng mga espesyalista na huwag uminom ng potassium tablets nang walang payo ng doktor dahil ang labis na potassium sa dugo o hyperkalemia ay maaari ring magdulot ng mapanganib na epekto, lalo na sa puso.

Sa mga kaso ng matinding hypokalemia, kinakailangan ang agarang medikal na atensyon at maaaring isaialim ang pasyente sa paggamot sa ospital upang maibalik sa normal ang antas ng potassium at maiwasan ang mga komplikasyon.

Binibigyang-diin din ng mga doktor ang kahalagahan ng pagtukoy sa ugat ng pagbaba ng potassium. Ang matagal na pagtatae o pagsusuka ay maaaring magdulot ng pagkawala ng electrolytes kaya inirerekomenda ang pag-inom ng oral rehydration solution upang mapalitan ang nawalang potassium at iba pang mahahalagang mineral.

Maaari ring maging sanhi ng hypokalemia ang ilang gamot tulad ng diuretics o mga gamot sa pampaihi at pampababa ng presyon ng dugo. Dahil dito, mahalagang ipaalam sa doktor ang lahat ng iniinom na gamot upang mabigyan ng angkop na payo at paggamot.

Paalala ng mga eksperto, ang wastong nutrisyon, regular na pagpapasuri, at pagsunod sa payo ng doktor ang pinakamabisang paraan upang mapanatiling normal ang potassium level at mapangalagaan ang kalusugan.
