“The provincial government of Cavite invites local and international companies to submit comparative proposals under a competitive challenge bidding process to finance, construct and operate the project under a 35-year concessional period,” said Renato Abutan, chairman of PPP Section Committee.

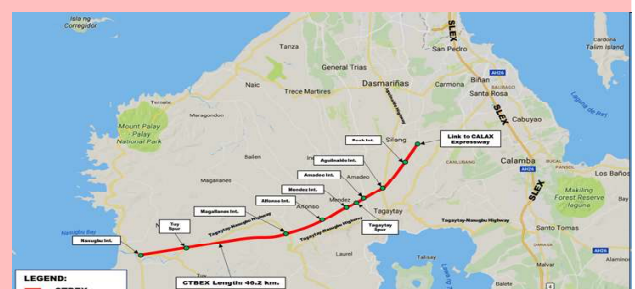

## EDITORIAL - Mga sakit pagkatapos ng bagyo't baha

Malaking pinsala ang nilikha ng bagyong Paeng sa buong bansa. Mula Mindanao hanggang Hila-gang Luzon, maraming sinirang bahay, kalsada, tulay at buhay. Sa pinakahuling tala umabot na sa mahigit 100 ang namatay. Pinakamarami sa Maguin-danao del Norte na mahigit 50 ang namatay maka-raang gumuho ang bundok at nalibing nang buhay ang mga taong nakatira sa paanan.

Marami ang nasa evacuation centers hanggang sa kasalukuyan. Karamihan ay wala nang uuwiang bahay sapagkat nawasak at natabunan ng lupa. Sabi ng mga nakaligtas, hindi na sila babalik sa lugar. Nag-karoon na sila ng takot na tumira sa gilid ng bundok.

Pinakamalaking problema na kinakaharap ngayon ay ang paglaganap ng sakit na nakukuha sa baha. Marami pang bayan ang lubog sa baha at pinanga-ngambahan ang pagdami ng kaso ng leptospirosis at dengue. Ang leptospirosis ay sakit na nakukuha hindi lamang sa kontaminadong ihi ng daga kundi sa iba pang hayop. Dahil sa rami ng daga mapa-lungsod man o mapanayon, nasa panganib ang ma-mamayan. Kapag nalubog sa baha ang bahagi ng katawan na may sugat, dito papasok ang virus na leptospira. Pinapayo na magsuot ng bota kapag lumusong sa baha.

Ang dengue ay dulot ng kagat ng lamok na Aedes-Aegypti. Ngayong tag-ulan, mabilis dumami ang mga lamok. Nangingitlog sila sa mga basyong bote na may tubig, tapyas na gulong, mga lata ng gatas na nakatambak at iba pa. Itapon o sirain ang



mga posibleng pamugaran at pangitluran ng mga lamok.


Dahil maraming tubo ng tubig ang nasira dahil sa baha, problema ang pagkukunan ng malinis na tubig. Sa Maguindanao del Norte, humihingi ng tulong ang mamamayan na padalhan sila ng inuming tubig. Karaniwang mga sakit na nakukuha sa pag-inom nang maruming tubig ay cholera at diarrhea.

Dalawa o tatlong bagyo pa umano ang dadalaw sa bansa bago matapos ang taon. Ibig sabihin nito, hindi pa tapos ang kalbaryo ng mamamayan. Posib-leng magkaroon pa ng mga pagbaha na magdudulot ng mga sakit na may kaugnayan dito. Iba-yong pag-iingat pa ang nararapat para makaiwas sa mga sakit.

Ang nagbago rito --- hindi masyadong malakas ang hangin pero maraming bumagsak na tubig. At hindi na nakayanan ng ating flood control at lumagpas na 'yung tubig doon sa mga dike, doon sa mga flood control natin.

Kaya't pumasok na sa mga bayan, Noveleta ganoon ang nangyari kaya't kailangan nating tingnan. Unang-una ay sa aking palagay --- kaya't talagang lagi ko hong ipinipilit at ipinapaalala sa lahat ng NDRRMC natin na ang pinakaimportante pagka alam nating may parating na bagyo ay mayroon tayong evacuation na pre-emptive na inuunahan natin 'yung bagyo na ilikas ang mga tao para kung sakali man dumaan doon sa lugar na 'yun ay hindi na sila mabiktima.

Kaya't 'yun lamang. Sa ngayon, eh pagkatapos nito ay magbi-briefing kami nang kaunti. May dali kaming kaunting dagdag na tulong para naman eh... Nahirapan na nga kayo eh, para hindi naman kayo mahirapan pa. Kaya't sige maraming salamat at...

Kami na munang bahala rito. We will take charge here and then make sure na okay kayong lahat. Maraming salamat.
