May 2021

In the last newsletter I reported that we had helped someone by posting the bail of \$2000, his aunt took on the rest of the obligation. He now has a job, a car, a lease on an apartment, and has finished his court obligations! Now he can breathe. He still has up to two years of parole and is doing very well. Based on several incidents that happened with the court, he and his volunteer are convinced that had this committee not posted bail, he would still be incarcerated, the attorney would not have pushed his case, the parole officer would not have seen how committed he is to being a responsible citizen. The bail money was a loan and is expected to be paid back by the end of 2021.

- Mill Creek Correctional Facility in Salem is scheduled to close July 2021 (though may be later this summer according to an officer at OSP).
 - The facility chaplain received permission from us to move the Christian Science books and literature to Oregon State CI (also Salem). The subscriptions to the Monitor and Sentinel were moved to Eastern Oregon CI whose facility chaplain has a list of those that read the Monitor.
 - The men on our list to receive Bible packets have been moved to Santiam CI (Salem) or will release before the facility closes.
- Shutter Creek CI (SCCI) in North Bend (think Coos Bay) is scheduled to close Dec 2021. The EC is considering where the books and subscriptions should go and make the request to the facility chaplain. None of the men on our list are at SCCI.
- Warner Creek CF in Lakeview is scheduled to close July 2022. None of the men on our list are at WCCF and redistribution of the literature will be decided after the other two facilities close.
- Adults in custody (AICs) no volunteers giving services yet, though there is a pilot at OSP. Our list is shrinking, but they are moved to the RCM list when they give us an "outside" address. Three to be released in 2021, two in 2022, three in 2023, then

significant gap for the other seven on our current list. Eight of them are in contact with a Journal-listed Christian Science practitioner a couple times a year if not every month.

- \circ One volunteer sends information to the facility chaplain to copy
- \circ One volunteer sends audio tapes to the facility chaplain to share
- Portland Christian Science Lecture Series continues to send DVDs to one facility of the public lectures given.

- Returning Community Members (RCM) – aka previously incarcerated

- Our secretary is attending the meetings of Embraced Fully (EF), see EmbracedFully.org for details on the organization at this time. They are taking a break in May to work with The Principle Foundation (TPF) to set up a 501(c)3 entity within TPF so it can receive grants on behalf of EF. If you would like to listen in or participate, contact Barb at <u>csiscoregon@gmail.com</u> and she'll send you the next meeting link. One Thursday a month there is a speaker or interview and one Thursday a month is the "angel teams" giving updates/encouragement. An angel team is a group of volunteers helping a previously incarcerated person get reconnected with community in a "pro-social" way. This group is currently all Christian Scientists but likely to grow organically to include people regardless of religious affiliation as needs grow.
- Secretary sends Bible lesson information to seven returning community members. Once the committee has an "outside" address, the RCM is eligible for one year to receive Full text Bible Lesson, Bible Lens, articles – similar packet printed for AICs. Three will "graduate" by August. TPF sponsored subscriptions for one to the Full text Bible Lesson and *Christian Science Sentinel*. Two more of our AICs are on TPF's list for subscriptions, cell phone, \$250 cash, \$250 cash card upon release.
- A volunteer leaves cheerful spiritual phone message with four RCMs each week and sometimes there is a conversation. The attitude is that we "walk" with them as long as they are willing and let them know we are here when they want to connect. Please contact our secretary, Barb Weiser, if you are interested in mentoring or working with a returning community member in some capacity.
