### **Badlands Boarding Terms & Conditions**

1. Badlands Boarding, LLC (hereinafter referred to as "We" or "Badlands Boarding") agrees to exercise due and reasonable care to keep its premises sanitary, property enclosed, and pets well cared for.
2. Badlands Boarding does not assume and shall not be held responsible for any liability with respect to the pets listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from the boarding of this pet, or any damages which may occur from any other cause whatsoever, including loss by fire, theft, running away, illness, death, injury to persons, animals or property, or illness, death or injury to any other animal caused by the within named pet during the term of this contract, whether this pet be on the premises of Badlands Boarding or not, and the owner of said animal agrees hereby to be and is solely responsible for any and all acts of behavior of said pet at any time within the term and time of the contract. In no case shall Badlands Boarding be in any way liable or responsible. Badlands Boarding is located in a rural area where wildlife also lives, including coyotes, mountain lions, snakes, various birds of prey, bees, insects, spiders and other wildlife. Badlands Boarding has taken reasonable steps to separate pets from this wildlife, but Badlands Boarding cannot guarantee that wildlife will not encroach and interact with pets on the property resulting in harm or injury to your pet. Known allergies should be noted to Badlands Boarding staff and Badlands Boarding suggests rattlesnake vaccines and/or aversion training.
3. The owner of the named pet specifically represents that he/she is the sole owner of said animal and that the pet has not been exposed to any communicable disease within the last thirty days, and that the form of a written receipt or certificate from their veterinarian stating dog has received a Rabies, DA2P-Parvo and Bordetella within the required time period or in the case of cats a Rabies and FVRCP. If proof is not produced at the time of check in, Badlands Boarding reserves the right to refuse to board the pet or to contact the owner's veterinarian to verify the inoculations. In addition a recent negative fecal exam (looking for giardia and parasites) will also be required for the pets stay.
4. Badlands Boarding shall have a lien on the aforesaid pet for any and all unpaid boarding and/or other charges resulting from this boarding of said pet with Badlands Boarding. The owner hereby agrees that in the event the daily boarding charges are not paid within 5 days after they become due and payable in accordance with the terms of this contract, Badlands Boarding may exercise its lien rights, and ten days after notice to owner may dispose of said pet for any and all unpaid charges at private sale, and if such sale does not secure a price adequate to pay such costs of board and/or other charges delinquent plus cost of sale, then owner shall and must pay to Badlands Boarding the difference.
5. If the pet becomes ill the owner or contact person shall be notified at once. If the owner does not immediately inform Badlands Boarding regarding measures to be taken or if the state of the pet's health requires quick action the right to call a veterinarian or to administer medicine or give advisable attention, within the discretion of Badlands Boarding, shall be taken and such expenses shall be promptly paid by Owner.
6. No person is authorized by Badlands Boarding to change or waive any of the terms or conditions of this contract and Badlands Boarding will not be bound by any changes therein whether oral or written. All terms and conditions of this agreement shall be binding on the heirs, administrators and assigns of the owner of the within named pet.
7. All service/product charges are due upon pickup of pet(s). There will be an interest charge on overdue bills, of eighteen (18%) percent.
8. All pets will be examined upon arrival for fleas and ticks, and if pet is found to have fleas/ticks, Badlands Boarding will treat the pet and charge the owner the appropriate fee for this treatment. Badlands Boarding is not responsible nor will be held liable for any veterinary expenses incurred for pet during or after the term of this contract. Owner is solely liable for all veterinary expenses.
10. Two pets in a kennel: At the discretion of Badlands Boarding, two pets boarded in the same kennel may be separated into similar accommodations and the owner will be charged the appropriate rate. This could happen, for example, if the two pets are not getting along, are destroying bedding, their surroundings, or pets do not have adequate space, or if entry to the kennel is difficult with two pets in the same kennel.
11. Owner agrees to indemnify, defend, and hold harmless Badlands Boarding for any claims, lawsuits or damages asserted against Badlands Boarding, including any managers, members, or employees, by any person as a result of any damage or injury caused or alleged to have been caused by Owner's pet. Owner further agrees to limit Badland's Boarding's liability for any and all claims to \$2,500, or the boarding fees paid to Badlands Boarding by Owner, whichever is less.
12. Older pets: When older pets are boarded, they are subject to a great deal of stress because of removal from their normal home environment. This stress can cause latent (dormant) physical conditions (such as heart, liver and kidney disorders) to become active. This can result in illness or death of said pet.
13. Upon request, an estimate of charges can be provided. Events that can affect this estimate are: Pickup day(s) early/late, bathing requests, vet expense, medicine expense, flea treatment, and other items which are usually discussed over the phone with owner or other authorized person. We attempt to provide an accurate estimate of total costs, but it is only an estimate.
14. Dog Interaction/Play Sessions: With the interaction of dogs, there is always a chance of injury and the possibility of infectious disease being passed between animals. The owner assumes all risk of injury or illness to the pet for the boarding. If the owner does not want their pets to interact with other animals, it is the owner's responsibility to notify Badlands Boarding prior to boarding.
15. By signing this contract, the owner is hereby acknowledging and agreeing to the above terms and conditions for the duration of said pet's stay, as well as any future reservations at Badlands Boarding.
