- **I understand** that the pick-up and drop-off times listed above are strict, and I cannot drop off or collect my pet outside of these specific windows. Time must be by appointment only. If you are early or late, please text 704-796-8107 for approval. If you cannot make the times above, CGSK9 will board your pet an additional day at owners expense.
- **I understand** that CGSK9 only accepts **Cash** at drop-off/pick-up. Checks and credit cards are not accepted. Venmo is permitted *only* if paid in full prior to arrival.

## **RELEASE, WAIVER OF LIABILITY, AND INDEMNIFICATION**

**1. Assumption of Risk, Injury, and Death:** I understand that due to the nature of canine behavior, boarding, training, and group play, certain inherent risks exist. These risks include, but are not limited to: cuts, scratches, nips, bites, broken bones, illnesses, infectious diseases, parasites, fleas, and death. I explicitly acknowledge that severe injury or death can occur even under proper supervision. I agree that CGSK9 SERVICES LLC is not responsible for my pet contracting fleas, ticks, or any other parasites during their stay.

**2. Sudden Medical Emergencies and Natural Death:** I understand and agree that CGSK9 SERVICES LLC is not an overnight medical or veterinary facility. In the event of a sudden, unpredictable medical emergency, illness, or natural passing (including but not limited to bloating, cardiac arrest, stroke, old age, or undetected pre-existing genetic conditions), CGSK9 SERVICES LLC shall not be held liable or at fault in any manner.

**3. Kennel Behavior, Stress, and Escape:** I understand that some pets experience boarding anxiety which can result in stress-related conditions, including diarrhea, weight loss, scuffed noses, self-inflicted injuries, or temporary personality changes. I will not hold CGSK9 SERVICES LLC liable for these conditions. Furthermore, I recognize that injuries, escape, loss, or death can occur from pets jumping or chewing out of crates/kennels, running on the premises, escaping a trainer during a session, or during daily exercise. In the tragic event that a pet escapes, becomes lost, and cannot be located, I agree that CGSK9 SERVICES LLC is not responsible, and I waive all rights to reimbursement, financial compensation, or damages for a lost pet.

**4. Aggression, Safety, and Necessary Self-Defense:** I certify that I have been completely honest regarding my dog's history of aggression towards humans or other animals. If my pet becomes highly aggressive and actively attacks a trainer, staff member, resident of the property, or another animal, I understand that CGSK9 SERVICES LLC personnel will take all necessary actions to defend themselves, others, and property. I acknowledge that these emergency defensive measures may result in injury up to and including the termination (death) of my pet, and I release CGSK9 SERVICES LLC from all liability in such an event.

**5. Emergency Medical Authorization & Financial Responsibility:** In the event of an injury or illness, CGSK9 SERVICES LLC will make all reasonable attempts to contact the owner or the emergency contact provided. However, if I am unreachable, I hereby authorize CGSK9 SERVICES LLC, its owners, employees, and agents to seek immediate veterinary care for my dog(s). I explicitly agree that all costs and expenses in connection with any veterinary, medical, or life-saving treatment shall be my sole financial responsibility.

**6. Complete Release of Liability and Indemnification:** I hereby release, waive, and agree to hold harmless CGSK9 SERVICES LLC, its owners, officers, members, employees, and agents

from any and all liability, claims, suits, actions, losses, injuries, sickness, death, or damages of any nature or kind sustained by my dog(s), myself, or caused by my dog(s) to others. I specifically agree to fully indemnify CGSK9 SERVICES LLC against any loss, cost, claim, or liability resulting from any act or omission, whether negligent, intentional, or otherwise, of any employee, representative, or agent of CGSK9 SERVICES LLC.

**7. Abandonment and Late Fees:** I agree to pay all charges incurred for the services my dog receives. If my dog is not picked up on the scheduled date, a late fee will be assessed and a standard overnight boarding fee of **\$25 per day** will apply. If a dog is left uncollected for more than **three (3) days** with no contact or payment from the owner, CGSK9 SERVICES LLC will legally consider the animal abandoned and retains the absolute right to re-home or surrender the animal.

**8. Media Release and Refund Policy:** I hereby grant CGSK9 SERVICES LLC consent to photograph and video my dog while on the premises. I agree that CGSK9 SERVICES LLC may use my dog's image, likeness, and video footage for promotional materials, including its website, Instagram, and Facebook pages. I explicitly understand and agree that there are **NO REFUNDS** for any services or goods provided by CGSK9 SERVICES LLC.
