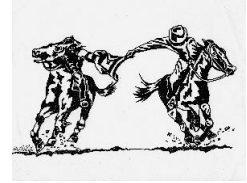


WANTED: PONY EXPRESS RIDERS!



TO: ALL INTERESTED RIDERS

As an officially sanctioned riding group for the Casa Grande Cowboy & O’odham Tash Days 2019, the Pony Express extends an open invitation to those interested in participating in the Casa Grande Cowboy & O’odham Tash Days Pony Express Mail Ride. The ride will take place on February 8th and 9th, 2019.

The opening ceremony will start 800 a.m. at the Casa Grande City Hall with Mayor Craig McFarland, 510 E. Florence Blvd., Casa Grande, AZ 85222 on Friday February 8, 2019. The ride will proceed to Sacaton where we will meet Gila River Indian Community Governor Stephen Roe Lewis, at the Ira Hayes Memorial Park. **We will park in the vacant lot on the southwest corner and then on to Stanfield.** There will be stalls available for an overnight camp out on Friday, February 8th, 2019.

On Saturday, February 9th, 2019 riders meet in Casa Grande at JB’s Restaurant, 1322 E. Florence Blvd. at 7:00 a.m. for breakfast and maps for the route will be distributed. Those that did not participate on Friday will sign up and leg assignments will be established. Ride will start at 9:00 a.m. at the Rodeo Park and proceed in 1 mile increments. Maps will be provided and assistance is always available! This ride will go through Eloy, Coolidge and Florence.

Florence: Meet at the vacant lot adjacent the Burger King at the Y intersection (main street/287) approx. 11:30 a.m. There will be **NO parade**

Cost for this ride will be **\$40.00 per rider**. This will cover the cost of the ride, non-alcohol beverages, a shirt and the BBQ at the end of the ride on Saturday, February 9th, 2019. There will be a drawing for donated prizes. Depending on the number of participants, each rider will receive at least one drawing ticket. **ALL MONEY MUST BE RECEIVED BY DECEMBER 10TH, 2018 TO ALLOW FOR SHIRT ORDER/PROCESSING OF THE RIDE!**

The parent or guardian must accompany each rider under the age of 18 years old throughout the ride. **Be mindful of your driving/riding needs. Drivers not provided.**
