School will not allow the kid back in school until the 21<sup>st</sup>, and only with two negative Covid tests or proof of vaccination. Lisa Gumataotao is suggesting to e mail a link for a school board petition to all the Trump Club members. Mike agreed and encourages members to write, call and contact their local representatives. Dennis McDonald is talking about who is running the health department in Flagler County. Schneider has a 1 year degree from 50 years ago. Janet elaborated on the fact that Covid is being weaponized against the people and the PCR tests where never designed to detect Covid and show a lot of false positives. Janet is calling on people to stand up for their rights and especially come to the school board meetings, reach out, talk to your neighbors, get involved and help our children. Janet states that the tests and the vaccination requests are abusive and need to stop. We all need to get involved. Jaiden asked Janet if a new school was being build. Schools are currently oversubscribed, but they do not want to burden the tax payers and are restructuring the school districts to help get schools better used for the different age groups. School impact fees are being raised for the first time since 2004, after extensive study of its necessity.
