Robert Paquette, Chief of Parks and Recreation, gave an overview of the specifications in the bid package.

DEM does not keep track of how many staff the vendor uses. There are staffing requirements in the bid package.

Vendor can choose the waste company they wish to utilize. Roll offs would be acceptable. However, containers with covers would be better due to the seagull problem. Vendor needs to coordinate with DEM.

The electric meter(s) are in the name of the State of RI. Meter(s) are read at the end of the season and then billed to the concessionaire. The usage for last year was:

Camp Store: \$3,000.00 Rec Center: \$2,100.00

Reserve America has the current contract in the campground.

Campground has well water.

Concessionaire carries the license for the propane.

DEM handles all major infrastructure issues.

DEM handles lifeguards.

Concessionaire is permitted to advertise at their own expense.

The campground has a leach field. Vendor is not responsible for maintenance/care of leach field.

Concessionaire can rent canoes/kayaks.

All sites must be mowed/maintained.

Out of state firewood is not to be brought into the campground. Only sell kiln dried fire wood. A tour was conducted of the campground:

There will be nothing in the 3 bay building (presently had current vendor's vehicle and equipment inside). Vendor will be responsible for the building.

Restrooms:

The cleaning of restrooms is detailed on page 17 of the solicitation. The CONCESSIONAIRE is responsible for providing the necessary cleaning supplies, cleaning equipment and the daily cleaning of the facilities:

Minimum of three (3) cleanings per day, Sunday through Thursday.

Minimum of four (4) cleanings per day, Friday and Saturday.






