EXHIBITION OPENING

The exhibition opening is the first Friday of the month from 5-8 p.m.

COMMISSION AND FEES

- A nonrefundable, nonnegotiable fee of \$15.00 per entry will be charged. You may enter more than one piece, depending on wall space. Size of artwork should not exceed 36" x 36". Larger sizes may be admissible but you must talk to Mas Art about them before submitting the entry form.
- Mas Art will take a 5% commission on all sales.
- All sales transactions must be processed through Mas Art.

DELIVERY OF ARTWORK TO AND FROM THE GALLERY FOR EXHIBITION

- Artists are responsible for transporting their artwork to and from Mas Art. Artwork is due at Mas Art on the Monday of the exhibition week.
- Art work, sold or not, must be picked up by Monday of the last week of show. A storage fee of \$ 20 dollars per day will be charged for artwork not picked up on time. For liability reasons artwork will not leave the store until all payments are cleared.

INSURANCE AND ARTIST'S RESPONSIBILITY DURING EXHIBITION

- Each artist is required to attend the opening reception on the First Friday from 5 to 8pm. "Meet the Artist" is a great opportunity to promote yourself and increase sales during exhibit.
- It is the artist's responsibility to arrange for insuring your art.
- All artwork must be clean, professionally mounted or framed and ready to be displayed.
- The artist is responsible for any taxes due from sales and for your own self-employment taxes. Plus, you
 are responsible for keeping all the records for your business including your freelance income and your
 freelance expenses.

MAS ART EXHIBIT RESPONSIBILITY

- Mas Art will supply the opening refreshments such as cheese, fruits, and wine. Mas Art also will have a
 volunteer to assist at the opening night.
- Preparation and distribution of invitations to Mas Art's email list and text newsletter will be done by
 Mas Art. Photos are taken at the opening for social media promotion of your exhibition: Instagram and
 Facebook.
- The work shall remain at the store for the duration of the month. Mas Art agrees to devote its best
 efforts to maintain and care for the artwork: however, artist should carry insurance adequate to cover
 the assigned value of artwork
- Mas Art assumes no responsibility for loss or damage sustained to art work.
- Payment for art sold will be made to the artist within a week of transaction processing.
- Charges for checks bounced or canceled will be charged to the artist.
