Austin Retired Teachers Association Minutes of the Regular Monthly Meeting Friday, May 9, 2025 Via In person/Zoom



The regular monthly meeting of the Austin Retired Teachers Association was held May 9, 2025, in person and via Zoom. In attendance there were 95 in person and six on Zoom for a total of 102 attendees.

Pre-Meeting Committee Fair: Beginning at 9:15 and lasting until 10:00, committee chairs were sitting at tables spread along the outside of the seating areas. Their purpose was to recruit new committee members and answer any question members might have. There were 13 committees participating.

GATHERING

Call to Order/Announcements: President Norma Jost called the meeting to order at 10:00 a.m. Jost also reminded members that dues are due, and that on May 15, AMBA will be sponsoring a new member recruitment luncheon at Central Market on North Lamar. Details are in the meeting packet.

Pledges of Allegiance to the U.S. and Texas flags: Catherine van Zanten led the pledges.

Inspiration: Laura Grayson reminded members that the journey is as important as the destination.

PROGRAM:

Program Introduction and Presentation: Linda Harvey and Glenda Black announced and introduced each of the 2025 ARTA Foundation Scholars. Several scholarship winners were unable to attend as they were taking AP exams. The honorees were Austin ISD seniors who have committed to pursue a career in education, for which they each receive a \$1,200 scholarship. The students who were present were asked to come up to the podium and share their inspiration for desiring to go into teaching and their plans for becoming a teacher. Twelve AISD high schools participated.

Early Meeting Door Prizes: Five door prizes were awarded.

Introduction of Guests/New Members: Betty Zschiesche directed members to look in their meeting packets to read about the seven new members. Our guests were the six parents of scholarship winners.

ARTA Foundation Report/Memorial Tributes: Sheila Sargent reminded members that contributions to the ARTA Foundation are for 2026 scholarship recipients. Linda Harvey presented the memorial tributes for Loretta Lowry Hughes and Betty Ruth Stephens Moore.

BUSINESS and COMMITTEE REPORTS

Approval of April 11, 2025, Minutes: The minutes were approved as printed.

<u>Treasurer's Report</u>: Treasurer Rudy Munguía referred to the four accounts posted in the meeting packet. The report was filed for audit.

<u>Standing Rules Committee</u>: Past President Joe Ramirez proposed an amendment to ARTA Standing Rules clarifying the role of the Program Committee chair. The proposed amendment was put to a vote and passed, going into effect July 1. The line now reads, *the Program Committee chair coordinates program committee selections and submits program information to the editors of the various ARTA publications.*

<u>Installation of Officers/District 13 Information</u>: Past President Joe Ramirez performed the installation of the new officers who were elected in February. They are First Vice-President: Terry Morganti-Fisher, Secretary: Marcia Caldwell, and Treasurer: Tony Dishner. Ramirez used the analogy of geese flying in formation; leaders may drop out of the front, but they join the ranks to maintain and support the organization.

In his persona as District 13 President, Joe Ramirez also announced the date of Wednesday, September 17, for the TRTA District 13 Fall Conference at the San Marcos Activity Center in San Marcos. In lieu of a traditional state convention, TRTA will be conducting a virtual House of Delegates on March 25, 2026. Delegates from each of TRTA's districts will meet at 20 different sites across the state on that day. District 13 will hold its combined House of Delegates and 2026 Spring Conference at the San Marcos Activity Center. Ramirez also reminded members that District 13 receives \$3.00 from every TRTA membership.

Membership Report: Terry Morganti-Fisher related that there were only 234 paid members of ARTA as of this meeting. Those who join by May 31 will be eligible for an HEB gift card drawing at the September meeting. The membership forms will need to change for July 1st, so Tony Dishner's information can replace Rudy Munguía's.

Membership Drive: The AMBA Each One-Bring One Luncheon will take place on My 14th, 11:30 a.m.— 1:00 p.m. at Central Market on North Lamar. Lunch will be free to the members who attend if their friend joins TRTA and ARTA. In addition, new members combined local and state dues will be paid for a full year.

<u>Legislative Update</u>: Dr. Gloria Lenoir reminded members that persistence is the key to change, but she also urged our group to be a polite role model while persisting. Several bills still exist that could be detrimental to retired teachers.

TRTA Children's Book Project: Maria Martinez shared that there were 873 books distributed at Cook Elementary via the Book Project. She suggested members should be collecting books now for next year's distribution.

<u>Volunteer Services/Community Involvement</u>: Marsha Lyons-Gray discussed the benefits of volunteering and distributed a new form for keeping track of volunteer hours. She would like members to submit their hours monthly, quarterly, or annually. Her direct contact information is on the new form.

Announcements and Reminders: President Norma Jost announced ARTA will be hosting a gathering for Travis County superintendents in September to communicate with them about the role of TRTA and how ARTA might be of service to their school districts. September 12 will be the first meeting for our new year.



IN MEMORIAM

Alice "Kay" Head was born December 15, 1940, in Dallas, Texas. At 14, she entered the convent and served 14 years. While there, she earned a music education degree. After leaving the convent, she earned a master's degree in Special Education at UT-Austin, where she met and married Joe Head. They had two daughters, Kat and CJ.

She served in the Prayer Shawl Ministry; her shawls offered comfort and solace to those who received them. Through JustFaith Ministries, Kay stood with the vulnerable and the marginalized. She and Joe opened their home to those in need of housing—offering shelter, dignity, and a sense of belonging.

As a teacher, she nurtured her students, teaching her greatest lessons in love more than in words. She was a Special Education teacher in Austin ISD from 1970 to 1999.

She saw the best in others and stood by those who struggled. Because Kay believed in people, they believed in themselves.

Kay died September 1, 2025, at age 84. She was an ARTA member from 2001 to 2025.

Proposed Amendments to the ARTA Standing Rules By Jane Garner, Standing Rules Committee Chair

The Standing Rules Committee proposes the adoption of the following proposed amendments to align the responsibilities of the ARTA Second Vice-President, Treasurer, and Communications Committee Chair to the current TRTA Bylaws, District 13 Standing Rules, and the new TRTA Operations Emergency Plan. Membership will vote on these proposed amendments at the October 10 ARTA meeting to go into effect July 1, 2026:

If adopted, Rule 7.1.4 as amended shall read:

The Second Vice-President shall:

- a. preside in the absence of the President and First Vice-President;
- b. serve as chair of the Communications Committee;
- c. represent the chapter Communications Committee at the district and state levels;
- d. promote the Children's Book Project and serve as coordinator or work with the assigned Children's Book Project coordinator;
- e. promote or work with the Technology chair and committee to maintain local chapter website, newsletters, and social media.

If adopted, Rule 7.1.6 as amended will include the additional two responsibilities:

The Treasurer shall:

- g. complete the annual review and revision of the TRTA Operations Emergency Plan with assistance from the President, Technology Chair and the ARTA Foundation Treasurer;
- h. retain a copy of the TRTA Operations Emergency Plan along with the ARTA President and one other bonded officer to serve as an alternate and notify the District 13 Treasurer annually when the plan has been completed.

If adopted, Rule 11.4 as amended shall read:

Communications Committee. <u>This committee shall promote and publicize</u> <u>TRTA state, district, and local chapter activities to the general public, all active and retired educational employees, and elected officials.</u> The Second Vice-President <u>shall chair and</u> represent this committee at the district and state levels.

11.4.1 TRTA Children's Book Project:

- a. collects children's books suitable for pre-K through grade 5;
- b. <u>selects a donor elementary school and a receiving elementary school in</u> support of "Student to Student" gifts of books for the same grades;
- c. determines dates for the collecting period;
- d. screens books and inserts book labels;
- e. delivers books to the receiving school;
- a. submits an annual report to the Second Vice-Presidents of ARTA and District 13. (Previously Rule 11.5.1 under the Courtesy Committee)
