## Buyer Agreement

1. The buyer agrees that if at any time, and for any reason, he/she is unable to keep or properly care for the dog, the dog shall be returned to the seller and no one else. If buyer returns the dog, no money will be returned to the buyer.  
The buyers understanding and acceptance of this condition is signified here by his/her initials: \_\_\_\_\_ on \_\_\_\_\_ (date) \_\_\_\_\_
2. You agree that your puppy **will be spayed or neutered by 1 year of age**, and veterinarian confirmation of this procedure must be supplied to the Seller. **Under no circumstances shall the dog breed or be bred with ANY dog.** (Initial) \_\_\_\_\_
3. If within 72 hours of the sale of puppy, the puppy should become ill, you may return the dog and get a full refund or a new dog. The buyer must furnish the Seller with a veterinary certificate indicating that the puppy is ill. (Initial) \_\_\_\_\_
4. However, if the Buyer takes the puppy to the vet during this period or incur any expenses, any and all costs of treatment will be the responsibility of the buyer. The Seller will not be responsible for any veterinary bills unless prior consent is given in writing. If you have any concerns, please contact us immediately. (Initial) \_\_\_\_\_
5. To reserve a puppy, there is a \$400.00 non-refundable deposit on a male or female puppy. First come-First Serve, such as—the first deposit gets first pick of the litter, second deposit gets second pick, third deposit gets third pick, and so on. (Initial) \_\_\_\_\_
6. Once the buyer is notified of the turn of the pick, buyer will have 24 hours to decide on choice of puppy. (Initial) \_\_\_\_\_
