- REVIEW MARCH 25, 2025 BOARD MINUTES REVIEW. DAVE HAS LOOKED OVER THE MINUTES AND FOUND THEM TO BE IN COMPLIANCE WITH WHAT THE REQUIREMENTS FOR INDIANA CONSERVANCY DISTRICTS.
- ▶ DAVE WENT OVER WHAT THE PROPOSALS FROM THE STATE LEGISLATIVE'S PROPOSALS FOR THE FUTURE OF PROPERTY TAX REDUCTIONS FOR INDIANA. WHICH MAY HAVE DETRIMENTAL AFFECT TO THE DISTRICT.

HOPING TO GET THE AUDITOR TO MAKE THE DECISION ON THE EXEMPTION FOR RELIGIOUS FACILITIES. IF THE CHURCH'S EXEMPTION IS APPROVED; ROBIN QUESTIONED WHEN THE EXEMPTION IT WOULD TAKE AFFECT. DAVE SAID LEGITIMATELY QUESTION AND HE WILL PROVIDE THE BOARD WITH AN ANSWER,

- ▶ GARY ASKED DAVE ABOUT THE PROPERTY TAX BILL THE DISTRICT RECEIVED. DAVE ASKED FOR A COPY TO BE SENT TO HIM AND HE WILL ADVISE. DAVE SAID THAT IT IS FOR THE DRAINAGE TAX THAT THE DISTRICT MUST PAY. HE ADVISED BASED ON THE PRICE TO GO AHEAD AND PAY IT
