- INDOT UPDATE
- ▶ NPCD DISTRICT MAP MUNICIPAL BOUNDARY IS NOW VIEWABLE ON THE GIS WEBSITE
- NO NEW CONNECTIONS
- ▶ PUMP PROJECT ALL DONE STILL NEED TO GET LOCKS TO THE OPERATOR.
- ▶ WAITING FOR PAPERWORK FROM SELGE TO FINALIZE THE LIFT STATION PROJECT. SELGES FINAL PAY APPLICATION, \$27,127.50 PRESENTED TO THE BOARD. FOR THE FINAL PAYMENT. UPGRADES AND OR REPLACEMENT OF COMPONENTS IN #2; PURSUANT TO SPECS THAT THE BOARD GIVES NIPSCO. THEY HAVE NOT GIVEN THEIR DECISION ON WHICH WAY THEY WOULD LIKE TO HOOK UP. NO FINAL ANSWERS FROM NIPSCO TO GIVE TO THE BOARD TONIGHT.
