We (The Board) continue to improve our aging District (over 25 years old) to hopefully continue to have a smooth operating District for another 25 years.

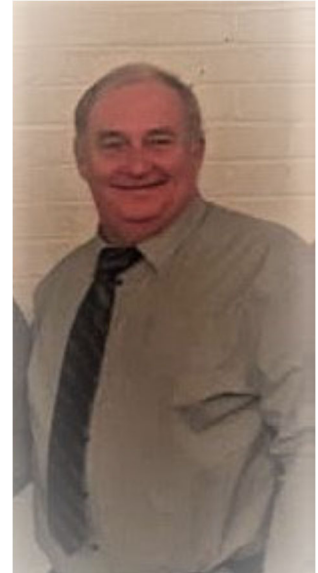
Our projects over the last five years and our future projects have been done without increasing the special assessment for NPCD on the property taxes, nor in a monthly rate increase. There has never been a

At the end of December you will receive a billing pack for the forthcoming year. We will no longer be sending out monthly mailings. If you loose or misplace your packet, there is a fee to replace the billing cards. NPCD's policies have not changed. All payments are due on the 15th of every month.
