CCSE Bylaws state in:

Article II - Officers and Election, Section 2. Elections

Officers shall be elected annually by roll call vote, and by the majority of the whole number of the members at its annual meeting, **but no less than six (6) members voting in favor** for a period of one year, and shall serve until their successors have been elected.

There were no winners after two rounds. According to FACE, if no winner is declared, the incumbent will continue in the position. Ellen McHugh will continue as Co-President.

Co-Presidents' Reports

- Attended a meeting on July 23 with Adrienne Austin. Topic was on Family & Community Wellness. 900 schools will have Family Healing Ambassadors and each will receive a \$500 stipend for the year.
- Attended a Zoom meeting with DOE reps on reopening. Most of the discussion took place in the chat and was so disruptive that the chat was taken down.
- Had a discussion with Camille Casaretti of CEC15 and Craig Spence and Mr. Shamel of D75 who are interested in having a town hall meeting on Summer Rising. Each member will take the suggestion back to their respective Councils.

• Summer Rising students in temporary housing were granted the opportunity to take curb to curb service that was not offered to students with IEPs but that has changed. Parents of IEP students are now able schedule transportation for their child in their Nextel? account.

- Attended D75's DLT meeting. The superintendant updated that D75 was allotted 24 social workers. Seventeen positions have been filled but there is still a staff shortage among related services and paras.
- Jody Salmon was in attendance and updated on the August 3 deadline to enter a request for transportation. The deadline was set to guarantee the student will have transportation on the first day of school.
- The VIA GPS platform is being rolled out in a small pilot program on September 20. As of now, 10,000 buses and outfitted with GPS devices. Waiting for drivers to implement actual program.

Bylaws – There was a change to the bylaws. A paragraph was deleted and since this is an amendment, the vote will take place at the next calendar meeting.

The Council reviewed the 2021-2022 budget prepared by AA Rose Morgan. The Council has an annual budget of \$25,000. The Council voted on the budget allocation. Six members approved and three abstained.

Presentation

Matt Berlin, CEO New York City School Bus Umbrella Service (NYCSBUS)

- Berlin talked about the creation of the non-profit New York City School Bus Umbrella Service (NYCSBUS) to purchase the Reliant Bus Company to improve school bussing.
- Goals include:
 - o providing insight on why busing cost so much
 - o provide great service to both users and staff
 - o become more innovative
- Brief discussion on retaining current staff drivers, matrons and dispatch. Conversation with Union on training and safety, COVID protocols. Making sure the maintenance of the buses are up to code.
- Discussion on who establishes the bus routes the DOE does and sends a list to the bus company.
- There were a lot of concerns and issues raised but because the purchase hasn't been finalized, they could not be addressed. A follow up meeting was suggested.
