Ms. Stiles stated each engineering firm was ranked during the Projects Committee Meeting and there will be a spreadsheet for the Board to review at the next meeting.

### **Indianbrook Waterline Replacement Project**

Construction started mid-September on Hokan and Tillamook working eastward. Currently the
contractor is working on installing the 12" main on Wapak Road. Weekly tentative schedule
updates posted on Indianbrook HOA and AWD Facebook page. Construction scheduled to be
completed by end of next month with exception of the final paving.

### Rudolph Foods – Elevated Storage Tank

- District still plans to meet onsite with City to make sure the final CO changes are operational.
- District still processing pay apps

### Lafayette Loop

- This project is high priority.
- Virtual meeting held with P&G on December 4<sup>th</sup> to review their preliminary waterline layout.
- District made funding application for HB 168/Water and Wastewater Infrastructure Grant.
- Approximately 85 users along Reservoir/Rumbaugh route.
- Survey sent to property owners to gauge interest in public water.

Ms. Stiles stated we may hear something regarding funding as soon as January and will move quickly on design if we are approved.

## East Regional


- Construction complete on all Contracts USDA paid out remaining grant. Funds were placed in the USDA Reserve Fund so the District will not have to make the annual \$14k transfer for a few years per the USDA requirements.
- Still have a small portion of paving to be done on Alger Road. Plan to use 0% OPWC for that work.
- Villages unhappy with the streets where City made taps. COL is working on cold patching where taps were made in the road. They will have a paving company come in spring to make permanent repair.

#### Diller Road Loop

- Plan to advertise for bid in early/mid-January and hold bid opening end of January in order to have ready to award at February Board Meeting. Bryce with Access plans to attend.
- Grant awarded from ODOD for \$439,000 to this waterline project.

#### Gomer

- Sugar Creek Township Trustees requested survey be sent to property owners to determine if we should keep exploring this as a project or table for now.
- Responses received thus far are mostly positive as shown in graph:



Sugar Street – Met with Bryce from Access Engineering to discuss options. Plan to meet with City of Lima and County Engineers early next year to further discuss. This is a county line.
