2. <u>NEW BUSINESS</u>: Ms. Stiles presented a resolution to the board regarding authorizing the Board Chair to sign/enter into a grant agreement with the Ohio Department of Development for the Diller Road Waterline Loop Project. Ms. Stiles stated their legal said this is a reimbursement grant. She also added the City of Lima has committed to \$65,000 toward the project and she is still talking to the Village of Elida and American Township to see if they would contribute toward the project. Mr. Core asked for clarification in regards to the reimbursement of the work after completion and that the money will not be available until work is completed and Ms. Stiles replied she is still finding out more about how the payment will work. Mr. Neeper asked what the total estimated cost would be and Ms. Stiles replied it is \$750,000. She also

added there are 9 potential connections that could be made voluntary with the possibility to recoup some of the project money. This project is on the priority project list.
