

## **Additional thoughts from Joan**

There are presently several legislative issues which are strongly in line with our mission of improving the quality of life for women. I want to highlight three:

- 1. Equal pay for women is a critical issue for Zontians, as well as women worldwide. March 24, 2021 was NYS Equal Pay Day. I encourage you to go to <a href="https://www.powherny.org">www.powherny.org</a> to learn more about this issue.
- 2. **The Violence against Women Act** expired in 2018. On Match 18<sup>th</sup> the US House of Representatives passed a law strengthening and reauthorizing this act. The senate is however blocking it because they object to a clause which restricts domestic abusers from purchasing guns. Calls to our senators are suggested.
- 3. I attended **NY Lobby Day** on March 25 on behalf of eliminating the loopholes in the child marriage bill. There is a mountain of legal jeopardy for a woman who is not a legal adult. We met with many of the members of the judiciary committee working on this issue. See the attached list and if possible send an e-mail to the assembly members designated as "Maybe."

#### Support S3086/A3891: Let's End Child Marriage in New York

Child marriage is an urgent problem in New York. The marriage age is 18, but a dangerous legal loophole allows 17year-olds to marry with parental "consent" and judicial approval. This loophole became law in 2017 in a move that was lauded as an end to child marriage in New York (previously, children as young as 14 were allowed to marry). In fact, the 2017 law did not end child marriage, as 17-year-olds are still children in terms of their limited legal capacity.2

#### Dangers in the Current Law

- When a minor is forced to marry, the perpetrators are typically the parents. Parental "consent" often is coercion."
- The judicial review process does not prevent forced marriage, even with the so-called safeguards the 2017 law added, because a minor who is forced to marry also is forced to lie to the judge about it.
- Minors are automatically emancipated upon marriage, likely ending their parents' financial obligation to them, regardless of the minors' level of financial independence.3 This can lead to teen homelessness, especially since 70 to 80 percent of marriages before age 18 end in divorce.1
- Some 73% of children married in New York between 2000 and 2010 were age 17.5 Thus the 2017 law failed to protect 73% of those impacted by child marriage.

#### Devastating Consequences of Marriage at 17

- Minors, even at 17, can easily be forced into marriage or forced to stay in a marriage. They cannot easily leave home, erelain an attorney or bring a legal action on their own behalf. While marriage gives a minor some "rights of adulthood," those rights are limited and are granted only after the marriage is approved and the minor has endured the trauma of forced marriage.
- Child marriage, even at 17, is a "human rights abuse" that destroys girls' health, education and economic opportunities, and increases their risk of experiencing violence.11
- Those who marry before 18 have a 70 to 80% chance of divorcing and teen mothers who marry and then divorce are more likely to suffer economic deprivation and instability than teen mothers who stay single. 12

#### Alarming Statistics

- Nearly 3,850 children as young as 14 were married in New York between 2000 and 2010.
- Some 84% were girls wed to adult men.13

#### Simple Legislative Solution

S3086/A3891 costs nothing, harms no one and saves girls from a human rights abuse. It keeps the marriage age at 18 but eliminates the dangerous loophole that allows marriage at age 17. States and territories across the U.S. are passing similar legislation to eliminate all marriage before 18; if New York does not act now, it could become the "destination site" for child marriage. 14 For more information, visit www.unchainedatlast.org.
