

Another interesting piece of legislation is the Interagency Committee on Women's Business Enterprise (ICWBE) Act H.R. 6058. This is significant because 39.1% of US businesses are owned by women – these businesses add \$1.8 trillion (and growing) to America's GDP annually yet women-owned businesses are lacking the governmental support they deserve. The ICWBE would look at the behavior of federal agencies on how they support, expand, and strengthen resources for women-owned businesses. Please urge your legislators to co-sponsor this bill. The 68<sup>th</sup> session of the Commission on the Status of Women at the United Nations was held last month. Diverse leaders met to discuss how social protection can be harnessed to realize and promote human and equal rights for women. A priority theme was to accelerate the achievements of gender equality and the empowerment of all women and girls by addressing poverty and strengthening and financing them with a gender perspective. There was also an emphasis on social protection systems as women are victimized more both economically and physically then men. To begin our new year in the fall we would like to look at how we can implement these ideas on a local level as well as globally.

District 3 will be holding our Spring Workshop in April on the 16<sup>th</sup> and 17<sup>th</sup> beginning at 6:30 p.m. It will be done by zoom and there is a \$15 charge each day. It is our hope that all or most of our members will attend at least one day if not both days. As you know the 16<sup>th</sup> is the normal day of our monthly meeting, also at 6:30 p.m. We cannot use the restaurant if we don't have a sufficient number of members willing to come, have dinner, pay the \$15.00 fee and watch the zoom event together. Therefore, we must immediately have a count of how many people would be willing to come to the restaurant and take part in this event. Please let us know if you would prefer to do it individually at home or in your own private groups. I am asking that you respond within 24 hours of your getting this Zontagram so that we will know how to proceed. We will let you know the group's consensus on how to approach this event.

### **Budgeting and Projects**

A question about our budget was raised at our March monthly meeting. The following are the procedure for the yearly budget (June1 to May 31)

We start our year with our June retreat to discuss Zonta International's visions for the year. This is usually done while enjoying our sisterhood and brunch together. Any member(s) that would like to introduce a project to undertake above and beyond the International's vision can do so at that time. Consideration of any project is dependent on time and money available to complete.

In August our board will meet. The treasurer presents the budget based on current and projected receipts and expenses. Once the board has approved the budget and projects, it is presented at our September monthly meeting to get approval from the membership.

We are a small organization that is operated under the International's umbrella of 401-C4 tax code. We do not have to pay income taxes for income less than \$50,000 per year but we still pay taxes for anything we buy. Since our individual club is not a 501(c)3 non-profit, we are not able to offer tax deductions to any of our donors. Therefore, our fundraisers rely on members, families and friends to support our activities.

We would like to thank Joan Mallory, who has been the major force for most of our fundraisers for the past four years.
