Hi Ewen,

The objective of the fencing and the warning signage is mitigate the risk to human health by preventing physical access and informing the public of the existing health risk. These measures will need to stay in place until the is no further risk to the public.

I reviewed the snow fencing photographs and I spoke to Dan Dings (MOE). He confirmed that the snow fencing should be replaced with modular metal construction fencing as soon as possible, and that the signage should be clearly posted and include " Caution. Fecal Contamination. Access is prevented under order of Ministry of Environment".

As leachate seeps out of the cut bank and pools beside the pathway, my recommendation is that the fencing include the pathway between the two schools (see attached photo and PDF). I recognize that it will be an inconvenience to students, but the risk to the public is not contained if the trail is in use.

Once the new fencing and signage is installed I will submit documentation to MOE to show that the immediately required actions have been implemented.


